COMMITTEE REPORTS - Committee reports were presented as follows:

- Facilities (Ashbaugh / Kerkvliet / Pollmann) - The committee toured the High School and the many projects in progress, including the boiler renovation (which is on schedule) and the phase 1 ground work.
- Finance (McGraw / Kamrath / Waldron) - The committee met on August 9, 2010 and discussed the following: bills; financial statements; the issue of state funding (at this time, the Finance Committee is not expecting the district to secure an operating loan due to the delay of 7.4 million dollars from the state), disaster planning (the group may visit with the Wadena district to gain knowledge of what they learned in dealing with their recent disaster), Kindergarten enrollment is currently at 211, negotiations, and the current excess levies come due in 2012 and 2014.
- Parks, Recreation, Community Education (Waldron) - The amount of volunteer time donated through PRCE is 4,766 hours! Four board positions will be available, if interested in serving contact the City of Hutchinson.
- Public Relations (Kerkvliet) - The committee met August 9, 2010 and reviewed the district's participation in the Water Carnival Parade and the upcoming McLeod County Fair, discussed how to raise funds for the School Foundation (payroll deductions are a great source of funding, thank you to all ISD 423 employees who have chosen to give), and continue to explore Tiger Pride opportunities. It was also noted that time and funds used for PR Committee projects are donated from our staff and the community.

PUBLIC SUMMARY OF SUPERINTENDENT'S PERFORMANCE EVALUATION (Kamrath) - Chairman Kamrath provided a public summary of Superintendent VanderHeiden's July 12, 2010 performance evaluation.

NEGOTIATIONS UPDATE - The administrative group and a few individual contracts are still open.

UPCOMING BOARD MEETINGS - The next regular meeting is set for Monday, September 13, 2010 at 5:30 pm in the City Council Chambers at City Center. The next quarterly meeting is set for Monday, October 18, 2010 at 5:30 pm, location to be determined.

MSBA SUMMER CONFERENCE - Tim Kerkvliet attended the MSBA summer conference. Highlights included: superintendent's evaluations (ISD 423 is above the benchmark), Q Comp (there may be more Federal dollars available), and information about the Bush Foundation (dedicated to the training and mentoring of new teachers).
