Linda Leota Roy Harless of Huntington

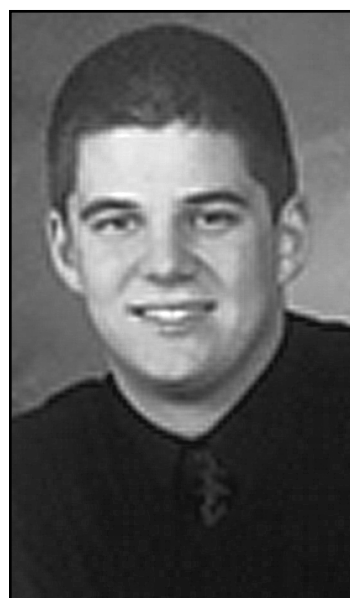

Louise Rowe of Genoa



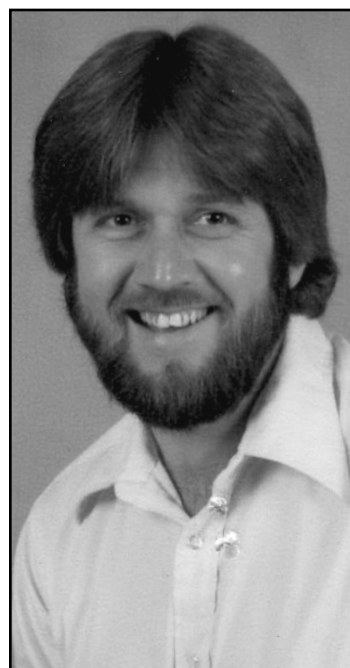

Joe Norman Pack of Louisa



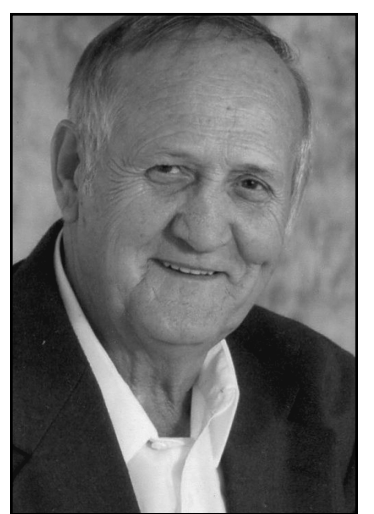
