Iowa Association for Justice (IAJ) installs new officers, honors IAJ award winners

(Des Moines) – The Iowa Association for Justice (IAJ) installed new executive officers and members of its Board of Governors during its annual convention (November 6-7) in Des Moines. IAJ's newly installed leaders will serve the 2014-15 term. IAJ also honored its 2014 award winners and completed its year-long fundraising campaign to place a fully trained therapy dog at On With Life in Ankeny, the Midwest leader in brain injury rehabilitation.

Mr. Daane received his law degree from the University of South Dakota and worked as a Judge Advocate General (JAG) officer with the US Army's 7th Infantry Division for 3 years following graduation. Over the past 26 years he has served Siouxland as a private attorney, a two term member of the Sioux City Community Schools Board of Education, a long-time board member of the Siouxland Economic Development Corporation, and on the boards of many other organizations, including service as President of Big Brothers/Big Sisters of Siouxland and the Noon Optimist Club. Mr. Daane now serves the Iowa legal community as 42^{nd} president of the Iowa Association for Justice, and was elected by his peers to the Judicial District 3B Nominating Commission. At his law firm he works as a trial attorney, advocating for Iowans who are injured by the misconduct and negligence of others, for children in need of assistance in juvenile court, and for the rights of the accused.

IAJ Awards Honorees

IAI Justice in Deed Initiative

IAJ's *Justice In Deed* initiative connects trial attorneys with community organizations across Iowa to help meet critical needs. The association's 2014 *Justice In Deed* partner was On With Life and the Puppy Jake Foundation. Trial attorneys from across the state donated a total of \$11,660 to support the groups this year. The majority of this donation (\$10,000) was used to purchase and train Lolo, a professional therapy dog at On With Life. The balance of funds raised will generally support the Puppy Jake Foundation, which placed Lolo and is presently training her.

On With Life in Ankeny is the Midwest leader in brain injury rehabilitation. The Puppy Jake Foundation is a nonprofit organization dedicated to helping military veterans through the assistance of well-bred and highly trained service dogs.

"I can speak for trial attorneys across the state when I say we are honored to be a part of this project. At just a couple months old, Lolo is already having a positive impact on the progress of the people served at On With Life. When Lolo finishes her training with the Puppy Jake Foundation she will be an indispensible member of the world-class rehabilitation team in Ankeny," said IAJ president Jim Daane.
