Page County Attorney, Carl M. Sonksen, reports the following activities in the Iowa District Court for Page County for the week of April 4, 2016. The Honorable Mark J. Eveloff, Judge of the Fourth Judicial District presided. All persons are presumed innocent until proven guilty in a court of law.

David Lee Berry, age 39, Shenandoah, Iowa, appeared by his attorney, having filed a written plea of not guilty to Driving While License Is Denied Or Revoked. Pretrial is scheduled for May 2, 2016, trial is scheduled for May 24, 216. All persons are presumed innocent until proven guilty in a court of law.

Casey William Bushaw, age 22, Anamosa, Iowa, appeared with his attorney and pled guilty to Assault On Persons Engaged In Certain Occupations and Inmate Assault – Bodily Fluids Or Secretions.
