The State of Minnesota, to all persons, companies or corporations who have or claim any estate, right, title or interest in, claim to, or lien upon, any of the several parcels of real estate and severed mineral interest described in the list hereto attached:

The list of taxes and penalties on real property for the county of Aitkin remaining delinquent on the first business day in January 2013, has been filed in the office of the Court Administrator of the District Court of said county, of which that hereto attached is a copy. Therefore, you and each of you, are hereby required to file in the office of the said administrator, on or before the twentieth day after the publication of this notice and list, your answer, in writing, setting forth any objections or defense you may have to the taxes, or any part thereof, upon any parcel of real estate and/or severed mineral interest described in the list, in, to, or on which you have or claim any estate, right, title, interest, claim or lien, in default thereof, judgment will be entered against such parcel of real estate or severed mineral interest for the taxes on such list appearing against it, and for all penalties, interests and costs. Based upon said judgment, the real estate and severed mineral interests shall be sold to the State of Minnesota on the second Monday in May 2013. The period for redemption for all land sold to the state at a tax judgment sale shall be three years from the date of sale to the state of Minnesota if the land is within an incorporated area unless it is:

(A) nonagricultural homestead land as defined in Section 273.13, subdivision 22; (B) homesteaded agricultural land as defined in Section 273.13, subdivision 22, paragraph (a); (C) seasonal recreational land as defined in Sections 273.13, subdivision 22, paragraph (c) for subdivision 27, paragraph (a), in which event the period of redemption is five years from the date of sale to the State of Minnesota.

The period of redemption for all other lands sold to the state at a tax judgment sale shall be five years from the date of sale.
