YOU WILL PLEASE TAKE NOTICE that Defendant, by and through undersigned counsel, will move this Honorable Court for bond. Said motion is based upon the following grounds:

1. Sidney Moorner was arrested on Friday, February 21, 2014. Sidney Moorner was denied bond on May 17, 2014. Sidney Moorner has been incarcerated without bond for close to ten (10) months.
2. This Honorable Court ruled at the bond hearing that the defense would be permitted a reconsideration of the bond decision at a future date, if warranted by the discovery and evidence.
3. The defense would show that a reconsideration of the bond decision is warranted at the present time. Defense counsel has had the opportunity to review the discovery provided. The discovery provided not only contradicts the State's representations at the initial bond hearing, but further establishes that Sidney Moorner could not be legally convicted of the crimes charged.
4. Defense counsel submits that Sidney Moorner is entitled to a bond. A more detailed explanation and analysis is set forth in Defendant's memorandum in support of his motion for bond, which will be provided separately to the Court and the State.
