Robbery suspect armed with BB gun

Man leaves hospital, is moved to FCC

The lone adult suspect in a Fairbanks apartment robbery last week carried an unloaded, "realistic looking" BB gun into the gunfight, according to the charging document filed against him Tuesday.

Isaiah Cross, 21, carried a BB gun, and his alleged accomplice, a 16-yearold boy, carried a 9mm pistol as they approached a Wedgewood Estates apartment where Cross later told Fairbanks police he planned to collect on

Five people were in the apartment about 2 a.m. when Cross and the juvenile knocked on the door. One, a 30-year-old man who Cross said owed him money, had a .40 caliber pistol and opened fire on the two alleged

In an ensuing gunfight, at least 10 shots were fired, and the man with the .40-caliber was shot once. The bullet lodged into his spine, but he's expected to survive, according to Fairbanks police.

Cross was shot several times. He was hospitalized at Fairbanks Memorial Hospital and was moved to Fairbanks Correctional Center on Tuesday.

Cross was arraigned Tuesday on a charge of first-degree robbery. He has previously been represented by the Public Defender Agency, including in

his one previous felony conviction, a December theft of a vehicle that was left warming up outside a Fairbanks pawn shop. Cross had a warrant out for his arrest related to that case when he was arrested this week. He's being held without bail at FCC.

Fairbanks District Attorney Michael Gray declined to discuss the possibility of charging the juvenile suspect in the adult court system, saying he can't comment on juvenile cases.

JUNEAU - A day after Gov. Sean Parnell said he'll make it easier for a third party to buy the soon-to-be-closed Flint Hills Refinery in North Pole but won't let Flint Hills bargain its way off the

hook for contamination cleanup, the Flint Hills Refinery CEO states in a letter to the governor that the sale is now

unlikely. "I am now in the position of having to tell the buyer that it appears the State of Alaska has no interest in seeing this refinery operate in the future without

extracting unreasonable concessions from Flint Hills," Flint Hills CEO Brad Razook wrote to Parnell on Tuesday.
