Rep. Wool sponsors ride-sharing bill

Interior legislator wants to bring Uber, Lyft to Alaska

Inspired by his experience running an event venue and bar outside town, Fairbanks state Rep. Adam Wool is backing a plan that could bring ride-sharing services like Uber and Lyft to Alas-

"I remember when Uber

came to Anchorage I was really excited and I was optimistic they would come to Fairbanks," Wool said, recalling the company's Alaska stint before it left after waiting for the green light from the city. "That was before I was in the Legislature. I use it on trips Outside and I love it."

The ride-sharing companies operate by allowing users to hail rides through a phone app, including rating drivers and paying through the app. Drivers, who are screened by the companies, are independent contractors who personally own or rent their vehicles.

Wool said he thought it would be a good fit for the Fairbanks area, saying cabs rides are expensive and can come with long waits.

"It changes how you go out and it'd help Fairbanks," he said. "It'd help facilitate travel, and keep people from drinking and driving."

Local concerns

The most controversial element of the bill would explicitly prevent local governments from regulating or outright banning ride-sharing companies. Wool said it's necessary to prevent an inconsistent patchwork of where Lyft and Uber rides are available.

But it's on that ground that municipalities have generally opposed the legislation as written. The Alaska Municipal League, which represents the state's municipalities, wrote a letter opposing the legislation.

City of Fairbanks Mayor Jim Matherly also sent a letter to the Legislature opposing the measure because of the limit. He said he supports companies like Uber and Lyft operating in the city, but not without the option for local regulation.

"My specific objection is the explicit provision pre-empting local authority to regulate

Trump signs bill overturning Obama BLM resource management update

President Donald Trump signed legislation Monday overturning the Obama administration's update to the Bureau of Land Management's long-standing process for resource management planning.

The revised BLM process, known as "Planning 2.0," was approved by the agency's director in December.

The House voted 234-186 on Feb. 7 to overturn the rule; the Senate made its disapproval vote of 51-48 on March 7. Republican Rep. Liz Cheney, of Wyoming, carried the bill in the House; GOP Sen. Lisa Murkowski, of

Crews install fiber optic cable from **Prudhoe Bay** to Fairbanks

Quintillion Holdings recently finished installing 250 miles of fiber optic cable connecting Prudhoe Bay to Fairbanks, company spokesman Tim Woolston said.

The fiber optic cable will bring broadband internet to the Arctic for the first time when the switch is flipped in mid-April, Woolston said. The exact moment has not been determined.
