ORDER

Pursuant to Section 53.1-232.1 of the Code of Virginia, having determined that the Supreme Court of the United States has denied both of the defendant's two petitions for writs of certiorari to the decision of the United States Court of Appeals for the Fourth Circuit, affirming the denial of federal *habeas corpus* relief to him, such that the stay granted pending filing and disposition of his petition for writ of certiorari with the United States Supreme Court has expired, and that the United States Court of Appeals for the Fourth Circuit has issued its mandate, this Court hereby **ORDERS** that the death sentence of Ricky Javon Gray be carried out on January 18, 2017, at such a time of day as the Director of the Department of Corrections shall fix.

It is further **ORDERED** that at least ten (10) days before said date, the Director shall cause a copy of this Order to be delivered to the defendant and, if the defendant is unable to read it, cause it to be explained to him.
