Absentee ballots will be available from the Nicollet County Auditor/Treasurer's office until 5:00 p.m. on Monday, November 4th. The Auditor's office will also be open on Saturday, November 2nd from 10:00 a.m. – 3:00 p.m. for absentee voting.

CITY BOND RATING IMPROVEMENT – The City's bond rating has been upgraded by rating agency Standard & Poor's. The rating was obtained as part of the preparation work for the issuance of a Municipal State Aid bond (see story below on City Council actions) and staff is pleased to report the rating was upgraded to an "AA-(SPUR)/Stable" rating.

According to the Standard and Poor's report, the rating is a reflection of their assessment of the St. Peter area having an adequate economy which benefits from the Mankato-North Mankato metropolitan statistical area and the stabilizing institutions of Gustavus and the Regional Treatment Center; a very strong budgetary flexibility with general fund reserves projected to remain higher than 30% of expenditures; strong budgetary performance, including projections of close-to-break-even operations in fiscal years 2013 and 2014; very strong liquidity providing very strong cash levels to cover both debt service and expenditures; strong management with good financial management practices; and very weak debt and contingent liability position, mostly as a result of the City's high net direct debt.

This is good news for the most recent bond sale as the net interest rate on the bonds was substantially below projections, in part due to the upgraded bond rating for the City.

CITY COUNCIL ACTIONS – Action taken by the City Council at the regular meeting of October 28, 2013 included a public hearing and subsequent action to modify the City Code to allow "birthing centers" as

conditional uses in some areas of the community; approval for the sale of \$4,720,000 in general obligation municipal state aid bonds; approval for a contract with Gustavus for transportation for Gustavus students on weekend evenings during the school year; changes to the City's public hearing process and regulations; approval of the concept for construction of a round-a-bout at the intersection of Old Minnesota Avenue and St. Julien Street in 2014; purchase of a replacement excavating system for Public Works; and modification to the City's municipal state aid plan to remove two blocks of roadway and add two different blocks. The Council also met in closed session to discuss Utility, Park, and Streets union contract negotiations and negotiations for purchase of property associated with the Washington Avenue Link Improvement Project.

The next regular meeting of the City Council will be Tuesday, November 12th at 7:00 p.m. in the Governors' Room of the Community Center. (**The meeting is being held on Tuesday due to the Veteran's Day holiday on the normal meeting date.) MAKES ME WONDER (BY CITY ADMINISTRATOR TODD PRAFKE) – Here is an update about the Pirate Crossing (Hwy 99 Bridge) at Rock Bend. Now I have been told by a person in the know that

on the Minnesota River, near the 99 Bridge (on the way to Whiskey River) is the rock out cropping that is the "Rock Bend".

As you stand on the bridge you can see the historic rocks and imagine the boat Captain saying "ARRRR...mates...Rock Bend ahead, prepare to land and drop this load off you swabbies." Well I know I added the "ARRRR" for a little affect and they probably did not sound like pirates but it is fun to think about. At some point Rock Bend had its' name changed to Saint Peter. (Bob Sandeen of the Nicollet County Historical Society can probably tell you all about that.)

Anyway, a few years back we were having lots of discussion with MnDOT about this "fracture critical" bridge and at that time a couple of actions were taken to prepare for what would be necessary if the bridge had to move. Long story short, historic bridge, fracture critical, cannot really change the

aesthetics, may need to replace, cannot tear it down, might be able to move it downstream for a bike trail crossing, big money, concern about losing this crossing, ugh!

MnDOT has done a lot of thinking about this and a bunch of research and it now appears that they and a consulting engineer are working on a new plan to enhance the strength of the bridge without significantly affecting the historic look of it. The current plan is to fix up the bridge while working to maintain the bridge's looks and they plan to be out for bids on bridge work sometime around the New Year with work to occur in the 2014 construction season. As I get more info, I will write about it here.

Do you ever cross that bridge? Is the crossing important to you or would it be okay to only have the Highway 22 Bridge? Does the idea of spending less and keeping the aesthetics of the Highway 99 bridge appeal to you? I think it appeals to MnDOT and us to and I appreciate MnDOT's continued work on this.

Will you be able to walk across the bridge and imagine the pirate landing by Rock Bend? It makes me wonder....

VEHICLE SALE – The City is auctioning off two seized vehicles through the State of Minnesota online auction site



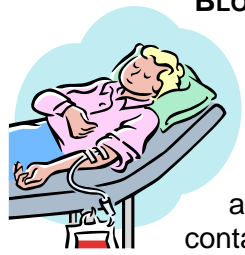
(www.minnbid.org). The first vehicle is a 1994 Dodge Colt in fair condition.

PARK RESTROOM CLOSURES – The City’s parks and the restroom facilities in the parks have officially closed for the season. As provided for in the City Code, all parks must be closed by November 1st. Because of the vandalism that sometimes happens on Halloween, the Parks crew closes the facilities before Halloween to save costly repairs and allow the winterization of the facilities.

HIGHWAY 169 WARRANTY WORK - THE contractor for the Highway 169 project (the one done in 2009) is back in town and will be doing some warranty work on the project. This work is being coordinated by the Minnesota Department of Transportation (not the City) as they were the original contract holders for the Highway project.

The contract (Schaffer) has set up their equipment in the old Library lot across the street from City Hall.

During the warranty work, drivers might encounter some short term roadway closures and/or detours in the downtown area as Schaffer makes repairs to sidewalks and other parts of the project. Everyone is encouraged to be patient with this work and to use extra caution in and around areas where work is being performed.

BIKE TRAIL DEVELOPMENT - THE City Council recently approved a plan to construct multi-use (bike/hike/snowshoe) trails in Traverse des Sioux Park. The



trails will be one-direction to prevent mishaps and will be approximately 11-15 miles long and about two feet wide. The trails will be constructed with minimal impact to the park and no trees will be removed during the construction. BUILDING ACTIVITY - Dean Busse, the City’s Building Official, was recently asked the question “Is there any building going on in the Saint Peter?”

The answer is a resounding “Yes!”

As of October 21st, the Building Department has issued five permits for new commercial construction. This number includes the two twenty-unit apartments being built on Park Row. Permits have also been issued for fourteen new single family homes, three duplexes, and two four-plexes and the Building Department is now reviewing plans for three more four-plexes and two more duplexes.

When contrasted with 2012 when permits were issued for nine single family homes, three four-plexes and four new commercial buildings, 2013 is a great year for building in Saint Peter.

LIBRARY REMINDER - AT the Public Library Saint Peter residents will find more than books! There are ten public internet computers, a wide



variety of movies for children and adults, over 140 magazines and newspapers, an electronic law library, meeting/study rooms, a special Minnesota Collection, and themed Storytime Bags. For families with young children, Storytime Bags are a great resource. Included in each large plastic bag tote are books, puzzles or puppets, activity ideas, hands on manipulatives, and song and poem sheets all centered on a common theme (e.g. trains, birthdays, cats, math, transportation, etc.)?

Staff can also help access eBooks and set up personal accounts with Zinio Digital Magazines.

Successful candidates will begin service January 1, 2014 and will be required to successfully complete required Firefighter schooling within one year.
