The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Controlled Substance in the Third Degree - Sale - Narcotic

Minnesota Statute: 152.023.1(1), with reference to: 152.023.3(b)

Maximum Sentence: Not less than 2 years nor more than 30 years prison, and a \$250,000 fine, or both.

Offense Level: Felony

Offense Date (on or about): 01/17/2015

Control #(ICR#): 15000684

Charge Description: On or about January 17, 2015, within Rice County, Minnesota, the defendant, Jeffery Neal Conrad, did unlawfully and feloniously sell, as defined by Minn. Stat. degree 152.01, subd. 15a, one or more mixtures containing a narcotic drug, to wit: 1.3 grams of methamphetamine.

Neal Conrad, knowingly or intentionally used or possessed drug paraphernalia.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

Your Complainant and/or Signing Officer designated below, being duly sworn, has reviewed police reports relating to the above-named Defendant and the allegations contained herein, and/or has spoken with peace officers having knowledge of the incident, and based upon that information, believes the following to be true and correct.

On January 17, 2015, at approximately 3:30 a.m., Faribault Police Department officers responded to a call at 1723 Second Street SW, #1, Faribault, Minnesota in Rice County. There was a report of a disturbance with people yelling and screaming. Once at the apartment, officers spoke with JJR, who had a small laceration on the bridge of his nose and a small cut on his right hand. The injuries appeared fresh. JJR allowed law enforcement to enter to make sure everyone was okay. Officers also found DJS, pretending to sleep in a nearby bedroom. He said that he was fine as well.

In another bedroom, Officer Marvin found a male sitting on the floor attempting to hide. The male refused commands to exit the room and was removed by law enforcement. The male was later identified as JEFFREY NEAL CONRAD (date of birth, 06/18/1985, the defendant). During a search of the defendant, Marvin detected what he believed to be a meth pipe in the defendant's left front pants pocket. The defendant confirmed that it was a pipe, and further confirmed that he had methamphetamine on him, as well as a warrant out for his arrest. Law enforcement confirmed he had a Felony warrant out for failure to appear for a Jury Trial.

In a further search of the defendant, law enforcement found the following:

- * 3 small baggies of suspected methamphetamine;
 - * Each bag field-tested positive for methamphetamine;
 - * First bag: 0.31 grams;
 - * Second bag: 0.26 grams;
 - * Third bag: 0.73 grams;
 - * Total weight: 1.3 grams;
 - * All weighed without packaging;
- * 9 small clear empty cellophane packages;
- * 1 digital scale;
- * Green plastic container with amount of suspected marijuana, 12.06 grams;
- * 3 small metal marijuana pipes;
- * 1 glass marijuana pipe;
- * 31 pills, Clonazepam, 2MG (prescription bottle with the name, BB)
- * 9 pills, Lorazepam, 1 MG; and
- * 1 pill and two half pills, Alprazolam, 2 MG.

Methamphetamine is a Schedule II narcotic drug. Alprazolam, Lorazepam and Clonazepam are Schedule IV controlled substances.

The defendant has the following subsequent controlled substance convictions:

On May 12, 2009, the defendant was convicted of Controlled Substance Crime in the Fifth Degree in Rice County District Court File No. 66-CR-07-463.

On April 2, 2009, the defendant was convicted of Controlled Substance one in the Fifth Degree in Rice County District Court File No. 66-CR-09-454.

On December 15, 2010, the defendant was convicted of Controlled Substance Crime in the Fifth Degree in Rice County District Court File No. 66-CR-10-3083.

On December 15, 2010, the defendant was convicted of Controlled Substance Crime in the Fifth Degree in Rice County District Court File No. 66-CR-10-3100.

On June 10, 2013, the defendant was convicted of Controlled Substance Crime in the Fifth Degree in Rice County District Court File No. 66-CR-12-2328. Sentencing is scheduled for November 13, 2013.

PLEASE TAKE NOTICE: Pursuant to Minn. Stat. 609.49., intentional failure to appear for duly scheduled court appearances may result in additional criminal charges, and in addition to any arrest warrant that may otherwise be issued by the Court.
