## Robbery Suspects Arrested

On Tuesday, August 18th, officers were dispatched to a reported robbery. **Officers Chris Tonjum, John Gramling** and **Sergeant Eric Sammon** arrived. The victim waved and pointed at three fleeing men, telling the officers that those were the suspects. Ofc. Gramling was able to stop and detain one of the men. Ofc. Tonjum spoke to the victim, who stated he had been approached by three men demanding his money and grabbing at his pockets, but fled before taking anything. As the victim spoke to Ofc. Tonjum, he also pointed out a man standing nearby and identified him as another suspect. That man was also detained and identified as Salman Dahir, 27. Both suspects were transported to the police department for questioning. Dahir was jailed, and the other suspect was released pending further investigation. The victim was able to identify the third

suspect from a photo lineup. Later that evening, **Officer Mallory House** stopped a vehicle for a traffic violation, and recognized the third suspect, Abdulkadir Adan, 29, inside the vehicle. Adan was arrested and jailed without incident. Dahir was charged with Attempted Simple Robbery, and his bail was set at \$25,000 without conditions. Adan was charged with attempted Simple Robbery and Interference with an Emergency

Call, and his bail was set at \$60,000 without conditions. **Detectives Matt Kolling, Scott Duncan, Sergeant Brandon Gliem** and **Captain Jason Severson** also assisted with the investigation.

## Search Warrant Nets One

On Thursday, August 13th, agents of the **Cannon River Drug and Violent Offender Task Force** executed a search warrant at a Faribault residence. The Rice County Emergency Response Unit assisted with entry into the residence. **Officer Mike Thul** and **K9 Chase**, **RCSO Investigators Paul LaRoche** and **Nate Hanson**, Northfield Police **Detective Brian Kramer** assisted with the search. In one of the bedrooms, agents found several small baggies and a glass pipe with residue. The items field-tested positive for methamphetamine. The agents also

found a Sig Sauer .40 caliber handgun in a safe inside the residence. The suspect, Kevin Savoie Jr., 36, was arrested and jailed without incident. He was charged with 5th Degree Drugs and Possession of Firearm - Convicted for Crime of Violence. His bail was set at \$25,000 without conditions.



## Domestic Assault Arrest

On Monday, August 17th, **Officers Mallory House, Adam Marvin, Tom Mueller** and **Ben Johns** responded to a reported domestic assault. The victim stated he had arrived home to find his fiancée intoxicated. She became upset with him and began swinging at him, striking him in the face. Ofc. House could see scratches and marks consistent with an assault on the victim's arms and face. He left and went to a friend's residence to get away



from her. About 15-20 minutes later, she arrived at the friend's house and continued yelling and swearing at the victim. She left when the friend called the police. The suspect, Carrie Love, 34, was found bicycling back to her residence and stopped. She was arrested, sent to a detox facility and then jailed. She was Charged with Domestic Assault and Disorderly Conduct. She was released on her own recognizance.
