Keynote Speaker:

PHILIP KENNICOTT

Philip Kennicott is the Pulitzer Prize-winning Art and Architecture Critic of *The Washington Post*. He has been on staff at the *Post* since 1999, first as Classical Music Critic, then as Culture Critic. He was a finalist for the Pulitzer Prize in 2000 for editorial writing and in 2012 for criticism, and an Emmy Award nominee in 2006 for web-based video journalism. In 2015, he was a finalist for the National Magazine Award in the Essays and Criticism category. He is also a former contributing editor at *The New Republic*, a reviewer for *Gramophone* and a frequent contributor to *Opera News*. He served as music critic and an editorial writer at the *St. Louis Post-Dispatch* from 1995-1999.

JAMES C. MILLSTONE

Millstone was often described as the conscience of the *St. Louis Post-Dispatch*. A brilliant newsman who combined a passion for honest reporting with remarkable personal integrity, he exerted a powerful influence over the content of the newspaper and served as a model and inspiration to its staff for more than 30 years.

Aside from fairness, Millstone’s passions in journalism were primarily in the areas of civil rights, the law and social justice. As a reporter, he covered the civil rights movement of the early 1960s; the riots in Washington, D.C. after the assassination of Dr. Martin Luther King Jr.; the police riot at the Democratic Convention in 1968; and, for many years, the Supreme Court. As an editor, he conceived and supervised reporting on such subjects as police brutality, the juvenile justice system and the bicentennial of the United States Constitution.

As the newspaper’s top news editor, Millstone influenced the direction of the paper and was a mentor to many young reporters. The Millstone Lecture Series was designed to perpetuate interest in his many journalistic passions, which included the legal system and civil liberties.
