2014 PUBLIC OPINON SURVEY

Survey conducted September 13th through September 14th, 2014. 604 St. Louis County residents participated in the survey. Survey weighted to match demographics of U.S. Census. Margin of Error is +/- 3.53% with a 95% level of confidence. Totals do not always equal 100% due to rounding.

Q: From what you have heard, was the shooting of an African-American teen by law enforcement in Ferguson, Missouri justified?

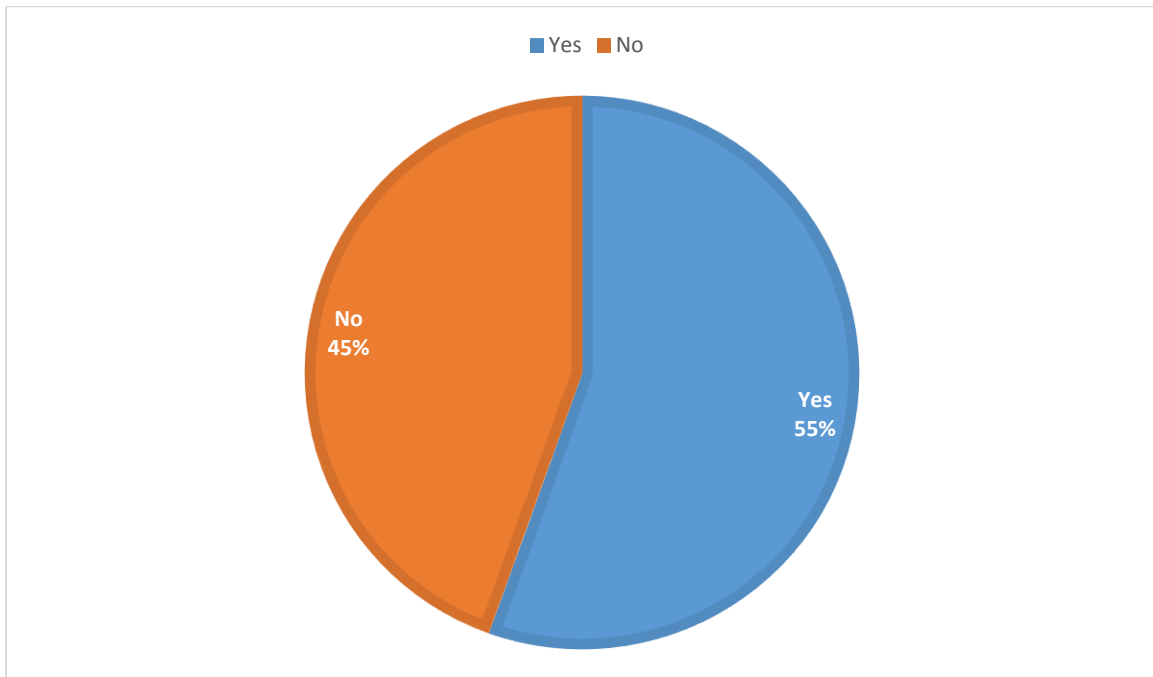


Figure 1. Total sample; base n = 604

Q: In your opinion and from the information you have, who is most responsible for the violence, rioting and looting in Ferguson, Missouri?

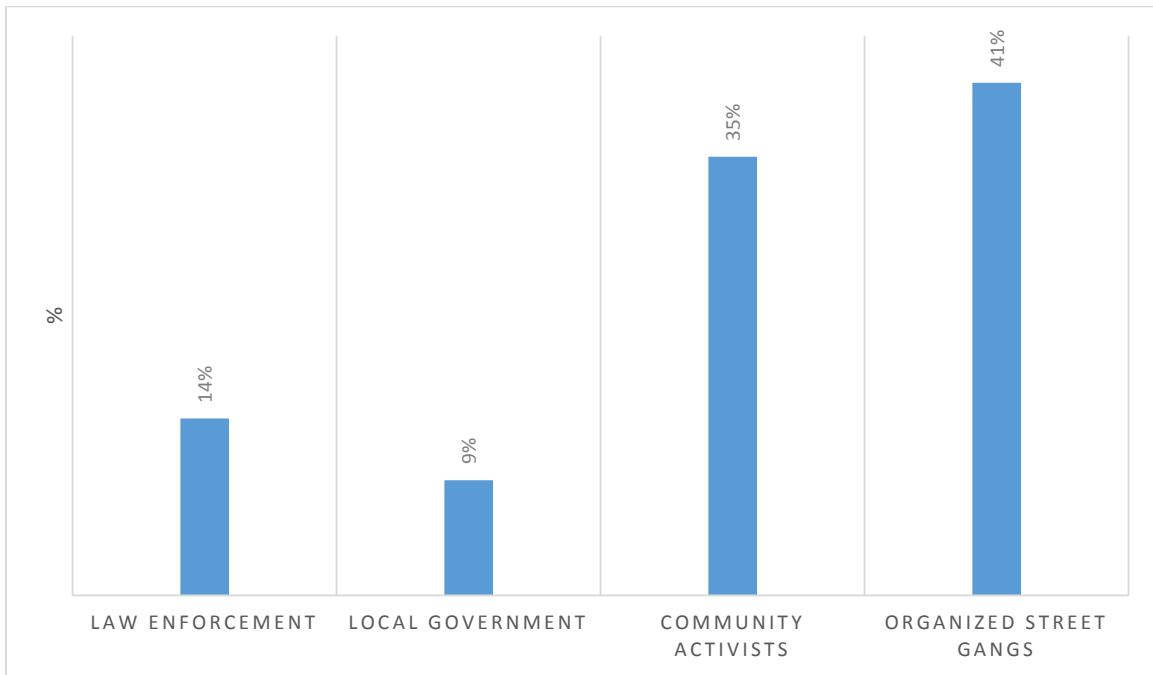


Figure 2. Total sample; base n = 604

Q: In your opinion, do you believe the African-American teen shot and killed by a law enforcement officer in Ferguson, Missouri was targeted because of his race?

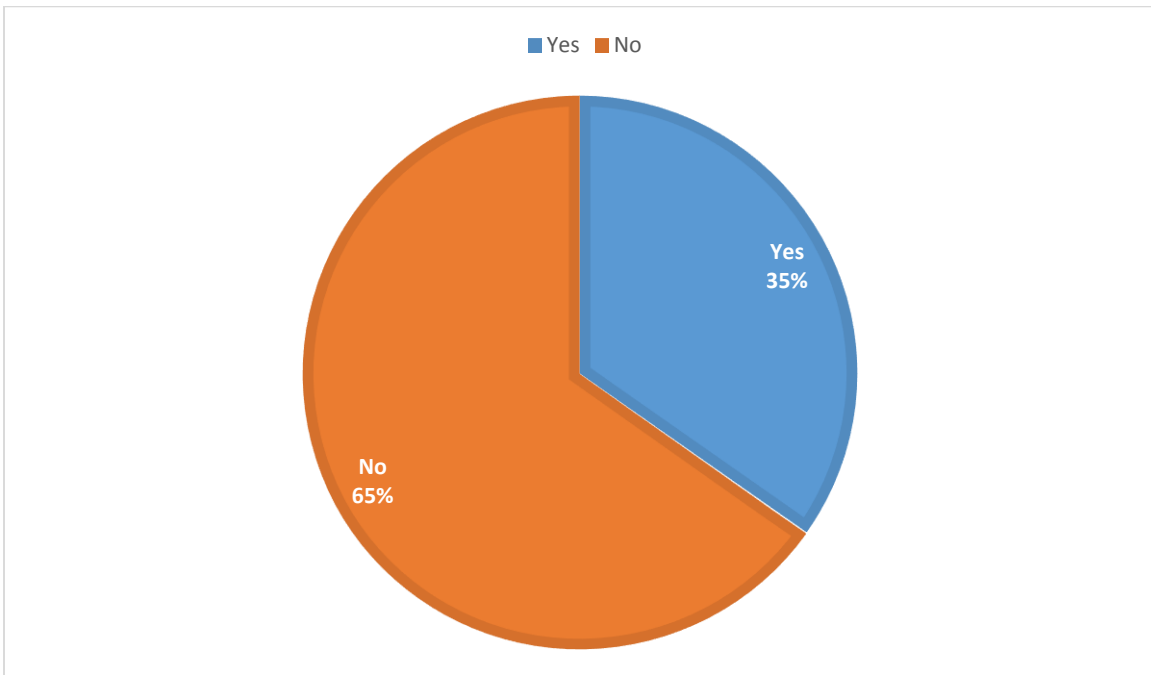


Figure 3. Total sample; base n = 604

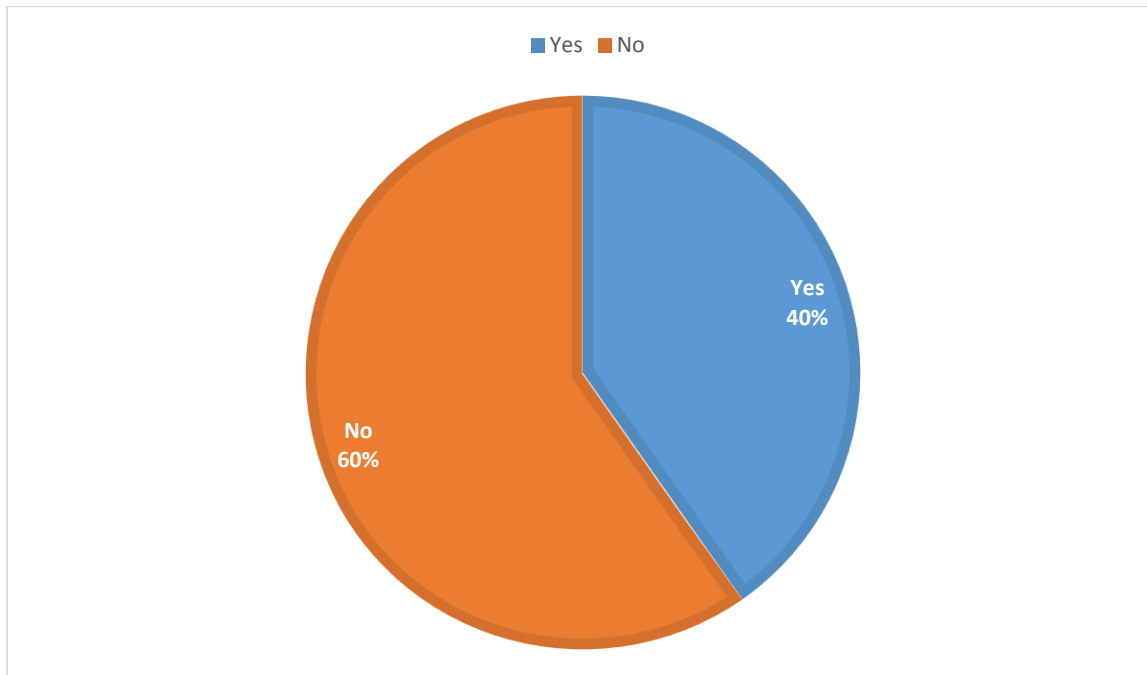


Figure 4. Total sample; base n = 604

Q: In your opinion, how do you view Governor Jay Nixon’s handling of the situation in Ferguson, Missouri?

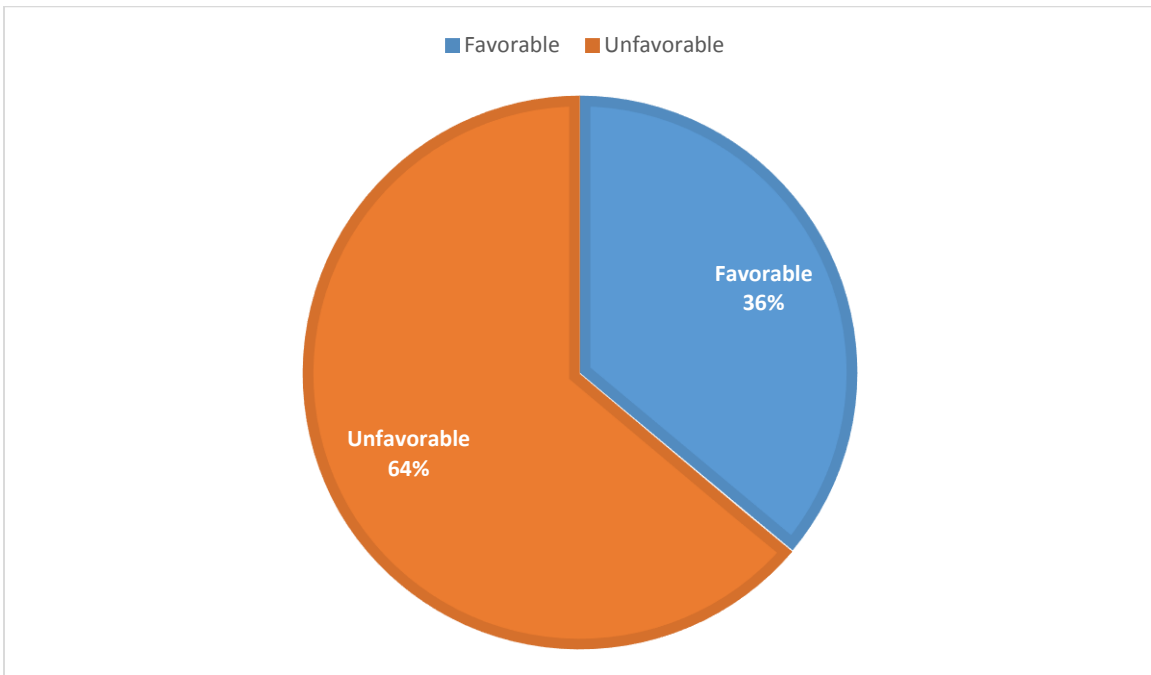


Figure 5. Total sample; base n = 604

Q: In your opinion, has the media made the situation in Ferguson, Missouri better or worse?

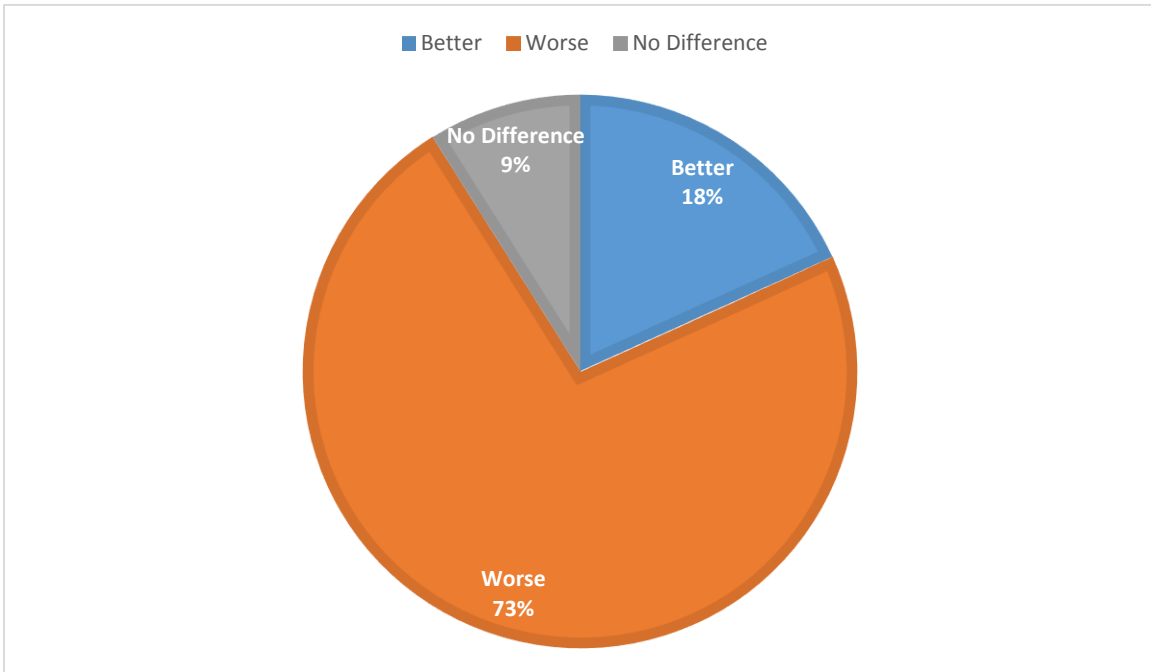


Figure 6. Total sample; base n = 604

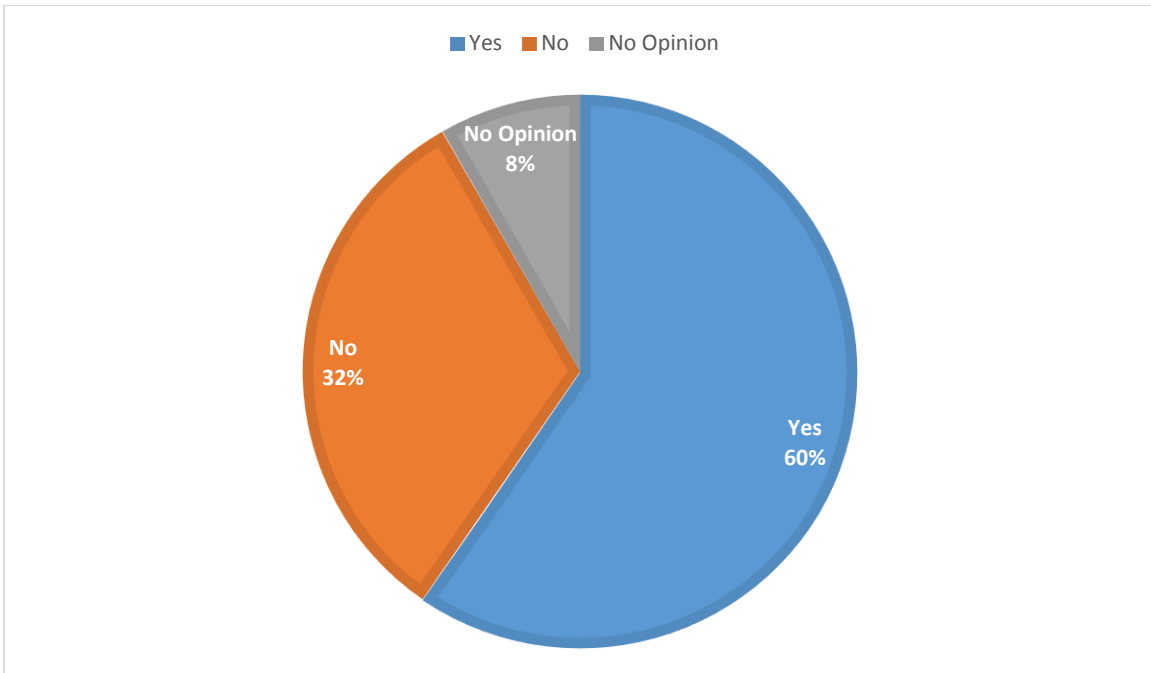


Figure 7. Total sample; base n = 604

Q: Generally speaking, and in your opinion, are African-Americans unfairly targeted by Law Enforcement because of their race?

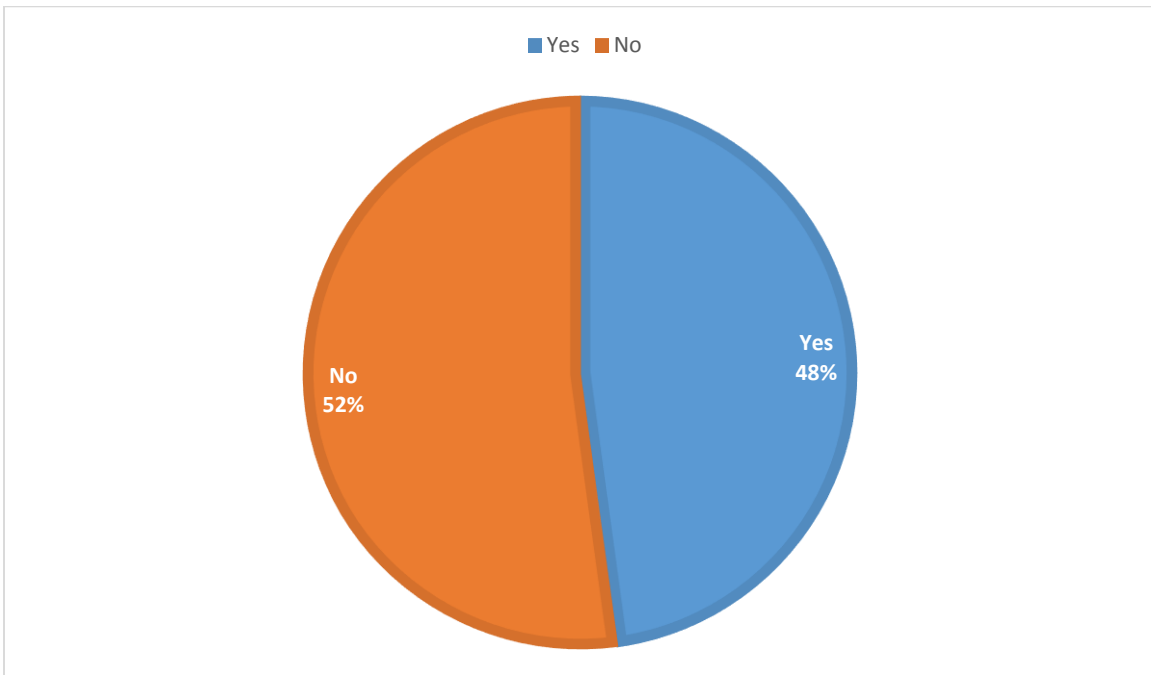


Figure 8. Total sample; base n = 604
