

NOTICE HEREBY IS GIVEN that the Board of Managers, Nine Mile Creek Watershed District, will hold a public hearing at 7:00 p.m., August 29, 2007, in Eden Prairie City Hall, City Council Chambers, 8080 Mitchell Road, Eden Prairie, Minnesota 55344, on a pending petition for the Eden Prairie Lakes Water Quality Improvement

Project ("Project").

The Project proposes to construct regional ponds to treat stormwater runoff flowing to Southwest and Northwest Anderson Lakes, Bryant Lake and Birch Island Lake; provide in-lake alum treatment of Bryant Lake; install a stormwater conveyance system to restore surface and groundwater flows from north of Highway 62 to Birch Island Lake; restore wetlands and extend a public trail adjacent to the Cardinal Creek area; modify the water elevation control structure between Southeast and Southwest Anderson Lakes; and drawdown Southwest and Northwest Anderson Lakes to address invasive plant species and water quality issues. A chemical treatment alternative is being considered either alone or in combination with the drawdown for Southwest and Northwest Anderson

On August 16, 2005, the City of Eden Prairie petitioned the Managers to establish and implement the Project. The Managers directed the District engineer to report whether the Project was feasible and provide a plan of the proposed work. The engineer's report was filed with the Managers in June 2006, and submitted to the Director, Division of Waters, Minnesota Department of Natural Resources and the Minnesota Board of Water and Soil Resources for review. The Director and the Board filed with the Managers their advisory reports approving the Project as being a practical plan. The Managers determined the damages to the properties subject to temporary or permanent easements by obtaining appraisals of those properties, which along with the engineer's report and plans are on file at the District office located at 7710 Computer, Suite 135, Edina, MN 55435 and subject to

inspection.

The estimated cost of the Project is \$1,928,000 plus the cost to acquire needed easement rights, as set forth in the engineer's report. The estimated cost of a project alternative that would include a combination of partial drawdown and chemical treatment of Southwest and Northwest Anderson Lakes is \$2,800,000. The Managers propose to fund the Project by a tax levied by value on real property within the legal boundaries of the watershed district. The City of Eden Prairie will pay for a portion of the easement

acquisition cost.

The Board of Managers held a public hearing on December 7, 2006 on this project at Eden Prairie City Hall, and left the record open for comment until December 13, when the Board of Managers determined that the recommendations of the District engineer as enumerated above are consistent with the objectives of the City's petition; consistent with the District's use attainability analyses for Birch Island, Bryant and Anderson Lakes; and will be conducive to public health, promote the general welfare, comply with watershed law, and result in benefits greater than the cost of Project implementation and damages. The Board of Managers granted the petition of the City of Eden Prairie, confirmed the Engineer's report, and ordered that the Project be established and constructed, and that voluntary conveyance of necessary easements be pursued, and that the Engineer, under direction of the Administrator, be ordered to proceed with making the necessary surveys, plans, and specifications, and advertise for bids.

In April 2007, residents on Anderson Lakes contacted the District and expressed concerns with the portion of the Project involving the drawdown and modified elevation control structure on Anderson Lakes. Accordingly, the Board of Managers

agreed to convene a further public

hearing on May 30 for the purpose of taking further testimony from any interested party concerning any aspect of the Project. Thereafter, the District prepared a draft Environmental Assessment Worksheet (EAW) concerning the Anderson Lakes elements of the Project, a copy of which may be obtained from Kevin Bigalke, District Administrator, 7710 Computer Avenue, Suite 135, Edina, MN 55435; telephone (952) 835-2078; or on the District web site:

The Board of Managers held a public hearing to receive comments on the draft EAW on July 19, 2007. A further hearing to receive comments on the project and the draft EAW will be held on August 29 as noted above. Written comments on the draft EAW were initially due at the District Office on or before August 15, 2007, but due to a publication error, that deadline has been extended to September 12,

On September 19, the Board of Managers will meet at Eden Prairie City Hall, Mitchell Road, Eden Prairie, Minnesota 55344, to determine whether an environmental impact statement (EIS) is necessary, and if no EIS is necessary, whether to order the project to proceed as originally ordered on December 13, 2006 with a drawdown of Southwest and Northwest Anderson Lakes; whether to order a chemical treatment of the lakes: whether to order a combined partial drawdown and chemical treatment; or whether to otherwise modify or delay the project.
