WHEREAS, City staff has received a Petition for Local Improvement to complete a feasibility study for street improvements along Lilac Street south of 78th Street to termination, 79th Street from Lilac Street to Marigold Street, Marigold Street from 79th Street to 79-1/2 Street, and 79-1/2 Street from 79th Street to Lilac Street,

1. This declaration is made in conformity to Minn. Stat. Section 429.035.

The petition is hereby referred to the City Engineer and that person is instructed to report to the council with all convenient speed advising the council in a preliminary way as to whether the proposed improvement is necessary, cost-effective, and feasible and as to whether it should best be made as proposed or in connection with some other improvement, and the estimated cost of the improvement as recommended.
