Careers in Dentistry: It is so much more than just drill and fill !!- Part 3

In the last two columns we discussed various careers in dentistry including the dentist, dental assistant, and dental hygienist. This week we will explore the roles of the dental office administrator/receptionist and dental laboratory technician. The dental office administrator/receptionist answers the telephone, makes appointments, helps patients with submitting dental insurance claims, and handles billing and accounting The amount of education held by the dental receptionist can vary usually including some studies in business administration. The dental laboratory technician usually works outside of the typical dental office setting in a dental laboratory. The dental laboratory is the main location where dental prosthese such as crowns, bridges and dentures are made. The dental laboratory technician requires exceptional artistic ability and attention to detail since their expertise is what determines the fit and appearance of all dental prostheses made outside of the dental office. They handle materials such as gold alloys, porcelain and plastic resins. The dentist works closely with the dental laboratory technician in communicating the desired results for the patient. The dental laboratory technician usually attends a two-year technical program with hands-on




