NOTICE OF HEARING ON PROPOSED SPECIAL ASSESSMENTS

Notice is hereby given that the City Council will meet at 7:00 p.m. on Tuesday, March 31, 2015 in the City Center, 8080 Mitchell Road, Eden Prairie, Minnesota, for the purpose of holding a Public Hearing to consider the proposed assessments for the following improvements in Hennepin County, Minnesota, Township 116, Range 22:

Attorney's fees and litigation costs incurred for abatement of nuisance pursuant to Minn. Stat. § 429.101 subd. 1(3) (2014) 07-116-22-32-0016

The total amount to be assessed is \$13,057.00

The proposed assessment roll is now on file with the City Clerk and in the office of the City Engineer and is open to inspection by all persons interested. All persons who wish to be heard with reference to the assessment roll should be present at the hearing to present either written or oral objections. Written or oral objections thereto by any property owner will be considered by the Council prior to the adoption of the assessment roll.

CAUTION: No appeal may be taken as to the amount of any assessment adopted unless a written objection, signed by the affected property owner, is filed with the City Clerk prior to the assessment hearing or presented to the presiding officer at the hearing. An owner may appeal an assessment to the District Court pursuant to Minnesota Statutes 429.081, by serving notice of the appeal upon the Mayor or City Clerk within 30 days after the adoption of the assessment and filing such notice with the District Court within ten days after service upon the Mayor or Clerk. For your further information, please note the following: Pursuant to Minnesota Statutes 435.193 through 435.195, which establishes a hardship assessment deferral for seniors or retired disabled, the procedure to obtain a deferred assessment and sets forth the events upon which the option to defer payment terminates and all amounts accumulated plus interest become due. Pursuant to these statutes, the City may defer the payment of special assessments for homestead property of persons 65

years of age or older or retired by virtue of a permanent and total disability for whom it would be a hardship to make the payments, who meet certain standards relating to eligibility. A deferment procedure is authorized by City Code Section 2.84 and has been established by City Resolution 83-177. The principal amount of special assessments deferred for such persons will bear interest, but not exceeding 50% of the original principal amount of the assessment. Payment of the interest will also be deferred and will be added to the principal amount of the deferred assessment. Any person who wishes to receive a deferment must make application to the City Engineer's office no later than November 10th of the year preceding the year in which an assessment is payable. ALL ABOUT CULTURE

According to the White House's website, President Barack Obama has been taking steps to "chart a new course" in the country's relations with Cuba, including re-establishing diplomatic relations with Cuba that were severed in January 1961 and expanding travel under general licenses for 12 existing categories of travel to Cuba, which includes educational purposes.

Skaar Meier said every tour that goes into Cuba has to have a cultural piece to it.

"You can't go on a beach vacation," she said. "You are the ambassador from this country going to learn about the cultural and economic pieces of their country."

According to the preliminary itinerary, the group would depart on April 2, 2016, and arrive in Miami where they would receive a briefing and review of documents from an ACIS representative.

The group would arrive in Havana on April 3, and visit Revolution Square to learn about historic events; eat lunch at Sloppy Joe's Restaurant; go on a walking tour of World Heritage sites in Old Havana and discuss the country's new free enterprise policies with booksellers in Plaza de Armas.

The rest of the week would include day trips to Soroa, Las Terrazas and Cojimar, the setting for Ernest Hemingway's "The Old Man and the Sea," and various locations in Havana such as the Fine Arts Museum of Havana and Centro Cultural Antiguos Almacenes San Jose. The group would leave Cuba on April 10.

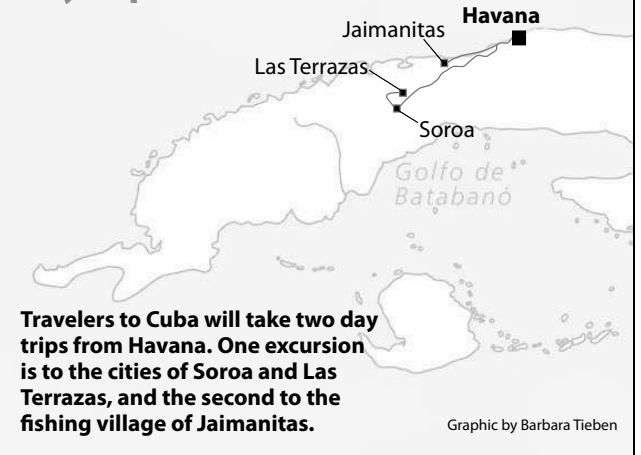
Skaar Meier and Cwodzinski plan to add other activities to tailor the trip to the participants' interests. Everyone is required to do the cultural pieces during the day, but the group is

free to do what it wants during afternoons and evenings," Skaar Meier said.

"It's not like you have a curfew. We'll go out every night to experience the restaurants and the night life. We really do want to see it from the perspective of the people that live there," she said. "We'll want to be going out to the markets and shops."

Skaar Meier said either she or Cwodzinski hope to attend an ACIS conference in Cuba in January 2016 to get a better idea of what's available. She added that she would consider adding something about sugar cane or cigars because they were once Cuba's biggest exports, or maybe baseball because it's a big sport there.

"I'm really interested in economic development for sustainable farming that they have. They do have a sustainable farm that we are going to go visit and I'm really interested in that part of the community," she said. She added that Cwodzinski said that he's

excited to learn more about the political aspect of Cuba and its art.

WANT TO KNOW MORE?

Skaar Meier said an informational meeting is scheduled for 6:30 p.m. March 19, in room 123 of Eden Prairie High School (near the east entrance). During the meeting she will have literature available and will discuss the trip, itinerary and protocol expectations.

"Cuba is only allotting so many people in the country each week with these organized groups. I have to work a year in advance," she explained.

She said the base cost of the trip is \$3,600 and includes 21 meals. An interpreter will be available but trip participants will be taught some basic phrases to use during the trip. "[We] want them to be part of the culture," she said.
