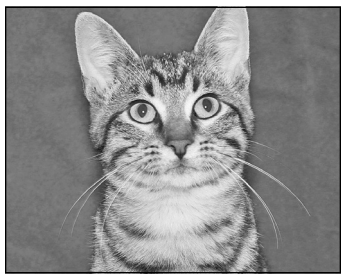

The Minnesota Landscape Arboretum, the largest public

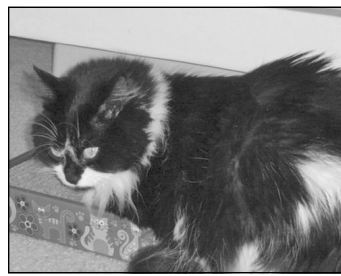

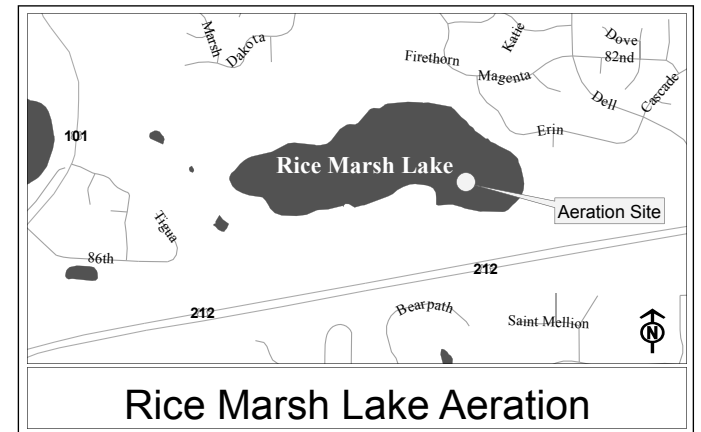
