To get an idea of what is possible, visit the Minnesota Landscape Arboretum now through March 31. On a recent morning, Lilia Smith and her mom, Laura, of Minnetonka and family friend Linda Solender of St. Louis Park, examined and exclaimed over the miniature fairy gardens displayed in the Oswald Visitors Center.

## SMALL AND CUTE

Anna Risan could be considered the local godmother of miniature gardens. Risan said she's always loved doll houses and miniatures. She thought it would be cute to incorporate some dollhouse miniatures with small-scaled plants.

"I started making little table-top pots," Risan said, 'to see how people liked them. Well, they loved them. Eventually, we started doing seminars, added more miniature inventory plants and garden furniture and fairies, gnomes, and elves, and it just got bigger and bigger.

"Anytime I see anything miniaturized, it tickles my fancy," Risan said. "I'd say we're considered fairy garden specialists now. We have people from all over country calling with questions and suggestions. Other greenhouses call, interested in learning how we got started, wanting to do a similar thing in their nursery.

Unlike a life-sized yard or garden, fairy gardens can be as simple as a small pot with a bridge and a troll. Then add a variety of small-scaled plants such as baby tears and sedum.

"They can be small or big and elaborate," Risan said. "It combines our love for plants and a love of playing and using your imagination.

"This is the time of year to have a little pot inside the house," she said. "You still have to trim the bushes and mow the baby tears of course. But it's a lot less work. It gives you a giggle. It's like walking into spring."
