These are the times when we may have to look a little harder, and dig a little deeper, to find things to be

grateful for. I thought about this after the speech contest on Saturday, and tried to come up with a list of things to be grateful for. It really wasn't that difficult. I'm grateful that I had the opportunity to take part in the contest in the first place, and that no matter what the outcome of the contest was,

I know I did my best. I'm grateful for the information and entertainment that came from the other speakers in the contest, and for the chance to meet some new and interesting people. Although I love competing, I'm grateful that the time it would take to practice and prepare for the next level of competition is time I can now devote to other things that are also very important to me. And I'm grateful I have people in my life who made sure I remembered that.

It seems to me that we can get more benefit from feeling grateful for the things that go wrong in our lives than for the things that go well. It's easy to be grateful when we win, but it's when we lose that gratitude helps pull us out of our slump. It allows us to learn from our mistakes and misfortunes, to see the bigger picture, and to take positive action to improve the situation instead of sitting around feeling sorry for ourselves.

Thinking about it that way makes me realize that gratitude is actually a tool. And whenever we experience a defeat, delay, or disappointment in our lives, it's the very first one we should reach for in order to fix the problem. No contest.

Sec.30-2. Impervious surface area means any material that substantially reduces or prevents the infiltration of stormwater.
