## Area real estate agent featured in show on HGTV

Amy Jurek to be on 'My House is Worth What?'

Searching for her 15 minutes of fame, a local real estate agent has cashed in on about 7 minutes worth and is looking to redeem the balance in the near future.

Amy Jurek of Prior Lake, who is an agent with Re/Max Advantage Plus of Savage, appears with the on-screen title "Real Estate Expert" in a segment of the HGTV series "My House is Worth What?" The program aired in December and will be shown again at 10: 30 p.m. Tuesday, Jan. 23 and 2:30 a.m. Wednesday, Jan. 24.

Jurek said that she often watches HGTV shows and has commented to her husband in the past that she'd like to be on one of the real estate-based reality programs. So, when the broker for her Re/Max office asked her if she'd be interested in "My House is Worth What?" she jumped at the opportunity.

Her self-proclaimed cheesy audition tape was a mock showing featuring family members. "It was a horrible

tape," she recalls of the submission but, two weeks later, she got a call from a production company to fill the Minneapolisarea slot.

Basically, Jurek said, the show features real estate agents walking through a property with the owner and telling them. based on the type and condition of the home and improvements made since the original purchase, what price tag could be put on their home.

It also gives people a chance to see what the housing market is like in other parts of the nation. Jurek speculates that as many agents watch these sorts of shows as do members of the general public "and you can sit in Minnesota and see what a condo in Miami is worth," she

Jurek is able to speak about the downturn in the real estate market in the Twin Cities, noting that it's making all agents "work harder and work smarter ... it's making us all sharpen our tools. She urges people to focus on "the wow factor" when putting their homes up for sale.

While her expertise is in the south-metro area, the home Jurek was asked to appraise was in Maple Grove. However, her knowledge of the

metro-area real estate market stretches throughout the area so she was able to confidently get the job done.

During the segment, Jurek tells the homeowners the value of their do-it-yourself renovations and recommends additional projects to maximize their profit.

Jurek didn't get any TV makeup and her fashion advice was simply to steer clear of stripes and suits. The sevenminute segment was shot May 1 and it took a day to complete. 'We worked from 9 to 6," Jurek said, "but, overall, it was a fun experience.'

Despite the long hours for minutes of air time, Jurek said she would absolutely do it again and, in fact, she's been asked to do an episode of "House Hunters" for the network.

Jurek said she likes the idea of making real estate entertainment. "I'd love to be the Rachel Ray of real estate – only without the cooking," she

Identifies the effective date of Ordinance. Ordinance 2006-03, an "Ordinance

Regulating the Construction and Maintenance of Driveways/Culverts within the Township" shall take effect and be in full force immediately following its adoption and upon publication.
