Subject: Notice of Property Removal – Forest Glen Apartments

Dear «firstname»,

This is to inform you that the University will be removing Forest Glen Apartments during the summer of 2013 in accordance with the Campus Master Plan. Residents of Forest Glen will be required to relocate to alternate housing prior to May 31, 2013.

Under the circumstances, we will attempt to offer alternate university-owned housing to current residents; however, we cannot guarantee your relocation to comparable housing. We are hopeful that providing significant notice of this situation will assist you in a successful relocation.

As the leaseholder, you should be aware of the following information.

If you are interested in moving to alternate university—owned housing prior to May 31, 2013, the following conditions will apply:

- 1) Leaseholder's rent must be current as of February 15, 2013 and remain current during the remainder of your stay at Forest Glen.
- 2) Leaseholder must maintain enrollment in at least six credit hours at UT Arlington during the Spring 2013 and Fall 2013 semesters.
- 3) Leaseholder must complete the attached Resident Relocation Request and return it to the Housing Office by February 15, 2013.
- 4) Leaseholders who have completed the requirements noted above will be given priority wait list status for their requested relocation community.
- 5) Priority of assignment to alternate housing shall be assigned by random drawing for all relocation requests that are received at the Housing Office by February 15, 2013.
- 6) Leaseholders who request to relocate will be given priority for university-owned apartments that are unassigned and available for occupancy between February 15, 2013 and May 31, 2013.
- 7) Leaseholders who request to relocate will be given priority over existing and future wait list applicants.
- 8) Leaseholders can only request one community to which they would like to relocate. In the event a leaseholder desires to change the requested relocation community at a later date, wait list priority shall be established based on the date of the requested change.
- 9) Leaseholders in one-bedroom apartments may only apply for another one-bedroom apartment. Similarly, leaseholders in two-bedroom apartments may only apply for another two-bedroom apartment.
- 10) When the University receives a notice to vacate for a requested apartment, the leaseholder will be contacted promptly regarding the future vacancy. In most cases, The University is provided a sixty-day notice by vacating residents.

- 11) Only one alternate housing offer will be made, so leaseholders are encouraged to accept the offer at the time it is made. Leaseholders who refuse an offer for alternate housing will be removed from the waitlist and will be given no further special consideration.
- 12) If the offer of alternate housing is accepted, the leaseholder must execute a new lease agreement for the new location and move into the alternate housing within seven days of the apartment being made ready for occupancy.

Please share this letter with any additional occupant(s) listed on your lease. Additional occupants should be particularly mindful of the following information.

Additional occupants who are listed on an existing lease and who are interested in relocating to other university-owned properties should go to the University Housing website immediately (www.uta.edu/housing) and apply as a new applicant. Additional occupants will not be given priority status in the relocation process and shall be considered as regular applicants.

In closing, I am pleased we have been able to provide you a temporary home at UT Arlington. Please let me know if I can offer any additional assistance. Your cooperation and understanding are appreciated.
