### TW Blazing HOT Bingo OFFICIAL RULES FOR CONTEST (January 2017-March 2017)

NO PURCHASE NECESSARY. A PURCHASE WILL NOT IMPROVE ONE'S CHANCES OF WINNING: Open only to residents of the United States within the Tulsa World circulation area who are currently of the age of majority in their state of residence, and who have the capacity to enter into legally binding contracts and satisfy all eligibility requirements.
