DETR Releases Local Area Employment Statistics for August

According to the Nevada Department of Employment, Training and Rehabilitation's ([DETR](#)) August 2025 economic report, the state's seasonally adjusted unemployment rate was 5.3 percent in August 2025 which decreased by 0.1 percentage point (pp) from July 2025. Seasonally adjusted estimates account for regularly seen economic patterns, with the following estimates not seasonally adjusted.

In the three Metropolitan Statistical Areas (MSA), the unemployment rates were 5.6 percent in the Las Vegas area, 4.2 percent in Reno, and 4 percent in the Carson area in August 2025.

In Nevada's counties, the lowest unemployment rate was in Pershing County at 3.4 percent, and Mineral County had the highest rate at 9.7 percent. For a look at the unemployment rate in your county, visit our [Area Profiles Page](#).

Counties and Cities Employment & Unemployment

In August 2025, the seasonally adjusted unemployment rate in Nevada decreased by 0.1 percentage points (pp) from 5.4 percent to 5.3 percent. The unadjusted rate went down by 0.3 percentage points from 5.6 percent to 5.3 percent. The number of employed individuals in the state went up by 106.

At the MSA (Metropolitan Statistical Area) level, the state saw a decrease in unemployment rate in all three of its MSAs. In the Las Vegas – Henderson – North Las Vegas MSA, the state saw a decrease in unemployment rate equivalent to 0.4 percentage points, moving from 6 percent to 5.6 percent. The Carson City MSA saw a decrease of 0.4 percentage points, going from 4.4 percent to 4 percent. The Reno - Sparks MSA also saw a decrease of 0.4 percentage points, going from 4.6 percent to 4.2 percent. These figures are not adjusted for seasonality.

At the county level, the state saw decreases in unemployment rate in all of its counties. The counties with largest decreases were Esmeralda, Eureka, and Humboldt with decreases of 2.4 percentage points, 0.8 percentage points, and 0.7 percentage points, respectively. The smallest decreases were seen in Clark, Washoe, and Storey County which all saw decreases of 0.4 percentage points.

Figures for state unemployment estimates come from the Local Area Unemployment Statistics (LAUS) program, a state/federal partnership sponsored by the Bureau of Labor Statistics (BLS-LAUS). This program produces monthly and annual employment, unemployment, and labor force data for census regions, states, counties, metropolitan areas, and many large cities, based on place of residence. 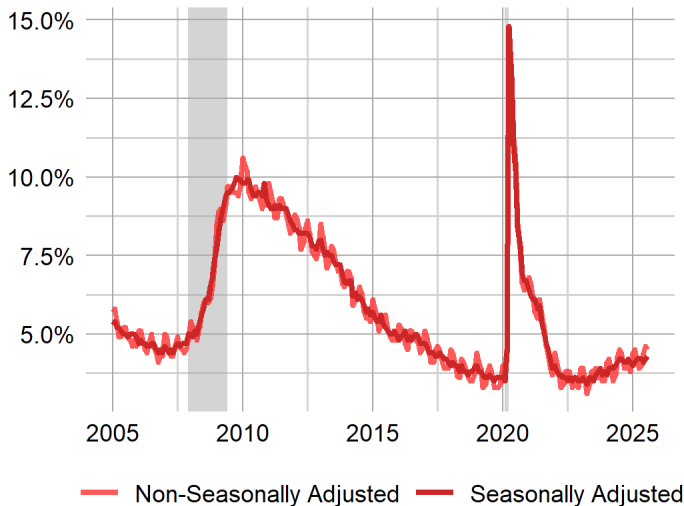

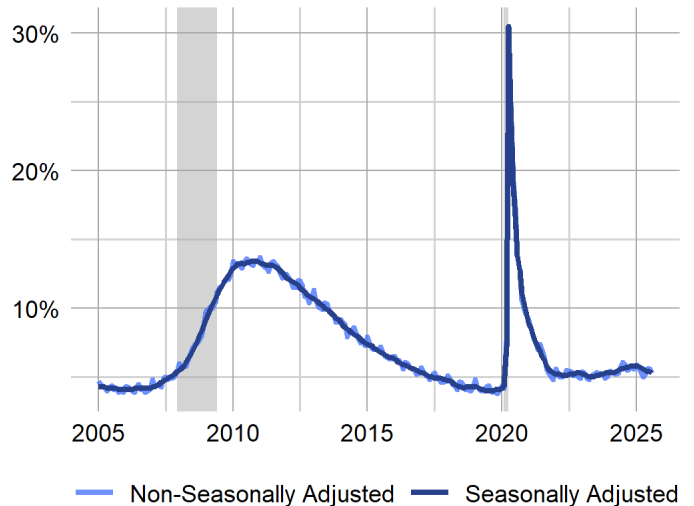
Seasonally adjusted estimates account for regularly seen seasonal employment patterns such as jobs associated with holiday hiring, holiday and weather seasons, or other jobs with seasonal components. The result of a seasonally adjusted estimate is usually a smoother estimate from which underlying economic trends can be seen. Adjusted estimates are in the summary table above, and in many of the other tables and figures throughout this document.

Nevada's seasonally adjusted unemployment rate was 5.3 percent in August, which decreased by 0.1 pp from 5.4 percent in July, and decreased by 0.4 pp from 5.7 percent in 2024. The number of unemployed individuals decreased by 1,409 from July to a current level of 88,547 people, which decreased by 5,487 unemployed people since 2024. The labor force in Nevada is currently 1,679,682 people, which has decreased by 1,303 people from July, and increased by 25,664 people since 2024.

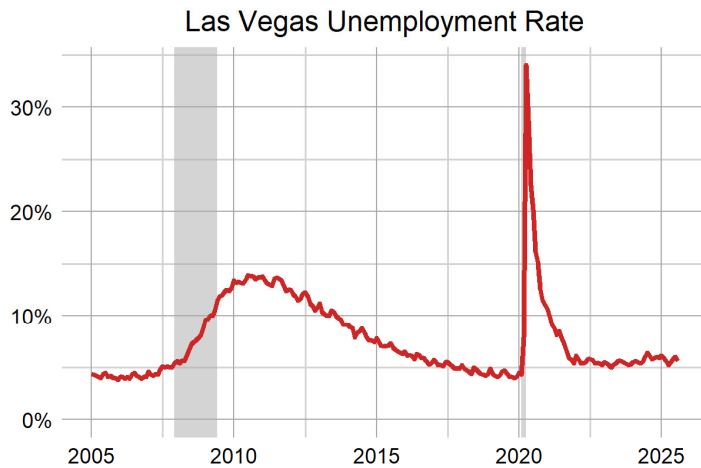
United States Unemployment Rate



Nevada Unemployment Rate

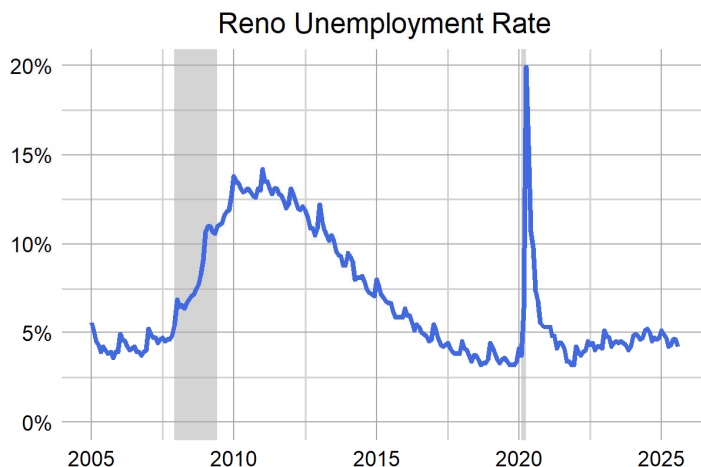


The Las Vegas Metropolitan Statistical Area's (MSA)s unemployment rate was 5.6 percent in August 2025, decreasing from 6 percent in July 2025, and down from 6.1 percent in August 2024, non-seasonally adjusted. The number of unemployed individuals decreased by 4,234 since July 2025 for a current level of 69,732 people, which is 5,467 less unemployed people than August 2024. The labor force in Las Vegas is currently 1,237,110 people, which is 2,127 less people than July 2025, and is up 14,117 people since August 2024.

The Reno MSA's unemployment rate was 4.2 percent in August 2025, decreasing from 4.6 percent in July 2025, and down from 5 percent in August 2024, non-seasonally adjusted. The number of unemployed individuals decreased by 1,153 since July 2025 for a current level of 12,634 people, which is 2,304 less unemployed people than August 2024. The labor force in Reno is currently 302,639 people, which is 462 more people than July 2025, and is up 4,126 people since August 2024.

The Carson City MSA’s unemployment rate was 4 percent in August 2025, decreasing from 4.4 percent in July 2025, and down from 4.7 percent in August 2024, non-seasonally adjusted. The number of unemployed individuals decreased by 113 since July 2025 for a current level of 1,196 people, which is 204 less unemployed people than August 2024. The labor force in Carson City is currently 30,026 people, which is 86 more people than July 2025, and is up 535 people since August 2024.

Unemployment Insurance Benefits

In August 2025, 11,739 initial claims for unemployment insurance were filed in Nevada, a decrease of 350 claims, or 2.9 percent, from August 2024 when there were 12,089 claims. This is also a lower number of claims than were seen in July 2025, when there were 12,563 initial claims.

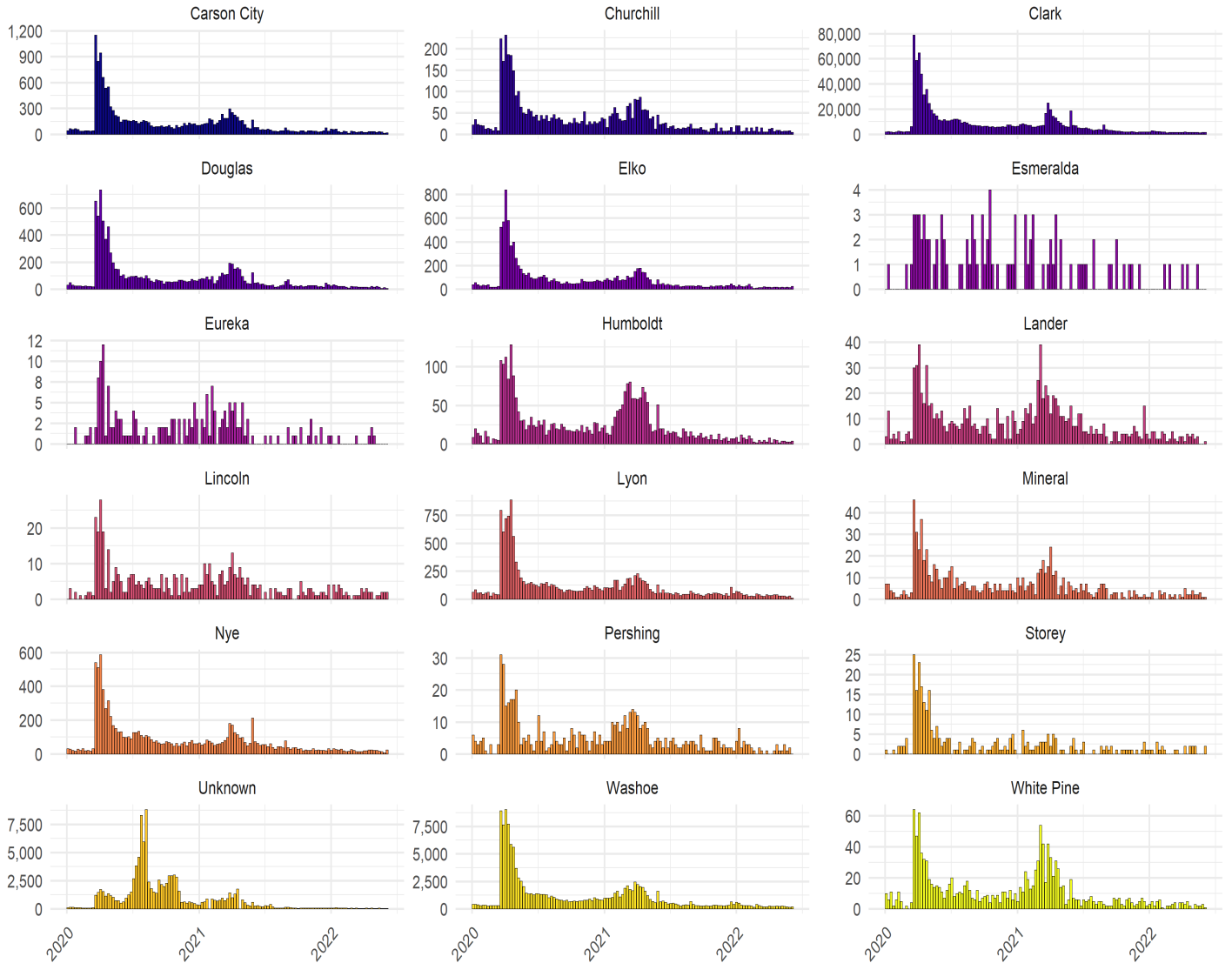

Initial Claims by County

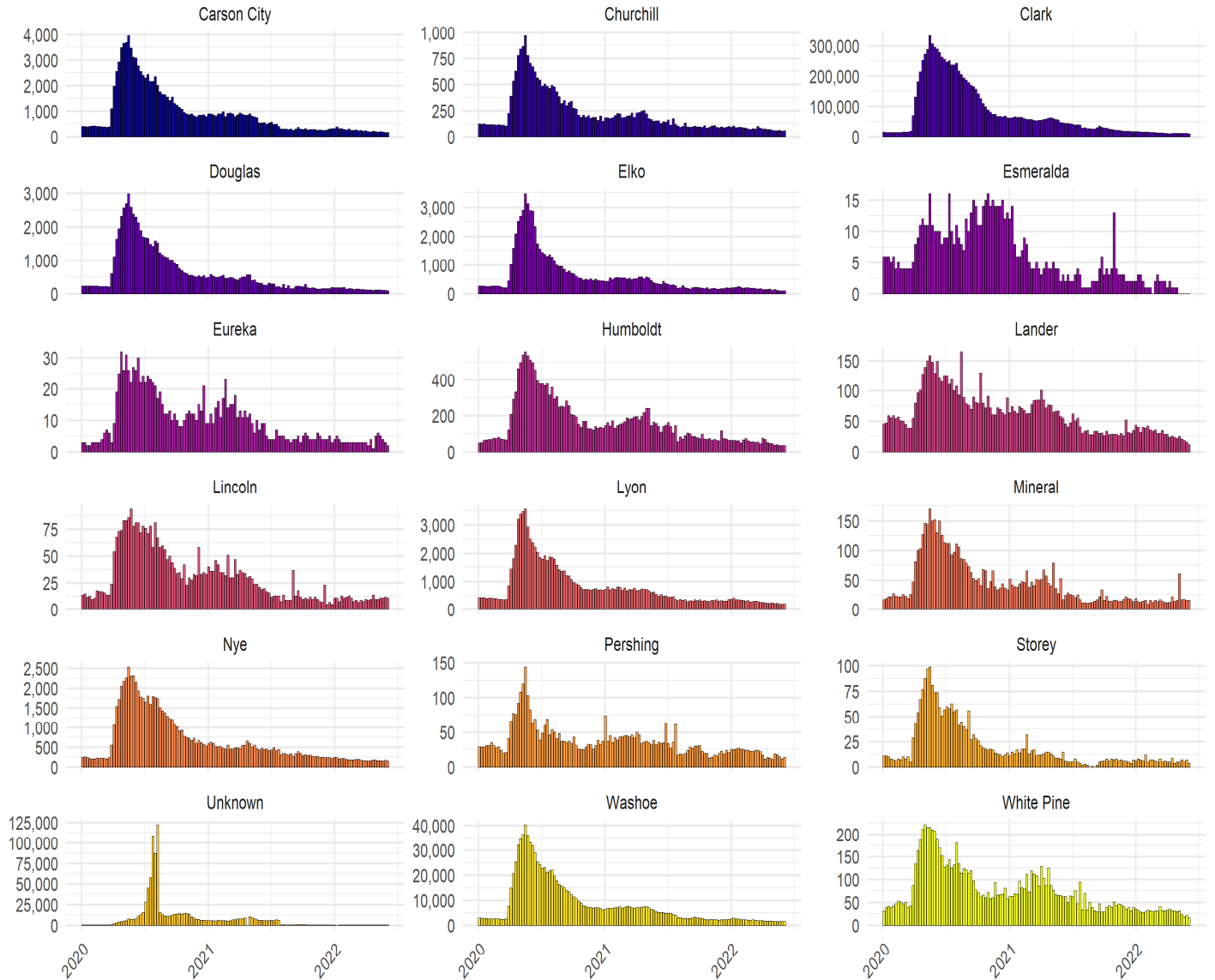
weekly claim totals since January 2020
