20 **ORDER GRANTING MOTION FOR BOND**

21 On May 31, 2023, the Supreme Court of Nevada issued an Order directing the
22 parties in this matter to renew their bond arguments in front of this Court. On June 5, 2023,
23 Real Party in Interest D/B/A RENO IRON WORKS (“Reno Iron”) Motion for Bond (“Motion”).
24 On June 20, 2023, Petitioner SOCIETY FOR THE PREVENTION OF CRUELTY TO
25 ANIMALS (“SPCA”) filed Reply to/in Opposition to Reno Iron Works Motion for Bond. On
26 June 22, 2023, this Court held a hearing on the matter.


27 After reviewing the pleadings and hearing argument during the evidentiary hearing,
28 this Court finds that bond will be granted in the amount of \$157,600 for a twenty-four month
delay as calculated by Reno Iron. This amount reflects the costs incurred to date,

1 demobilization, remobilization, and monthly maintenance costs. See Exhibit 1. This Court
2 will also grant bond in the amount of \$38,000 for temporary storage and lease costs
3 including the unloading of supplies and reloading to the job site. See Exhibit 2. Due to
4 inconsistencies in the financial costs disclosed to this Court by Reno Iron, this Court will
5 not be granting any bond in a higher amount.

6 IT IS HEREBY ORDERED THAT BOND WILL BE SET AT A TOTAL OF \$195,600.

7 IT IS SO ORDERED.
