16 **JUDGMENT OF CONVICTION**

17 The Defendant was found Guilty by a Jury and no legal cause being shown  
18 as to why judgment should not be pronounced against him, the Court enters judgment as  
19 follows:

20 That Joseph John Greco is guilty of the crime of LEWDNESS WITH CHILD  
21 UNDER THE AGE OF FOURTEEN YEARS, a violation of NRS 201.230, a category A  
22 Felony, as charged in Count I of the Second Amended Information, and that he be  
23 punished by imprisonment in the Nevada Department of Corrections for the maximum term  
24 Life with the minimum parole eligibility of ten (10) years, with credit for seventy-nine (79)  
25 days time served.

1 That Joseph John Greco is guilty of the crime of LEWDNESS WITH CHILD  
2 UNDER THE AGE OF FOURTEEN YEARS, a violation of NRS 201.230, a category A  
3 Felony, as charged in Count II of the Second Amended Information, and that he be  
4 punished by imprisonment in the Nevada Department of Corrections for the maximum term  
5 Life with the minimum parole eligibility of ten (10) years to be served consecutive to the  
6 sentence imposed in Count I, with no credit for time served.

7 It is further ordered that pursuant to NRS 176.035 Joseph John Greco's  
8 aggregated sentence is imprisonment in the Nevada Department of Corrections for the  
9 maximum term of Life with the minimum parole eligibility of twenty (20) years.

10 It is further ordered that Joseph John Greco shall pay Twenty-Five Dollars  
11 (\$25.00) as an administrative assessment fee, Three Dollars (\$3.00) as an administrative  
12 assessment for obtaining a biological specimen and conducting a genetic marker analysis,  
13 One Hundred Fifty Dollars (\$150.00) as a DNA testing fee, and submit to a DNA analysis  
14 to determine the presence of genetic markers to the Clerk of the Second Judicial District  
15 Court.

16 Joseph John Greco is hereby advised that: Any fine, fee or administrative  
17 assessment imposed today (as reflected in this Judgment of Conviction) constitutes a lien,  
18 as defined in Nevada Revised Statute NRS 176.275. Should you not pay these fees,  
19 collection efforts may be undertaken against you.

20 It is further ordered that pursuant to NRS 179D.460, Joseph John Greco  
21 shall register as a sex offender within 48 hours of sentencing or release from custody.

22 It is further ordered that pursuant to NRS 176.0931, Joseph John Greco shall  
23 submit to a special sentence of lifetime supervision that shall commence after any period  
24 of probation, or any term of imprisonment, or any period of release on parole.
