

21 On or about June 7, 2022, in the above named Judicial District, the crime of **ASSAULT WITH**  
22 **INTENT TO COMMIT A FELONY, in violation of PENAL CODE SECTION 220(a)(1), a**  
23 **Felony**, was committed by DARIO ANTHONY CERAGIOLI, who did unlawfully assault K.E., with  
24 the intent to commit rape.

26 "NOTICE: Conviction of this offense will require to register pursuant to Penal Code section 290 et seq.  
27 Willful failure to register is a crime."

28 "NOTICE: The above offense is a violent felony within the meaning of Penal Code 667.5(c)."

6 On or about June 7, 2022, in the above named Judicial District, the crime of **CRIMINAL THREATS**,  
7 **in violation of PENAL CODE SECTION 422(a), a Felony**, was committed by DARIO ANTHONY  
8 CERAGIOLI, who did willfully and unlawfully threaten to commit a crime which would result in death  
9 and great bodily injury to K.E., with the specific intent that the statement be taken as a threat. It is  
10 further alleged that the threatened crime, on its face and under the circumstances in which it was made,  
11 was so unequivocal, unconditional, immediate and specific as to convey to K.E. a gravity of purpose and  
12 an immediate prospect of execution. It is further alleged that the said K.E. was reasonably in sustained  
13 fear of his/her safety and the safety of his/her immediate family.

15 "NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."
