This is to inform you that yesterday on October 30, I have filed the attached Civil Rights complaint with the U.S. Department of Justice.

I ask you to immediately drop all your cases against David Fennell for State Senate and issue an apology to the media.

You have violated Title 18, U.S.C., Section 245(b)(1)(A) as you have broken the following law and can be prosecuted: anyone who "willfully intimidates or interferes with..any person... qualifying or campaigning for a candidate for elected office" which is a Federally Protected activity.

David Fennell for State Senate requests that the FPPC immediately issue a new press release and withdraw any and all legal actions against David Fennell.

In the attached email from FPPC Communications Director Jay Wierenga (916) 322-7761 dated October 30, 2024 stating that "To the best of the knowledge of the FPPC, as of the afternoon of Wednesday, October 30th, no statements had yet been filed."

NOTE: The FPPC did not send us the email. I heard of the email when KRCR ABC 7 reporter Max Tedford mentioned the email during a phone interview and I asked that he send me the email.

After receiving the FPPC press release my team went through the emails and, as you can see in the attachment, our team was in regular correspondence with the CA FPPC after we were having problems with the CA-Access website and we did in fact file February 17, 2024.

If you look at the email trail, both FPPC Senior Commission Counsel Jenna Rinehart & FPPC Executive Researcher Cole Smith received the email and in a follow up phone call, Jenna Rinehart admitted she received the filings.

SO JENNA IS LYING IN COURT FILINGS!

NOW I AM HEARING THAT THE FPPC IS TELLING REPORTERS THAT THEY ARE GOING TO ASK A JUDGE TO REMOVE ME FROM THE BALLOT!

#### FPPC DOES NOT HAVE THE POWER TO REMOVE ME FROM THE BALLOT!

Everyone knows that the California Secretary of State website crashes and you have corrupt "treasurers" who essentially blackmail candidates by telling them they have to use their services as they have older computers that still work on this out dated technology and if you don't use their services they will report you for investigation in a bizarre effort at political extortion.

There is no history of me not filing paperwork. But there is a long history of 24 years of an outdated computer system crashing the way ticket-master computer crashed when all the Swifties were trying to buy Taylor Swift concert tickets for the Eras tour. Taylor Swift fans sued Ticketmaster and the DOJ got involved. Do I need to sue the California Secretary of State to update their computer system?

No current "establishment" politician wants the Secretary of State website updated because it acts as barrier to entry for new candidates who want to run for office.

Democrat Secretary of State Dr. Shirley Weber who is known as the "Godmother of Reparations" does not seem very interested in ensuring that Republican candidates are treated equally under the law and when I have pointed out obvious voting violations, her staff told me on the phone that "Republicans don't have civil rights as they are not a protected minority class" and to get her to enforce election law I would be required to get a Petition for a Writ of Mandate which is why I have a case in the 3rd Court of Appeals.

Also where did they get the idea of filing with Judge Stephen E. Benson in Butte County when they know that election matters are always heard in Sacramento. They also know the FPPC already has power over Judge Stephen E. Benson because, unlike me, who has followed the law and the only issue is CASOS crashing computers, when Judge Benson actually broke the law both the FPPC and the Judicial Counsel of California cited him for not disclosing a \$71,000 loan.

So the Judge who is ruling in my case himself actually broke FPPC rules and not just a paper work issue but real violations.

Why aren't they dragging the judge to court before his election?

This is all fraud and to prove me wrong, they should please provide the information asked for in this California Public Record Act request.

This is a request under the California Public Records Act (California Government Code § 6250 et seq.) and Article I, § 3 of the California Constitution

- Please provide the emails of all the media outlets to whom you sent press releases and statements regarding David Fennell for State Senate.
- Please indicate how many races the FPPC has jurisdiction over in this election and how many have FPPC issues.
- Please provide the top cover sheet of any other court hearings against a current candidate during the last two weeks before the November election to prove that I am not the only candidate being targeted.
- 4) Please prove the FPPC filed on Judge Stephen E. Benson regarding his FPPC violations.
- 5) Please provide any FPPC statement showing a payment from billionaire Charles Munger ir to any of FPPC Commissioner Catharine Baker's campaigns
- 6) Please provide any emails or letters from CAGOP General Counsel Ashlee Titus firm Bell, McAndrews & Hiltachk, LLP regarding David Fennell's past complaints with the FPPC office.

Here is what I don't want you to do in response to my California Public Request

In the past each time I do a California Public Request to try to get information of fraud at their agency, Galena West pulled this stunt, where, instead of giving me the one document I asked for, emailed me hundreds of irrelevant documents.

Just give me one page per item.

If the FPPC emails a mountain of garbage, I plan to push really hard for jail time.

These libelous statements and ridiculous court filings are an effort to weaponize the Democrat controlled FPPC against Republican candidates who are challenging the Democrat establishment who appoint all 5 members of the FPPC Board, none of whom are voting for Trump.

Butte County Superior Court Judge Stephen Benson today granted the FPPC's request for an injunction to force State Senate District 1 (one) Candidate David Fennell to file required campaign statements for the upcoming, November election. Judge Benson ordered Fennell to file all required campaign statements by 5pm Tuesday, November 5<sup>th</sup>, the day of the election.

The FPPC will seek additional court-imposed penalties if Fennell fails to do so.

To the best of the knowledge of the FPPC, as of the afternoon of Wednesday, October 30th, no statements had yet been filed.

The Butte County Elections has set up a NetFile account in their admin system for you. In order to use the Free Filer system you need to go through a one-time only process to create a login account for you and then link your login account to the filer that your agency has set up in their admin system. If you would rather have NetFile do this for you, NetFile offers free online training session for filers to show you how to use the free filer application mentioned above. To request an online training session with a NetFile representative, complete and submit the form located at Campaign Filer Training.

If you would rather create your free filer account yourself, here are the steps:

Note: The individual who will be entering the data into the NetFile Filer system must first create a user ID and then link it to the filer account by following these instructions:

Step 1: Create a NetFile User Log In

Go to the NetFile User Log-in page at https://netfile.com/filer

Click "Create a New NetFile User" in the "Campaign Committee Filers" section

Enter and submit the e-mail address you want to use for your new NetFile User

Receive a confirmation e-mail from NetFile

Click the link in the e-mail to confirm the request

The webpage you come to will need your name and phone number as well as a password you would like to use to log-in. Click the "Create NetFile User" button to complete your log-in profile. You are not done yet. You now need to link your log-in profile to the filer your agency created in their admin system.

Step 2: Link your User Log In to the Agency's admin filer account

Go back to the NetFile User Log-in page at https://netfile.com/filer

Log in using the e-mail and password created in Step 1

Click the "Link Local Campaign Filer Account" link

Enter the Campaign filer information as follows:

a) Enter the Filer Name

b) Enter the "Filer ID" area with: #{{FilerID}}

c) Enter the "Filer Password" area with: #{{FilerPassword}}

(Note: Do not attempt to log in with the Filer ID and Filer Password; they are for linking purposes only!)








#### Introduction

in September of 2016, the Governor signed into law Senate Bill (SB) 1349, the Political Reform Act of 1974. Secretary of State: online filing and disclosure system. The bill requires the Secretary of State, in consultation with the Fair Political Practices Commission (FPPC), to develop and certify for public use an orline filing and disclosure system for campaign statements and reports that provides public disclosure of campaign finance and liabbying information in a user-friendly, easily understandable format.

#### Background

The California Automated Lobbyist and Campaign Contribution and Expenditure Search System (CAL-ACCESS) was developed to provide greater public access to campaign contribution and expenditure data, and state lobbying financial activity, CAL-ACCESS was developed to respond to the objectives of the Online Disclosure Act, added to the Political Reform Act of 1974 (PRA) by Ch 866, Stats of 1997. CAL-ACCESS is the public's window into California's campaign disclosure and lobbying financial activity, providing financial information supplied by state candidates, donors, lobbyists, lobbyist employers, and others.

CAL-ACCESS was deployed in June 2000, and, since that time, nearly two (2) million filings have been submitted by filers. However, CAL-ACCESS is an old and fragie system that is at the end of life and operating on an unsupported information technology platform. The current system design has technological restrictions that prevent a from being modified or updated. It lacks data display and reporting features that are commonly used for data analytics.

CAL-ACCESS users and stakeholder groups have identified the following business problems

- Program business operations are negatively affected by the current system design.
- Program business operations are at risk due to an old, unsupported information technology platform.
- The Secretary of State's Political Reform Division (PRD) and stakeholders have limited information access and reporting capabilities

SB 1349 requires the Secretary of State to implement a CAL-ACEESS Replacement System (CARS) to address the shortcomings and vulnerabilities of the current system.

On December 29, 2017, pursuant to the Government Code section 84602 (b) (4), the Secretary of State submitted its report to the Assembly Committee on Elections and Redistricting and the Senate Committee on Elections and Constitutional Amendments.



In the triple-digit heat of summer, Thursdays in downtown Sacramento are usually quiet. But not on June 29 last year.

The March Fong Eu Secretary of State Building was jumpin' like a Black church on Sunday, the joyous shouts from teary-eyed Black people impossible to ignore. But Shirley Weber, California's secretary of state, tried to anyway during the final meeting of the state's reparations task force.

Weber, 75, has long been a force in Democratic politics, from the San Diego Board of Education to the state Assembly to her current role—a first for a Black woman. But lately, she has achieved near-rock-star status as something less official: The "godmother of reparations."

It was her Assembly Bill 3121 that led California to do what Congress has refused to do — appoint a task force to study the lasting harms of slavery and recommend what compensation is owed for decades of systemically racist laws and policies. State lawmakers are now grappling with many pieces of proposed legislation stemming from the task force's recommendations. It has been a hard, slow slog,

It's work that has breathed new life into the national reparations movement, turning what many Americans had long seen as a joke into a serious, often inescapable policy discussion.

This letter is in response to your request for public records under the California Public Records Act ("CPRA") (Gov. Code, § 6250 et seq.) that was received by the Fair Political Practices Commission (the "Commission") on June 2, 2016.

You requested documents relating to FPPC Case Number 11/471 San Mateo County Republican Party, which was previously received by the FPPC on May 27, 2016. Your request was to know how much cash was collected by the committee, documents showing payments to Nicholas Rice-Sanchez, and correspondence from Charles Bell, Jr. regarding the case. These same requests were previously sent by you and received by us on May 27, 2016.

The items that you have requested contain names of records that we do not have. We have previously provided you with a copy of the closed case file for 11/471 on June 20, 2014, in response to a previous request for that file. We also responded to this request on June 2, 2016, noting that the Public Records Act does not require us to create records for requesters.

We have made a reasonable search for the materials you requested and found no other documents responsive to this request.
