Runway 17/35 Navoids Improvements, Apron Rehabilitation/Reconstruction, Taxi lanes Rehabilitation/Reconstruction, Parking Lot Reconstruction, Fuel System Enhancements, Sponsor owned hangar rehabilitation, pavement maintenance, Snow Removal and Mowing Equipment acquisition, Airport Master Plan, Airport Layout Plan Update, Exhibit A update, Sponsor owned hangar construction, Wildlife/Security Fence/Gates and/or Security System, Runway 17/35 Rehabilitation/Reconstruction and/or Extension and Lighting/Signage Construction/Replacement, Runway 9/27 Parallel Taxiway and Lighting/Signage, Land Acquisition Construct Taxi lanes and Aprons; clear and maintain runway approaches as stated in Wis. Admin. Code Trans §55, and any necessary related work.
