In accordance with the provisions of Section 11-45-8 of the Code of Alabama, the following ordinance is published in synopsis form in The Auburn Villager as follows:

ORDINANCE NO. 3595

AN ORDINANCE ADOPTED PURSUANT TO THE PROVISIONS OF SECTION 11-42-20 ET SEQ OF THE CODE OF ALABAMA, 1975, AS AMENDED, PROVIDING FOR ASSENT BY THE CITY COUNCIL OF THE CITY OF AUBURN TO THE ALTERATION AND REARRANGEMENT OF THE BOUNDARIES OF THE CITY OF AUBURN AND ASSENTING TO THE ANNEXATION OF CERTAIN LANDS INTO THE CITY LIMITS OF THE CITY, IN RESPONSE TO PETITIONS FILED BY PERSONS OWNING ALL THE LAND AREA OF THE LANDS ANNEXED, AND APPROVING SUCH ANNEXATION.

LEGAL DESCRIPTION:

Parcel A; Commence at a concrete monument at the northwest corner of Section 17, T-19-N, R-26-E, Lee County, Alabama; thence run N89°35'25"E 1587.00' to an iron pin and the POINT OF BEGINNING of the property herein to be described; from said POINT OF BEGINNING, thence run N89°27' 11E 2584.6' to an iron pin; thence run S00°43'54"W 263.47' to an iron pin on the northwesterly margin of Lee Road 97, thence run S48°05'26"W 988.32' along said margin o a concrete right-of-way monument at PC 94+09.2; thence run a chord of S42°57'48"W 411.41' along the curve of said margin with a radius of 2331.80' to an iron pin; thence leaving said margin, run West 965.23 to an iron pin; thence run South 300.00' to an iron pin; thence run West 600.00' to an iron pin; thence run North 1500.00' to an iron pin and the original POINT OF BEGINNING.
