ON 9/12/18 IT WAS REPORTED THERE HAD BEEN SEVERAL NAKED PICTURES OF [REDACTED] PUT UP AT THE ELEMENTARY SCHOOL, HULL ELEMENTARY, WHERE KIDS ATTEND SCHOOL. THE PICTURES WERE OF STANDING NUDE IN AN IMAGE WHERE A PERSON WOULD CLEARLY KNOW HOW WAS IN THE PICTURE. THE PICTURE SHOWED [REDACTED]'S PENIS. THE PICTURES WERE TAPED TO THE FENCE OF THE SCHOOL WITH THE PICTURE FACING IN SO THE CHILDREN OR ANYONE ELSE INSIDE THE FENCE WOULD BE ABLE TO SEE THEM. [REDACTED] STATED THE ONLY PERSON HE SENT THIS PICTURE TO WAS HIS [REDACTED] DEBORAH BRITTON. ONE PARTY CONSENT CALLS [REDACTED] ATTEMPTED BUT DEBORAH WOULD NOT SPEAK WITH [REDACTED] MEN CONFRONTED AND HUNG UP ON HIM. DEBORAH WAS ARRESTED ON AN UNRELATED WARRANT ON 11/14/18. AT THIS TIME I CONTACTED HER AND SHE WAS SERVED WITH AN OOF AND SPOKE TO ME DURING A POST MIRANDA INTERVIEW. DEBORAH STATED THERE WAS NO REASON HER FINGER PRINTS SHOULD BE ON THE FLIERS OF [REDACTED] NAKED AND STATED SHE DID NOT POST THEM.

ON 12/11/18 I WAS ADVISED THE LAB RESULTS HAD COME BACK AND DEBORAH'S FINGERPRINT WAS FOUND ON ONE OF THE FLIERS. DEBORAH WAS CONTACTED VIA THE TELEPHONE AND STILL DENIED INVOLVEMENT AND ASKED HOW HER FINGERPRINT COULD HAVE GOT THERE. I ADVISED DEBORAH SHE NEEDED TO TURN HERSELF IN AND SHE STATED SHE WOULD CONTACT ME BACK WITHIN 24 HOURS. AFTER FAILING TO CONTACT ME BACK I LEFT HER A MESSAGE AND HER LAWYER CALLED ME BACK TO ARRANGE A TIME FOR HERTO TURN HERSELF IN.
