

## Notice of Intent to Adopt a Mitigated Negative Declaration Study Results Available Changes Proposed for State Route 58 in Kern County Opportunity for Public Hearing

**What's Being Planned:** The California Department of Transportation (Caltrans) proposes to upgrade existing pavement, guardrail, bridge rail, median barrier, drainage, and lighting on State Route 58 from postmile 77.20 to postmile R88.56. The project will also involve realigning the curves at postmiles 77.7, 78.5, R83.2, and 87.1 as well as potential construction of a wildlife undercrossing and/or culvert modifications within the limits of the future State Route 58 Truck Climbing Lane project (Post mile 76.3 – 79.5). Constructing this mitigation structure in advance would serve to address potential impacts to wildlife habitat connectivity and movement as a result of the construction and operation of the State Route 58 truck climbing lane by enhancing habitat connectivity and promoting safe movement of wildlife under the existing highway.

**Why This Ad:** CALTRANS has studied and documented the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. An "Initial Study/Mitigated Negative Declaration" report has been prepared. This notice is to inform you that the report is available for you to read and offer comments, and to notify you that an online public meeting will be offered upon request.
