Dear Mr. Pierce:

Enclosed please find those documents located and determined to be non-exempt responsive documents, produced on behalf of the Kern High School District, pursuant to your California Public Records Act request for "...digital copies of any and all emails, written correspondence and memos between district officials, and between school site officials pertaining to this incident" (as related to the Tyson Reed/taser matter). As previously advised, the KHSD continues to assert all of the applicable exemptions and objections related to your request, including but not limited to:

- 1. Requests information or documents that are confidential personnel records pertaining to any police officer. The procedures for obtaining information contained in peace officer personnel records are governed by Evidence Code §1043 (i.e. Pitchess motion). Penal Code §832.7 specifically provides that peace officer personnel files and information obtained from such records, are confidential and shall not be disclosed in any proceeding except by a discovery motion pursuant to Evidence Code §1043. The procedures outlined in Evidence Code §1043 are the exclusive means by which to seek to obtain confidential information from peace officer personnel files. See *City of Fresno v. Superior Court* (1988) 205 Cal.App.3d 1459, 1474.
- 2. The request seeks records containing confidential witness and confidential juvenile information under Welfare and Institutions Code sections 827 and 828. (See *Westcott v. County of Yuba* (1980) 104 Cal.App.3d 103.) A court order is necessary to release such records.
- 3. The request seeks disclosure of exempt or prohibited records pursuant to federal or state law (see Gov. Code, § 6254 subd. (k)), or infringes upon the attorney-client privilege. (*Roberts v. City of Palmdale* (1993) 5 Cal.4th 363, 370-371) and the work product doctrine. (See Code Civ. Proc., § 2018; Evid. Code §§952, 954; Bus. & Prof. Code §6068.)



- 4. The request seeks documents or information that constitute confidential student records and/or contains confidential student information. (Gov. Code, § 6254, subd. (k); FERPA, 20 U.S.C. § 1232g; Ed. Code, § 49076; *Rim of the World Unified School District v. Superior Court* (2002) 104 Cal.App.4th 1393, 1399.)
- 5. The request seeks preliminary drafts, notes or memoranda not retained in the usual course of business. (See Gov. Code, § 6254 subd. (a).)
- 6. The request seeks personnel files or other documents, the disclosure of which would constitute an unwarranted invasion of privacy. (See Gov. Code, § 6254 subd (c); City of Hemet v. Superior Court (1995) 37 Cal.App.4th 1411, 1421-22.)
- 7. The request seeks records that reveal deliberative process, legal research, theories or strategy, or requests information regarding closed session Board matters. (See Gov. Code, § 6254 subd. (p); *Kleitman v. Superior Court* (1999) 74 Cal.App.4th 324; Brown Act.)
- 8. The request seeks records subject to the confidential privilege under Government Code section 6255 subdivision (a).

You will note that some of the enclosed records have been redacted consistent with the objections and exemptions stated herein, and the otherwise non-exempt and non-privileged/protected records are enclosed herein.

At this time the District considers this CPRA request to be fulfilled, and we appreciate your patience as the District performed its search. Please feel free to contact me with any further questions or concerns.

As I walked into Spindt Hall 107 saw that Unit 3 Bridget L. AND Unit 5 Jose P. were already there with the student Tyson Reed. Moments later Officer Pena arrived he then approached the student Tyson Reed and asked him to walk with him to the deans office, student refused. He asked him again and the student refuse again. Officer Pena then asked him to stand up and put his hands behind his back. The student refusing saying "I'm not moving until I get marked here". Case in fin point ... The recent incident at BHS which resulted in a taser being deployed, began as a classroom issue where perhaps if the teacher recognized that the student should've been marked present, per Ed code, then others would not have been called to his room. Also a similar situation happened just days prior to this one, without a taser being deployed. Additionally ... the student mentioned to the teacher that he was having an ... perhaps if we were training teachers in TETRIS or other EBI's or protocol, then the teacher would have known that the student mentioning this would have raised a red flag & prompted him to consider some other measures, even if he didn't know what to do, training would have prompted him to contact a counselor or admin to ask about this revefin-lation. Some may want to question the taser protocol/use of the officer, but

had the protocol of notification been used (not blaming BHS, however when others start pointing fingers ... some point back to the pointer), perhaps we wouldn't be in this situation. Lastly ... who the f ok'd the purchase of tasers in the 1st place ... had the officer only had the tools that were issued to him through the proper channels, then we also would not be having this conversation ... the Officer was hesitant to use pepper spray (closed in classroom and he may have been rendered incapacitated), a baton would have been a bit much, and this was a non-lethal situation so I would bet he would not have pulled his firearm. March 10, 2015

To whom it may concern:

On Friday, March 6, Tyson Reed came to class at 2:26 with a note and told me he had been in the office because some guys had gotten in trouble and after questioning they had let him go because he wasn't part of it. He was told to take a seat. I quickly I realized his note had been marked 1:48 so I had him come back up to my desk. When asked about the :40 gap he said he had been experiencing "anxiety". I said I understood and that he must have seen someone about it and told him, " there's no problem just go ahead and go on back to the office and just chill down there". He told me, "no". I said it's no big deal, you're not in trouble, just go on down there". He told me "no" again. I said, "just be cool, you're not in trouble, just take it easy down there". He again refused. He then pointed out, "they're not doing nothing", When I briefly explained what they were doing Tyson pointed out, " they have their heads down".

I had told him that I didn't want to call the dean but he challenged me to do so while making the demand that I mark him here. I told him we could deal with it later but he persisted. As I stood he told me, "I'm not intimidated by you, don't play that game with me because I'm not intimidated by you". I turned and called the dean's office telling them I had a student that needed to be picked up because he wouldn't leave the room when told to do so. They asked who it was and security showed up a few minutes later.

The security guard arrived and I pointed Tyson out to her. He told her, "no" when told, "to come on, let's go". Tyson told her, "I'm not going to leave until he marks me here". Security told Tyson that it wasn't his place to make demands but he continued his defiance. By that time the bell had rang and the students left. The argument went back and forth and when security finally explained that she could call the officer, "if I have to" Tyson challenged, "go ahead, call the cops. I'll go to juvenile hall before I leave. I'm not leaving until he marks me here". The second security guard had anxiously approached from Tom Sakowski's room (there had evidently been a mix up with the room number when the call went out) but quickly realized there was no threat and immediately relaxed. Officer Pena was 30 feet behind and appeared to be relaxed, and said hello as he passed. I was stepping outside and ushering students out who had arrived to take make-up tests. Several seconds went by and I re-entered the room to figure out what to do about testing. At that point I realized that Tyson was still not conforming to commands and I needed to leave. As I was leaving and once out the door I could hear all involved trying to get Tyson to comply. I didn't hear any commotion or loud sounds until a minute or so had passed. I eventually heard several voices hollering and desks being pushed around. I opened the door and saw a group of people on the ground. Tyson was shouting, "what did I do, I didn't do anything"! I heard several responses including Officer Pena telling him," I gave you chance after chance". I heard others saying, " stop it! Just quit"! I was told to, "get out!" I did!

A couple of minutes had gone by and I was told to take my students upstairs, I dismissed them once we were there. They left out another exit opposite from the one I assumed they would take Tyson out of. I went downstairs and soon saw them leading Tyson off In cuffs. Tyson said, "all this just because I didn't want to leave class. Man, Bonetti".

Additionally, on Wednesday, March 4, Tyson was tardy to class and wasn't following directions to work quietly. I told him to come up and call his mom. He refused and would not even give me the number to call her. He argued with me for a minute as I was trying to coax him into helping me out. I told him to sit in his seat, so he sat in a place of his choosing to listen in on the conversation between his mother and I. The bell had rang and I told him to go ahead and leave. He stayed and eventually left when he wanted to.

IBridget Leong was disparched to spend tall 1084 defiant student upon my arrival I made contact with the teacher Benetti he informed me that Tyson read was not participating in the class activities I would like for me to escort him to the Dean's office. At that time I make contact with Tyson and I asked him to come with me he tell me know that he wasn't going anywhere until the teacher marked him here. I asked him again to come with me so we can talk about it and once again he stated no he wasn't going I asked him for a third time will come outside the classroom and talk to me about was going on and we could try to figure something out, he then just repeated himself by saying no I'm not going anywhere until he marked me here. At that time the bell rang for class to end and school to let out, all the kids exited the classroom except for him and one other female student that was staying to take a test. At that time I walked in the classroom and shut the door behind me and approach Tyson who was sitting in a chair and a table table ass Tyson what's the deal why he won't leave I he kept telling me was I'm not leaving till he Marks me here he kept telling the teacher Tamarkin here he wasn't leaving till you mark some here I've been advised Tyson that it's not the teachers job to do what he tells him to do that the teacher can mark them here at any time and just step out side with me and we can talk about the situation, I asked him at least four times at that time to just come outside not worry about being marked here and come with me, he kept refusing and he kept talking over me telling the teacher that he better mark him here or he needs to mark him here, at that time I told the teacher to just exit the classroom so I could try to talk to Tyson alone. Tyson tell me he didn't want to leave the classroom because he had a probation officer and if the teacher does not mark them here that the probation officer is going to take him to juvenile hall. I then stated what do you think your probation officer would say or feel about you not listening to me or if I have to get the dinar please officer over here to escort you out of the classroom because you're refusing to follow authority he then stated I don't care call the police call and Dean I'm not leaving till he marks me here, so at that time I ask the Dean and the police officer Pinyan District 12 to respond to my location to assist me on the student. A couple minutes later to other security showed up Joe and Roman to assist me at that time I asked Tyson again to come with me and he's just making things worse than they need to be and he just refused said he's not leaving he has nothing else to say because we already called the police. About a minute after that officer opinion shows up and walks in and stated to Tyson come on let's go and a friendly manner Tyson said no the teacher needs to mark him here. Pena then asked him again hey let's just go to the office and will talk about it there Tyson just kept refusing and said no I'm not going to go anywhere until the teacher marks me here. After about three times of Pinion asking him nicely to walk to the office then tells him okay then stand up and put your hands behind your back. Tyson said for what and yeah then stated because I've asked you nicely to walk with me to the office numerous times and you refusing so now I'm telling you to stand up and put your hands behind your back, at that time the girl that was in there taking a test I did ask her to leave I forgot that she was in there and she was at the back of the classroom. Tyson just kept telling paying him know I'm not going to leave until the teacher might after numerous times and asking them to stand up and put his hands behind his back Pena then reached for Tysons right arm and shoulder and lifted him up to a standing position, at that time Tyson started to pull away from Pena and started to resist pulling his arm away from him trying to jerk his arm out of Pena's grip and kept saying why are you doing this to me I just want to be mark here, leave me alone. Pena repeatedly told him stop resisting, quit pulling away just put your hands between your back, man... why are you doing this knock it off just put your hands behind your back, at that time the other two security offices Joe and Roman can see that Pena was struggling with him so they assisted Pena by trying to help get Tyson's arms behind his back by this time Tyson was bent over the table with his hands somewhat underneath his chest just refusing to cooperate, resisting and would not give up his hands and just kept yelling just mark me here just mark me here why you doing this. I also noticed that Tyson had his right leg between Pena's legs and and what looked to me like he was kicking pain yet in his crotch area, I was trying to grab Tysons legs and keep him from kicking anybody because at this point all three of them were really struggling with Tyson he was just continue to fight and kick and yell and resist. At the same time as all this is going on Pinyan is telling him dude just stop put your hands behind your back just stop stop resisting what are you doing this. Once Tyson started kicking Pena, he then told him quit resisting or I'm going to tase you Pena told him this at least five times that I can remember and Tyson just refuse continue to fight so at this time Pena tased him. After paying a tased him Tyson was still fighting and resisting and yelling by this time all three of them were on the ground struggling with him and he still would not stop paying again told him quit it stop I'm going to tase you again and he just would not listen kept fighting and yelling and then Pena tased him again for the second time. At that point paying it was able to place

hang cuffs on him and put him in restraints Pena then called for an ambulance to be dispatched on his radio and I got on my radio and asked for administrator and/or Dean to respond to where we are and have a unit lookout for the ambulance and escort them to the classroom.
