FOR CANDIDATES

The first day to circulate nomination papers is Monday, December 1, 2025, and the final day for filing nomination papers is 5:00 p.m. on Tuesday, January 6, 2026. Candidates for Justice of the Supreme Court and Circuit Court Judge file nomination papers and declaration of candidacy with the Wisconsin Elections Commission. County Supervisor candidates file with the Office of the St. Croix County Clerk.

SPRING PRIMARY

If a primary is necessary, the primary will be held on Tuesday, February 17, 2026.

Acceptable Photo ID will be required to vote at this election. If you do not have a photo ID, you may obtain a free ID for voting from the Division of Motor Vehicles.
