Proposals shall be based on American Institute of Architects Document A101-2017 "Standard Form Agreement Between the Town of Eau Galle and Contractor where the basis of payment is a "stipulated Sum" for the Town of Eau Galle Town Hall.

Bids must be accompanied by a Bid Security (Certified

Check or Bid Bond) in the Amount of ten percent (10%) of the maximum bid amount made payable to the Town of Eau Galle, as a guarantee that the bidder will enter into a contract and furnish bonds. Bid and Bid Security may not be withdrawn for a period of forty-five (45) days after the bid deadline. Bid Security will be retained if the bidder is awarded the Work and fails to execute the Agreement and furnish 100% Performance and Payment Bonds.
