Our firm represents Walgreen Co. d/b/a Walgreens ("Walgreens"), in the above referenced matters issued by the Board of Pharmacy, State of Vermont. We write to seek a stay of the deadline to respond to the Specifications of Charges filed by the Vermont Office of Professional Regulation ("OPR"). The current deadline for Walgreens to respond to the charges is August 20, 2022.

On August 18, 2022, Walgreens filed a Motion to Dismiss the Specifications of Charges. We request that the Board stay the deadline for Walgreens to respond to the Specification of Charges, until thirty (30) days after the Board issues a decision on the Motion to Dismiss. A stay of the deadline would preserve resources and not delay adjudication of this matter as Walgreens' motion may resolve almost all of the Charges.
