GREETINGS:

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Alford, qualified to vote in Town affairs, to meet at the Alford Fire House in said Town on Tuesday May 9, 2023, at 6 P.M., then and there to act on the following Articles:

ARTICLE 1. To see if the Town will vote to authorize the Board of Selectmen and the Board of Health to appoint any member of the Board of Selectmen and any member of the Board of Health, respectively, to another office or position for the term provided by law, if any, otherwise for a term not to exceed one year, in accordance with Section 4A of Chapter 41 of the General Laws; or to take any other action relative thereto.

ARTICLE 2. To see if the Town will vote to accept any and all funds being provided by the Commonwealth of Massachusetts Department of Transportation (Mass DOT), under the provisions of Chapter 90 of the General Laws, to pay for such costs as allowed by appropriate legislation in connection with the maintenance, repair, and construction of Town ways and bridges, or to take any other action relative thereto.

ARTICLE 3. To see if the Town will vote to fix the maximum amount that may be spent during fiscal year 2024, beginning on July 1, 2023, for the revolving funds established in the Town's bylaws for certain departments, boards, committees, agencies and officers in accordance with M.G.L. Chapter 44, Section 53E1/2, as follows, or to take any other action relative thereto.

To see if the Town will vote to raise and appropriate or transfer from available funds \$150,000.00, or any other sum of money, to pay costs of repairs and improvements to Alford Highways, and for payment of all other costs incidental and related thereto; or to take any other action relative thereto.

ARTICLE 5. To see if the Town will vote to raise and appropriate or transfer from available funds \$ 96,057.00 to the pay the cost of debt service on the 7 Alford Road Property or to take any other action relative thereto.

ARTICLE 6. To see if the Town will vote to transfer \$25,000.00 from Retained Earnings of the Alford Link Enterprise Fund to the Alford Link Enterprise Stabilization Fund in accordance with the provisions of Section 5B of Chapter 40 of the General Laws; or to take any other action relative thereto.

ARTICLE 7. To see if the Town will vote to transfer \$13,115.00 from Retained Earnings of the Alford Link Enterprise Fund to pay the cost of debt service on the Alford Link Broadband borrowing; or to take any other action relative thereto.

ARTICLE 8. To see if the Town will vote to appropriate from receipts of Alford Link the following sums to operate the Alford Link Enterprise fund; or to take any other action relative thereto.

ARTICLE 10. To see if the Town will vote to transfer from Free Cash \$20,000.00 to pay for survey and design services for ADA accessibility at the Town Buildings; or take any other action relative thereto.

ARTICLE 11. To see if the Town will vote:

(i) to accept as a public way a certain portion of the roadway known as West Road, which portion is shown generally on a plan entitled "Plan of Proposed Town Highway Layout of a Portion of West Road in Alford, Massachusetts," prepared by CHA Consulting, Inc., and dated April 14, 2022, and shown more specifically as the "2022 Town Layout" on a plan entitled "Massachusetts Department of Transportation Highway Division Plan and Profile of West Road over Scribner Brook, Bridge No. A-06-004, in the Town of Alford, Berkshire County, Preliminary Right of Way Plans," also prepared by CHA Consulting, Inc., comprised of eight (8)

total Sheets, originally dated July 14, 2021, and revised through December 23, 2022, which plans are on file with the Town Clerk; and

(ii) to authorize the Select Board to acquire by gift, purchase and/or eminent domain (a) the fee to and/or easements in said portion of West Road and any appurtenant construction, utility, drainage and/or other temporary and/or permanent easements related thereto, including but not limited to interest(s) in portions(s) of adjoining properties known as and numbered 295, 300, 301, 307 and 311 West Road, to be used for all purposes for which public ways are used in the Town of Alford or for other associated municipal purposes, and (b) the fee to and/or easements, temporary and/or permanent, in the aforementioned West Road and adjoining properties as may be necessary in connection with the West Road over Scribner Brook bridge replacement project, expressly including the easements identified as "TE-1," "TE-2" and "PUE-2" on the latter of the plans referenced above, to be used for the purposes of bridge construction and maintenance, clearing, relocation of utilities and associated purposes; all of said acquisitions having been determined to be necessary for the health, safety and/or welfare of the inhabitants of Alford;

or to take any other action relative thereto.

ARTICLE 12.To see if the Town will vote to transfer from Free Cash a sum of money to pay for appraisal services and for the acquisition(s) referenced in said Article 11 for West Road and/or the West Road over Scribner Brook bridge replacement project; or to take any other action relative thereto.
