## <u>DEFENDANTS-INTERVENORS' BERKSHIRE AVIATION STATUS REPORT AND</u> REQUEST FOR EXTENSION OF STAY

Berkshire Aviation Holdings, Inc. and Berkshire Aviation Enterprises, LLC (collectively, "Berkshire Aviation") respectfully submit this status report in accord with the February 22, 2023 order of the Court<sup>1</sup> and request an extension of the stay for the reasons set forth below.

On April 9, 2023, the Great Barrington Select Board voted to issue a special permit to

Berkshire Aviation for the continued operation of the Great Barrington Airport. Berkshire

Aviation understands that the written special permit decision is currently being reviewed by the

current stay ought not be extended beyond April 30, 2023. (Piper, C.J.).

what further progress has been made, if any, on Berkshire's special permit application, and providing information on any appeal from any decision issued by the Board on that application. If, by April 30, 2023, there have been insufficient meaningful steps accomplished in the special permit process, the stay will end, subject to the opportunity of the court, on its own motion or that of any party, to revisit the matter of a stay, and to consider whether or not to extend the stay, with or without modification, in whole or in part. Any motions which the parties may file concerning the extension of the stay beyond April 30, 2023 should indicate in reasonable detail what discovery is sought to be completed (and an anticipated timeline for completion of that discovery) should the court determine that

Counsel are to file a further joint written report with the court by April 30, 2023, indicating

Town's legal counsel and is expected to be filed with the Great Barrington Town Clerk by next week, that is, on or before Friday, May 5, 2023.

Berkshire Aviation therefore requests that the stay be extended until 21 days after the special permit decision is filed with the Town Clerk, which will be one day beyond the 20-day time limit for the plaintiffs in this action (or anyone who may have standing) to file a zoning appeal under G.L. c. 40A, § 17. For example, if the special permit decision is filed with the Great Barrington Town Clerk on Friday, May 5, 2023, the stay would be extended to Friday, May 26, 2023, which is the 21<sup>st</sup> day after May 5.

If the Court determines the stay should not be extended, Berkshire Aviation does not seek to do any discovery in this case.
