Discussion

The Owner's Project Manager ("OPM") and Designer conducted a feasibility analysis of the facility and developed a Schematic Design, including a proposed scope of work, schedule, and estimated budget. The District's Designer, Gale Associates, Inc., recommends replacement of the roof, windows, and doors at the Charles McCann Vocational Technical School. The Designer has confirmed that the proposed roof, window, and door replacement(s) will comply with the MSBA's sustainability requirements.

MSBA staff reviewed the existing conditions analysis provided by the District's consultants as well as the proposed schedule. MSBA staff also discussed the proposed scope and budget with the District and its consultants. The District has provided a Total Project Budget of \$16,779,269, which includes a construction cost of \$14,439,779. Construction costs include the following components:

- \$8,121,253 for installation of 80-millimeter PVC membrane roofing.
- \$5,129,711 for the installation of aluminum windows and exterior doors and all associated work.
 - \$23,195 for replacing AC window units is ineligible, \$217,195 for replacing roller shades is ineligible, and \$795,272 for replacing windows less than 30 years old is ineligible.
- \$337,943 for accessibility upgrades.
- \$850,872 for associated roof, window, and door scope, including demolition, hazardous material abatement, masonry repairs, and painting and patching.

MSBA staff recommends the Estimated Total Facilities Grant and the Maximum Total Facilities Grant, as set forth in the table below, subject to MSBA approval and audit:
