A Petition Against Enacting a Residential Real Estate Tax Exemption in the Town of Stockbridge, MA

To the Members of the Select Board of the Town of Stockbridge:

For one or more of the following reasons outlined below, we, the undersigned residents and/or business owners in the Town of Stockbridge, Massachusetts, hereby voice our opposition to the Select Board's proposed implementation of a residential real estate tax exemption ("RTE"). This measure, that would apply to every full-time resident, rich or poor, would result in an increase in the amount of real estate taxes paid by all of the town's part-time residents, to make up for the resulting loss of revenue. We feel this measure is too broad, is poorly considered, and doesn't accomplish the goals it sets out to achieve in a manner that serves the best interests of the town as a whole:

- The RTE is inefficient. It seeks to address an as yet unquantified (and likely modest) need, with blunt overkill rather than precision. It will likely raise more than a million dollars in taxes, almost all from part-time residents, in order to transfer a much smaller amount to the targeted full-time homeowners who are believed to have modest means. The excess raised would be allocated to all full-time owners, with no regard for need. And it has fallout: raising the general tax rate will likely lower the values of all residential properties in the town, regardless of who owns them.
- The RTE is divisive. A requirement that all part-time residents pay more in real estate taxes than full-time residents, regardless of the need or income of either group, will divide us and pit full-time residents against part-time residents, which is contrary to the united spirit of mutual cooperation, benefit, and respect that currently exists between these two groups.
- The RTE would place an unfair tax burden on existing owners. A person who has chosen to purchase a part-time residence in Stockbridge did so with the knowledge that he/she would be paying taxes despite not having the right to vote on Town issues and despite not utilizing certain services to the same extent as full-time residents. But it is unfair to ask this group to assume a new and greater tax burden than similarly situated full-time residents without regard for any individual's financial means. As an illustration of this inequity, an analysis of the proposed RTE prepared by Stockbridge Town Assessor Michael Blay shows that every part-time resident, regardless of the assessed value of his/her home, would be required to pay \$2213 more in taxes than a full-time resident owning similarly assessed property.
- The RTE is not targeted to address income inequality. The Select Board's goal, to assist
 economically disadvantaged families by reducing their tax burden, is laudable. However,
 Stockbridge is designated as an "upper income census tract" as defined by Community
 Reinvestment Act regulations, which means that the overwhelming majority of full-time
 Stockbridge residents are likely not struggling to pay their current real estate taxes. Our

- government leaders can and should implement a program to ensure that any tax relief targets only those individuals who really need it.
- The RTE is outside the mainstream. In the 43 years since the Massachusetts Legislature authorized towns to enact an RTE, only 16 Massachusetts communities have chosen to adopt it, none of which is located in the western half of the Commonwealth. Stockbridge itself has never had a two class property tax classification, as long as records reveal. Adoption of one would be a major change in local culture, benefits, and burdens, and deserves wide ranging discussion and ultimate buy-in by those to be affected.

Better (and more targeted) alternatives for tax relief exist and should be explored.

For example, the Commonwealth already offers elderly tax relief through the Massachusetts Senior Circuit Breaker Tax Credit and the Senior Tax Deferral program—which no Stockbridge residents have availed themselves of currently. The Town could consider hiring or dedicating a Social Worker or similar professional to identify those in specific need, all sources (state, local, and federal) of possible aid (including housing, food and medical assistance), and directly or via a managed group of volunteers, reach out to educate and assist the targeted population in applying for and accessing such benefits. The cost of such an effort could be borne by the town budget and any necessary funds raised via the general tax assessment, same rate to all, so the cost is borne by us all as one united town of residents. Alternatively, the state legislature could be lobbied to revise the RTE legislation to target allowed exemptions solely to property owners who have a defined need for assistance, with the costs borne by all other property owners.

We, the undersigned vote NO on the residential tax exemption:
