PROCEDURAL ORDER DIRECTING THE FILING OF DISCOVERY RESPONSES

On April 26, 2024, the Town of Lyndon Electric Department ("Lyndon Electric") filed revised rate schedules and tariff documents with the Vermont Public Utility Commission ("Commission") reflecting a proposed 7.4777% increase in its rates. The tariff changes were proposed to take effect on a service-rendered basis commencing June 10, 2024.

On June 10, 2024, the Commission opened an investigation into the proposed rate increase.

On November 1, 2024, the Vermont Department of Public Service ("Department") submitted prefiled testimony recommending that Lyndon Electric's rate increase be limited to 7.25%, or \$762,187, after adjusting for Lyndon Electric's energy market costs.

On November 21, 2024, Lyndon Electric filed a letter agreeing to the reduced overall rate increase of 7.25%, or \$762,187, and stating that Lyndon Electric does not believe any additional procedural steps are needed in this proceeding.

On November 26, 2024, the Department filed comments agreeing with Lyndon Electric that it does not believe any additional procedural steps are needed in this proceeding.

At this time, I do not see a need for the remaining scheduled procedural steps established in my Scheduling Conference Order, namely, the Evidentiary Hearing and the filing of briefs.

For my review, I direct Lyndon Electric to file its responses to the Department's discovery requests no later than Wednesday, December 4, 2024.
