TOWN OF LYNDON  
ANNUAL TOWN AND HIGHWAY DISTRICT MEETING**

**Notice to Voters:**

Residents of the Town of Lyndon, who are not already on the voter checklist, may register to vote up to and include the date of the vote, March 4, 2025.

For Australian Ballot articles, Lyndon registered voters may request an early voter ballot at the Lyndon Town Clerk's Office during the office's regularly scheduled hours.

**Australian Ballot:** election of Town Officers and Special Appropriation requests (articles 10-20). Polls will open Tuesday, March 4, 2025, at the Lyndon Municipal Office Building Conference Room, Lyndon, Vermont, between the hours of 10:00 AM and 7:00 PM.

**Warning Notice:**

The legal voters of the Town of Lyndon are hereby warned and notified to meet in person at the Municipal Office Building gymnasium at 119 Park Avenue, Lyndonville on Tuesday, March 4, 2025, at 9 AM for the following purposes.

Article 1: Shall the voters authorize general fund expenditures for operating expenses of \$4,371,669.00, of which \$2,315,786.00 shall be raised by taxes and \$2,055,883.00 by non-tax revenues? (Note: Total General Fund Budget is subject to increase based upon voter approval of the Special Appropriation Articles 8-17.)

Article 2: Shall the voters authorize highway fund expenditures of \$2,974,718.00, of which \$1,931,829.00 shall be raised by taxes and \$1,042,889.00 by non-tax revenues?

Article 3: Shall the voters authorize payment of General Fund and Highway Fund real property taxes to the Treasurer on or before November 7, 2025 by physical delivery to the Treasurer before 4:30 PM Friday, November 7, 2025 with delinquent taxes having an eight percent late penalty charged against them from the due date of November 7, 2025 at 4:31 PM, and interest charges of one percent per month for the first three months, whereafter interest rates will be one and one-half percent per month?

Article 4: Shall the voter of the Town of Lyndon adopt all budget articles by Australian ballot pursuant to 17 V.S.A. §2680(c)? If passed, voting budget articles by Australian ballot would begin in 2026.

Article 5: Shall the voters of the Town of Lyndon vote on all public questions by Australian ballot pursuant to 17 V.S.A. §2680(d)? If passed, voting public questions by Australian ballot would begin in 2026.

Article 6: Shall the voters of the Town of Lyndon authorize the elimination of the office of First Constable and Second Constable pursuant to 17 V.S.A. §2651(d)(1)?

Article 7: Do the voters of the Town of Lyndon desire to transact any other proper business?

**Australian Ballot Articles as follows:**

To elect the following Town officers as required by law: Town Moderator, Selectperson for one (1) year, Lister for three (3) years, Cobleigh Public Library Trustee for five (5) years, and a Sanborn School Fund Trustee for three (3) years.

Article 8: Shall the Town of Lyndon vote to raise, appropriate, and expend the sum of \$10,000 for the support of Caledonia Home Health Care & Hospice to provide services to residents of the Town?

Article 9: Shall the Town of Lyndon vote to raise, appropriate and expend the sum of \$1,200 for the support of Catamount Film and Arts to provide services to residents of the Town?

Article 10: Shall the Town appropriate \$5,000 to The Darling Inn Senior Meal Site for the purpose of providing meals that are delivered to area residents who are homebound in accordance with 24 V.S.A. §2691?

Article 11: Shall the Town of Lyndon vote to raise, appropriate and expend the sum of \$7,476 for the support of Fairbanks Museum and Planetarium to provide service to residents of the Town?

Article 12: Shall the Town appropriate \$6,000 to the Lyndon Outing Club to continue to provide affordable skiing, recreational opportunities, and a venue for meetings and gatherings to the public in accordance with 24 V.S.A. §2691?

Article 12: Shall the Town appropriate \$6,000 to the Lyndon Outing Club to continue to provide affordable skiing, recreational opportunities, and a venue for meetings and gatherings to the public in accordance with 24 V.S.A. §2691?

Article 13: Shall the Town of Lyndon vote to raise, appropriate, and expend the sum of \$6,000 to support The Northeast Kingdom Council on Aging to provide services to residents of the Town?

Article 14: Shall the Town of Lyndon vote to raise, appropriate and expend the sum of \$11,962 for the support of Northeast Kingdom Human Services, Inc., a not for profit 501(c)(3), to provide needed services to residents who cannot otherwise afford care?

Article 15: Shall the Town appropriate \$2,750 to Northeast Kingdom Youth Services for the continued vital supportive services for youth and families that they have offered since 1975?


Article 16: Shall the Town of Lyndon vote to appropriate the sum of \$8,000 for the support of Powers Park to provide services to the residents of the Town in accordance with 24 V.S.A. §2691?

Article 17: Shall the Town of Lyndon vote to raise, appropriate, and expend the sum of \$10,000 for the support of Umbrella to provide services to residents of the Town?
