When Erica Guenther and Jenn Whyman opened Child's Play in July 2020, they couldn't imagine that it would be so much more than a business.

"Our heart was to provide a safe and welcoming space for local and visiting families to come together to craft," Guenther said. "Throughout this journey we've found how encouraging it is for families to come in with their kids and engage in the creativeness that comes with making art."

Child's Play is a studio and retail space that offers classes, take-home craft kits, and art supplies.

"We started this all during COVID because kids were so hungry for affirmation," Guenther said. "It's also become a ministry of outreach for us."

For the second year in a row, Child's Play will host their annual CREATE Art Show May 13-15. All the pieces in the show are created by artists ages 3-18.

"Last year we had 54 kids and it looks like we'll have about the same this year," Guenther said.

Back in the 80s, very few women were surfing the Oregon Coast.

"Back then there were only four of us constantly going out in the ocean," Lexie Hallahan said.

"Once in a while you might see a woman from California come by, but mostly it was just us four chicks. At the time, three of us were body boarding and one was surfing. I wanted women to get involved because they don't know what they're missing out on."

First, Hallahan pitched the idea of a women's wetsuit to Hotline and they picked it up.

"Wetsuits didn't fit women really well," Hallahan said. "You were constantly wearing gear that was too big, and getting cold and that was a deterrent [to the sport]."

The second hurdle was boards. "The boards were also not scaled down to fit a womens' dimensions," Hallahan said. But soon, local board makers were crafting smaller surf boards.

The last step was instruction.

"Woman were looking for some guidance and instruction," Hallahan said. "We put together a two day surfing weekend, it was almost all women, girls, and moms. We put on this really wonderful, women, empowering surfing weekend."

That was 18 summers ago and Northwest Women's Surf Camps was born. Northwest Women's Surf Camps provides unique surfing lessons, bodyboarding clinics, Surf Camps and more in Seaside and Oswald West State Park. This chapter introduces the TSP and provides an overview of the purpose, planning process, and current policies affecting the development of the TSP. It summarizes the transportation needs of the City based on existing and future conditions and takes into consideration demographics and key community destinations. It provides an overview of community involvement strategies employed to encourage participation from all stakeholders and populations represented in the City of Cannon Beach.

Purpose

The TSP serves as a blueprint and vision for transportation system development in Cannon Beach for the next 20 years. The 2022 Transportation System Plan is Cannon Beach's first TSP. This plan:

• Assesses the existing and future conditions of Cannon Beach's transportation system and

determines transportation needs for all modes of travel, including

driving, walking, biking, using transit, and using a mobility device.

• Discusses the freight, rail, marine, and aviation needs of the system.

• Assesses emergency response facilities, including tsunami evacuation routes, assembly areas,

and wayfinding and signage, and provides recommendations for improving the emergency

response and evacuation system.
Includes both near and long-term projects that directly address transportation issues in the City

of Cannon Beach and provides an evaluation system for prioritizing these projects.

Cannon Beach Reads turns the pages May 18

The May selection for Cannon Beach Reads is Animal Farm, by George Or-well, which will be discussed via Zoom on Wednesday, May 18, beginning at 7 p.m.

Animal Farm is an allegory about a group of farm animals who rebel against their human owners and then seek to establish a so-ciety where all animals can be equal and free. In-stead, their efforts result in a dictatorship.

Orwell published Animal House in 1945, as a satirical critique of Joseph Stalin, who at the time was popular in the UK for fighting Nazi Germany. Orwell, a staunch anti-communist, noted that

in writing the book, he had tried "to fuse political purpose and artis-tic purpose into one whole."

George Orwell was the pen name of Eric Arthur Blair, a novelist, journalist and critic. Orwell's fiction, nonfiction, and essays reflect his opposition to totali-tarianism and authoritarian governments. He is per-haps best known for Nineteen Eighty-Four, a dystopi-an novel that has given us terms like 'Orwellian,' 'Big Brother,' and 'doublethink.

Orwell documented his experience with working class life in industrial England in The Road to Wigan Pier, and

his experience as a soldier in the Spanish Civil War in Homage to Catalonia. He was also a well respected literary critic. Orwell has been described as having "uncompromising intellectual honesty" and as being the "saint of common decency."

Cannon Beach is immersed in and surrounded by parks and natural areas. Many people are drawn to the City for the beach and views of Haystack Rock. Tolovana State Park provides a large car parking area for visitors to access the beach with amenities like restrooms and a playground. Local City Parks such as Whale Park and Les Shirley Park, are also access points to the Ecola Creek estuary and beach. Though Ecola State Park is outside of the City, the primary access is through Cannon Beach. Parks, natural areas, and other community destinations.

Cannon Beach's land use is primarily a mix of residential, commercial, and park or natural spaces. Other land is used for institutions or public works, like the wastewater treatment plant and City offices. Land use in Cannon

Beach is expected to remain consistent based on land use designations in the Comprehensive Plan.

Most of the City is zoned for residential development, primarily designated low or medium density. Notable high density residential locations include Breakers Point condominiums on the north edge of Ecola Creek and the multifamily housing on Elk Creek Road east of US 101. The City also has zoned areas for residential motels and manufactured homes, which includes two RV parks. Cannon Beach has three commercial nodes, one toward the north end, one in the middle of the city, and one toward the south end. Each commercial center has restaurants, retail, and places to stay.

Cannon Beach has a variety of civic resources, including the Cannon Beach Library, Chamber of Commerce, City Hall, and the Cannon Beach History Center. Cannon Beach Academy is the only public school in the City and is located just off S Hemlock Street, potentially attracting walking trips to school. Cannon Beach is

also home to Ecola Bible College, a one-year Christian school, and Christian Culinary Academy, both at the north end of the City.

Tourism is the largest contributor toward the City's economy. Estimates from American Community Survey data show approximately 780 people were employed in Cannon Beach in 201

The largest industry by far was Accommodation & Food Services, followed by Real Estate & Rental & Leasing and Retail Trade. Nearly 85% of Cannon Beach employees are estimated to work in one of these sectors.

While the impacts of tourism are seen year-round, transportation demands are highest from June through September. Freight activity in Cannon Beach plays a vital role in supporting the local economy and services for tourists such as transport of food and retail items.

Cannon Beach Planning **Commission needs** more variety in backgrounds

The appointment of Aaron Matusick to the Cannon **Beach Planning Commission** violates the law and strains the credulity of the good citizens of our community.

State and local law prohibits appointment of more than two members to the Planning Commission from "the same kind of occupation, business, trade, or profession," or more than two people "engaged principally in the buying, selling or developing of

real estate for profit." These restrictions are proscriptive, not advisory. There are no exceptions, nor any suggestion that appointment authorities can choose to ignore them at their convenience. It is an indication of the community's overriding interest in ensuring that people appointed to this important role represent the community at large, not a particular profession, business, or special interest.

As an attorney licensed to practice law in Oregon and Washington, Mr. Matusick joins two other members already on the Commission licensed to practice law, and his personal and professional interests in developing real estate for profit stacks the Commission with four of its seven members from just two professions, law and real estate.

The Planning Commission should be as diverse as the people whom live in Cannon Beach. We're a growing community with big issues that need tackling. The participation of a variety of backgrounds is required to grow our village while keeping the whole community in mind. I urge the City Council to withdraw its appointment of Mr. Matusick at the earliest possible convenience.



Coast Guard fines boater after crossing restricted bar

The U.S. Coast Guard fined a recreational boater last Thursday for crossing the restricted Tillamook Bay bar in March in Garibaldi.

On March 31, 2022, at approximately 11:30 a.m., a 23-foot recreation vessel approached the Tillamook Bar with three people onboard.

Coast Guard Station Tillamook Bay's bar watch tower radioed the vessel as it approached the closed bar. The bar was closed due to posing a hazard to vessels under 35feet. The vessel reportedly admitted to knowing of the bar restriction and continued to approach.

During the transit, the vessel experienced an engine causality and broke down between the jetties.

After the vessel became disabled, Station Tillamook Bay launched a rescue crew aboard a 47-foot motor lifeboat and towed the vessel to safety. The tow took approximately an hour and a half.

"Bar restrictions save lives," said Lt. Cmdr. Colin Fogarty, the Enforcement Chief at Coast Guard Sector Columbia River. "Bar assessments are conducted by highly trained surfmen who utilize years of experience and training to determine whether vessels can safely navigate the dangerous waters. When a boater violates a bar restriction, they not only place their own lives at risk, but the lives of their passengers and ultimately Coast Guard members, should we need to save them. If a boater violates the restriction, the Coast Guard will seek to hold the boater responsible through fines or criminal referral. A fine of

\$3,500 is a lot of money to pay for salmon but, it could have cost that boater and his three passengers their lives."

The Coast Guard has issued a \$3,500 Notice of Violation for violating a restricted bar (Title 33 CFR §165.13(b)) and negligent operations (Title 46 USC §2302(a)).

The Coast Guard is dedicated to ensuring the safety of the public. These incidents and the subsequent fines are preventable and serve to protect the maritime public.

Influenza detected in Oregon

Staff Report

The U.S. Department of Agriculture's Animal and Plant Health Inspection Service (APHIS) confirmed today the presence of highly pathogenic avian influenza (HPAI) in a non-commercial, backyard flock (non-poultry) in Linn County – the first confirmed case in Oregon since 2015.

HPAI (H5N1) is a highly contagious virus that transmits easily among wild and domestic bird species. However, according to the U.S. Centers for Disease Control and Prevention, the recent HPAI detection does not present an immediate public health concern.

We knew HPAI was coming our way after a bald eagle in British Columbia tested positive in early March," Oregon Department of Agriculture (ODA) State Veterinarian Dr. Ryan Scholz said. 'Since that detection, we have been hard at work communicating with our commercial poultry producers, veterinarians, and the public on how they can protect their flocks. Now more than ever, all bird owners must practice good biosecurity, prevent contact between their birds and wild birds and report sick birds or unusual deaths so ODA can ensure testing."

A quick response is needed to prevent the spread of HPAI, according to Scholz. Background

The owner of the affected backyard flock reported the deaths and delivered at least one of the birds to Oregon State University's (OSU) Vet-



erinary Diagnostic Laboratory for initial sample testing. Samples were also sent to APHIS's National Veterinary Services Laboratory (NVSL).

ODA quickly quarantined the affected premises. ODA will humanely euthanize any additional birds on the property to prevent the spread of the disease. Birds from this farm were not used for food and will not enter the food system. There are no detections in commercial poultry in the state.

ODA and federal partners are working jointly on additional surveillance and testing in the nearby area, following existing avian influenza response plans.

If you find a sick or dying bird, ODA asks that you do not touch it; report it. For domestic birds, please report by calling ODA at 1-800-347-7028 or email npip@oda. oregon.gov. For wild birds,

please call and report to the Oregon Department of Fish and Wildlife by calling 1-866-968-2600. Resources For more information

about HPAI, visit ODAs Avian Influenza web page for more information about HPAI to learn more about avian influenza, its signs, symptoms, and ways to protect

your birds.

APHIS also has materials about biosecurity, including videos, checklists, and a toolkit available at Defend the Flock Resource Center.



Cannon Beach community welcomes Pilot House Distilling

Whiskey aged on a fishing boat. That's quite the talking point. And it's what draws many people to Pilot House Distilling.

"We age it two years before it goes out to sea," Co-owner Christina Cary said. "We just released batch number seven of 'Come Hell or High Water.' This batch was out to sea on the Maverick which was on the Deadliest Catch."

Three barrels spent over a year out at sea in Oregon, Washington, and Alaska waters. The batch has a richer, saltier, and more oak characteristics than previous batches and Cary expects the limited-offering to sell out quickly.

"The constant movement of the ocean speeds up the

aging process," Cary said. "People do tell their friends [the story] and bring their friends back next time."

Pilot House Distilling is a small craft distillery located in historic downtown Astoria owned by Christina and her husband Larry. Established in 2013, the distillery started out producing basic vodkas and gins, and has now grown to two addition tasting rooms and produce a variety of spirits including canned cocktails, whiskey, absinthe, and coffee liqueur.

A Pilot House Distilling tasting room opened this past month in Cannon Beach.

"We wanted to be in Cannon Beach for a long time," Cary said. "We do a lot of markets and get a lot of people and tourists from Cannon Beach...it's a beautiful place. Making our presence known in the community has always made sense to us."

The tasting room is located in the Landing at 224 N. Hemlock.

"It's been so fantastic, I absolutely love that space, the location, the people," said Cary. "The people are so welcoming and friendly."

Customers can visit the tasting room seven days a week, noon-6 p.m. to sample the spirits as well as purchase product to take home.


"It's a very educational experience," Cary said. "That's what we thrive on. We want customers to ask questions and we want to educate people on what they're trying and why we do a recipe that way."
