Given our experience with Covid-19, what precautions would you put in place to allow for safe, secure elections whereby voters are not choosing between their health and their right to vote, especially in November? Include how you would fund any necessary precautions and changes.

Here in Ohio, our election professionals have worked hard to ensure you can safely cast your ballot this November, whether you choose to do so by mail or in person.

Voters who don't want to risk their health amid the ongoing pandemic by voting in person still have the right to participate in our nation's democratic process and must have the option to do so. To ensure the Postal Service has the resources they need to deliver those ballots, I recently voted with my colleagues across the aisle to provide the Postal Service with \$25 billion in additional funding. Ohioans who plan to cast their ballot by mail should have full confidence that their vote will be counted

Similarly, voters who wish to cast their ballot in person must be able to do so safely. Our board of elections are working to establish the necessary precautions to ensure the safety of those who vote in-person as well as those working the polls.

Last month, I was proud to work with a Lake County manufacturer, RB Sigma, and the Secretary of State's office to create a partnership that will provide nearly half a million surgical masks for poll workers and voters in all 88 counties on election day. RB Sigma was able to retool their machinery to produce PPE thanks to a \$500,000 grant funded by the CARES Act. I'm proud to support manufacturers like RB Sigma that have worked around the clock to produce and deliver essential PPE across Ohio, ensuring that voters who choose to vote on election day are safe.

#### How would you address immigration policy? I have long worked across the aisle to address the

problems we're currently facing due to our broken immigration system and am frustrated that Congress has failed to act to end the crisis at our southern border. America is the land of opportunity. That's why fixing our broken immigration system should not be a red or blue issue. It protects both Americans and those who want to come here for a better life.

Congress needs to provide the tools our border patrol agents need to do their jobs safely, ensure the security of our nation and end the broken cycle that has led to the humanitarian crisis at our border. Whether it's women and children being abused or trafficked on their way to our country, the separation of those individuals once they get here, the level of drugs flowing across our southern border that contribute to thousands of American deaths each year, or those impacted by crimes committed by individuals who would've never been allowed into our country had they gone through legal channels, it is very clear that there is too much suffering going on.

Partisan politics have prevented progress on this issue for decades, but the reality is that perpetuating the security and humanitarian crisis at our southern border can no longer be an option. As someone who has voted both to provide DACA recipients with legal certainty and strengthen our border security. I firmly believe we cannot continue to shy away from compromise when it comes to fixing our broken immigration system.

#### Where do you stand on efforts to protect our water, air, and land?

Having lived my entire life here in Northeast Ohio, I know how valuable our natural resources - like Lake Erie - are. In Congress, I'm proud to help lead the bipartisan effort to protect and preserve the Great Lakes. I'm known in Washington as "the Great Lakes Guy" for all the work I do to combat invasive species, restore habitats, reduce harmful algal blooms and prevent pollution in the Great Lakes region. These lakes supply 90% of our nation's surface water, are home to 3,500 species of plants and animals, create \$62 billion in wages each year and support 1.5 million jobs. They're a national treasure and must

be preserved for future generations to come. In addition to my work to restore the Great Lakes, I've introduced a number of bipartisan conservation and environmental bills, including the RECYCLE Act with Rep. Dean Phillips and a bill to extend and increase funding for the Ohio & Erie Canalway National Heritage Area with Rep. Tim Ryan. That's not to mention the countless other pieces of legislation I've cosponsored such as the Restore our Parks and Public Lands Act and the Trillion Trees Act. We must continue to be good stewards of our environment and I will continue to work across the aisle to ensure legislation coming out of Congress helps us accomplish that.

#### What legislation, if any, would you suggest to address gun safety?

As a member of the initial prosecuting team for the Chardon High School shooting in 2012, I have seen first-hand the impact that acts of senseless violence have on our communities. That's why I have reached across the aisle and offered to work with my Democratic colleagues to critical issue in a non-partisan way.

In addition to consistently voting to protect and strengthen the National Instant Criminal Background Check System (NICS). I voted to increase the accuracy of background checks and penalize agencies that fail to report required information to NICS. I have also supported numerous pieces of legislation that address the root cause of these tragedies, such as the Mass Violence Protection Act of 2019. This legislation tackles gun violence by improving information sharing among law enforcement agencies and cracking down on illegal firearm possession.

Other legislation I've cosponsored includes the Mental Health Crisis Act of 2016, the STOP School Violence Act, the Securing our Schools Act, and the Safe Schools Improvement Act. Last Congress, I sent a letter to the Department of Justice in support of Ohio's application for funding under the STOP School Violence Act to help bring threat assessments and training programs to all Ohio schools.

As the only member of Congress to have prosecuted a school shooter, I remain committed to finding commonsense solutions to reduce gun violence and directly improve the safety of our communities.

Given our experience with Covid-19, what precautions would you put in place to allow for safe, secure elections whereby voters are not choosing between their health and their right to vote, especially in November? Include how you would fund any necessary precautions and changes.

The CDC spells out clear recommendations for holding safer elections in light of the COVID-19 crisis. The risk for infection is highest when circumstances force larger crowds to congregate indoors for longer wait times. Lower risk scenarios include having a wide variety of voting options, longer voting periods (more days and/or more hours), and other means of reducing the number of voters congregating indoors. Polling locations should be set up to maximize adherence to CDC recommendations, including mask use, social distancing, and hygiene. Further, we should invest alternatives to in-person voting, including extended absentee voting and the placement of ballot deposit boxes, placed in an equitable manner based on population and travel time from population centers.

The CARES (Coronavirus Aid, Relief, and Economic Security Act) Act combined with 2002's HAVA (Help America Vote Act) provide over \$825M in available funding; however, most estimates place the cost of a safe, secure election closer to \$2B and the shortfall ought to be covered by Congress via a further stimulus package. Additionally, the Postal Service must be fully funded as part of our election infrastructure. The right to vote is one of Americans' most basic Constitutional rights and Congress has a sworn obligation to ensure all citizens have the ability to safely cast their ballots.

### How would you address immigration policy?

Give me your tired, your poor, your huddled masses yearning to breathe free...

The United States is a nation of immigrants, creating not just our identity, but also a necessary component of our economic success.

Our system is undeniably broken with arcane rules, years-long backlogs, and no identifiable 'line' amongst numerous problems. Current toxic discourse has led to the US shirking its duty under international law to care for refugees, locking children in cages, separating families, removing people from the only home they've ever known, and even deporting military veterans.

Perhaps it is not pragmatic to conceive of rebuilding the system from the ground-up, but it is obvious that wholesale reform is necessary.

The most immediate reform necessary is a return to the rule of law. Due process in immigration enforcement. Adherence to international treaties. A return to decency and fair play and rejection of unnecessarily cruel and punitive enforcement actions. Our focus and investment should be in combatting the flow of illegal drugs, weapons, and human trafficking.

#### Where do you stand on efforts to protect our water, air, and land?

If we fail to act soon, climate change will damage our economy and leave a difficult and uncertain future for future generations. Climate change is hurting our community in important ways including damage to agriculture, health, and damage to Lake Erie that can't be fixed with a few dollars of

Further, I believe our military leaders when they tell us that climate change is a national security threat. For example, many naval bases are highly susceptible to sea level rise. Further, climate change

will exacerbate conflicts around the world and may lead to mass migrations of people escaping the ensuing conflict, drought, and famine.

As Americans, we have the ability to face and overcome any challenge, and climate change requires our unique American ingenuity, spirit, and can-do attitude. What's more, we've had historic successes using policy—in cooperation with business and markets—to solve major environmental issues. Despite dire warnings that solving these problems would harm the economy, the economy grew as the solutions were implemented. For example, our heavily polluted rivers, dramatized by the Cuyahoga River fire in Cleveland in 1969, were cleaned up through industry's innovation and federal legislation (Clean Water Act).

Taking on this challenge can actually benefit us. Environment vs. economy is a false choice—the clean energy economy creates jobs in green infrastructure that can't be shipped overseas.

#### What legislation, if any, would you suggest to address gun safety?

As a combat veteran I will unequivocally say that weapons of war do not belong on our streets. This does not translate to 'anti-gun;' firearms are necessary tools and belong in the hands of trained law enforcement personnel and hunters amongst others. We can prevent guns from getting into the hands of criminals through common-sense regulation which respect the 2nd Amendment and are in keeping with historical precedent.

Priority one is universal background checks. Background checks have the support of over 85% of Americans. They work and have prevented over 3.5 million sales to people who are prohibited from owning guns, such as felons, abusers, and fugitives. Simply put, background checks help keep weapons out of the hands of criminals making our streets safer for us, our children, and law enforcement. Universal checks close the loopholes in the system. Over 30 states—including Ohio—do not require a check on unlicensed sales

We must reinstate the 1994 prohibition on assault weapons and high capacity magazines and institute a voluntary buyback of those in circulation. This prohibition made our streets safer and is consistent with historical regulations dating back to our nation's earliest days

Finally, the gun industry's immunity to most civil lawsuits, established by PLCAA, must be revoked so they reap the costs of selling their products, not just the profits.

In what ways would you change our election system in order to be prepared for crises that impair the right to vote?

Robust voter education about voting options is key during a crisis. Some changes that should have been implemented in Ohio during this crisis are (1) the ability to request an absentee ballot online instead of limiting requests to a paper application that is mailed in, and (2) increasing the number of ballot drop box locations rather than only allowing a drop box at a single Board of Elections location for each county. Including postage on the return envelope for requested absentee ballots would also facilitate voting. Some other states only permit absentee voting if the voter has an "excuse," and those states should adopt Ohio's system of "no

excuse" absentee voting. Other types of crises could involve the internet or electrical systems, and returning to the universal use of hand-marked paper ballots could help ameliorate those problems.

#### What will you do to combat gerrymandering and ensure that voter-approved redistricting reforms are implemented?

Fair districts and fair elections are essential to our democracy. A three-judge federal panel ruled last year that Ohio's current congressional districts are unconstitutionally gerrymandered, depriving us of our free speech and voting rights. But the Supreme Court subsequently ruled that it was up to the political process rather than the courts to address gerrymandering. Fortunately, new Ohio rules govern how maps are to be redrawn in 2021 and require far more transparency and bipartisanship than when districts were last drawn. As a state senator I will have the opportunity to vote on the new district maps even if I am a member of the minority party, and I will diligently review such maps for fairness. I will be a strong voice for compliance with the new laws and for fair districts within the legislature and in all public forums. Members of all political parties benefit from fair districts where politicians are accountable to voters and extremism is not rewarded.

#### Where do you stand on gun safety measures?

My dad was a game warden with the Ohio Division of Wildlife; I grew up hunting with him and guns were a regular part of our lives. I recognize Second Amendment rights and I support common sense gun safety measures such as universal background checks that keep guns out of the hands of criminals and terrorists. I also support Red Flag Laws that allow courts with due process to keep guns out of the hands

of people who are a danger to themselves or others, like domestic violence perpetrators. I am the endorsed candidate of the Ohio Fraternal Order of Police, and I support measures that protect our police such as disclosure of concealed weapons during a traffic stop or other law enforcement purpose.

#### Where do you stand on women's reproductive rights and health?

When I was a married law student without health insurance, I was able to receive affordable routine women's healthcare at Planned Parenthood and those services included birth control that allowed me to plan when I would start our family. I support healthcare services such as Planned Parenthood and believe women should be able to access affordable healthcare and to make their own healthcare decisions with their doctors without interference by the government. This right to make medical decisions extends to their reproductive rights, subject to the limits set forth by the United States Supreme Court in Roe v. Wade. This decision has been established law in this country for almost 50 years and should not be overturned.

#### In what ways would you change our election system in order to be prepared for crises that impair the right to vote?

In Ohio we have the option of in person voting, and by request, mail-in absentee voting. In March of this year, our in person voting option was taken from us late the night before the primary election by a "non-elected" health official. This was done after a judge denied the request backed by Governor Dewine to postpone the election. The crisis in this event: government overreach, as well as, the violation of the separation of powers as outlined in the Constitution. The Health Department should not have the authority to strip or alter our voting rights, nor should the governor have the authority

to disregard the ruling of a judge. I would pass legislation to make sure they never have that authority again. When in the event of an actual crisis during an election, emergency session of legislation should determine the correct path to take. How would you implement a constitutionally compliant school funding system?

The Constitution grants the federal Government no authority over education, so the 10th amendment applies, giving that power to the state and to the people. Ohio should nullify the "No Child Left Behind Act", and all regulations imposed by the Federal Government's Department of Education. Parents should also have the right to provide for the education of their children in the manner they deem best, including home, private, or religious. Equitable tax relief should also be provided for families whose children do not attend public schools.

#### Where do you stand on efforts to protect our water, air, and land? Include how you would address climate change.

It is our responsibility to be prudent, productive and efficient stewards of our natural resources. This requires a proper and continuing dynamic balance between development and conservation, between use and preservation. With that, we must wholeheartedly support realistic efforts to preserve the environment, and reduce pollution. I however dispute the argument of the perceived threat of "man-made" climate change.

#### Under what circumstances is it appropriate for the state to restrain or check local government?

The closer civil government is to the people, the more responsible, responsive and accountable it is likely to be. Ohio's "Home Rule Law" recognizes this ideology; therefore, the only time the state should check or restrain local government, is in the events that people's unalienable rights are being infringed, general law is being broken, or the constitution is being violated by the local government. #### In what ways would you change our election system in order to be prepared for crises that impair the right to vote?

severely limits the quality of education and services that we can provide our Children and our Communities. Where do you stand on efforts to protect our water, air, and land? Include how you would address climate change.

I have seen the enemy, and it is us. We are far too reliant on single use plastics; and this comes from a person who grew up at a time when we were going to embrace recycling and the metric system. What happened? The 99th House District includes communities that are being devastated by climate change. Land that was receding into Lake Erie at a rate of a feet each year, is now vanishing away in large sections - gone forever. Members of our Community have lost their homes, or remain at risk of losing their homes to on-going erosion. Moreover, our local Communities that depend on the lake for tourism are in danger, placing our area at risk for future economic growth.

# Under what circumstances is it appropriate for the state to restrain or check local government?

The United States Constitution sets the minimal rights that we hold as Citizens of this great Nation. The individual States can expand those Rights not inconsistent with the U.S. Constitution. For instance, recognizing the importance of education in our Society, Ohio's Constitution requires the "thorough and efficient" funding of Public Education by the State of Ohio.

The Citizens of Ohio voted for "Home Rule," permitting certain levels of local government to enact ordinances not inconsistent with the U.S. or the Ohio Constitutions. Often, State and Federal Governments control the "purse strings," causing limitations in the operation of local government. I'm not suggesting that this is a correct use of Federal or State Power, but the "Home Rule" provisions enacted in the 1912 Ohio Constitution have decreased as restrictions are placed on local government. In my opinion, the Supreme Court of Ohio must re-visit the issue on the application of Ohio's Home Rule Provisions.

As a long time voting location manager for Ashtabula County polls, I can say first hand that the challenges of voting during this crisis are unprecedented. I think that it is vital to offer voters the opportunity to vote in person, while still allowing options such as absentee ballots and early voting. It is important that we maintain local control of the elections, allowing each county board of elections to continue to tailor their operations and emergency response plans (including personal protection equipment and sanitation) to their county's needs in cooperation with the local health department. Ohio has one of the most efficient and state-of-the-art voting systems that allows all eligible voters, and only eligible voters, a wide variety of safe and secure options so they can make their voice heard in every election.

# How would you implement a constitutionally compliant school funding system?

Bob Cupp, former Ohio Supreme Court Justice and joint-sponsor of the Patterson-Cupp School Funding Bill (HB 305), testified to the Ohio State Board of Education in 2019 that Ohio's school funding system has undergone several fundamental changes since the Ohio Supreme Court ruled on its constitutionality which means that the ruling is no longer applicable.

The ongoing policy discussion revolves around decisions of how local tax monies are raised and spent, balancing state funding with regulatory oversight and accountability measures, and how

to ensure that all students have access to quality education. My eight years on the State Board of Education have provided me with an understanding of and appreciation for the complexities of balancing local control with additional state tax dollars.

Additionally, the state needs to use accurate assessments that reflect the true academic knowledge of students, make state report cards clear and understandable, and respect parents' education choices.

# Where do you stand on efforts to protect our water, air, and land? Include how you would address climate change.

Having grown up in agriculture, I know firsthand the importance of maintaining our soil and water resources and their unique ecology's. Good stewardship includes respect for our natural resources and the economy that is the engine powering those resources. In our efforts to preserve and restore a healthier air and water supply, we need to consider the personal and commercial freedoms which often contribute to new technologies advancing our knowledge, usage and conservation of these resources. I am pleased to have received the "2020 Friend of Agriculture" designation from the Ohio Farm Bureau (OFBF-AGGPAC) and have been endorsed by the National Federation of Independent Business (NFIB-PAC), which have been forward thinking organizations in promoting balance and good stewardship of these important resources.

#### Under what circumstances is it appropriate for the state to restrain or check local government?

The purpose of government at the local, state, and federal levels is to protect individual rights and ensure equal application of the law. Just as we have three coequal branches in our system of government, the local, state and federal jurisdictions serve as checks and balances on each other to best address the needs of the citizens.

My general attitude is "subsidiary," the principle that a central authority should have a subsidiary function, performing only those tasks which cannot be performed at a more local level. The test for that should error on the side of local control, requiring that a task or oversight is shown to be demonstrably better in the hands of that central authority. The state and federal jurisdictions have a role but caution should be exercised to avoid over regulation and excessive unfunded mandates. I have been endorsed by the Ohio Citizens PAC, Ohio Republican Party, Ashtabula Republican Party, and Geauga Republican Party.
