Chamber, SCORE to offer CARES Act webinar
The CARES Act created two very large SBA disaster funding vehicles. The Economic Injury Disaster Loan (EIDL) and the Paycheck Protection Program (PPP) provide emergency funding to small businesses who are impacted by the Covid-19 pandemic.
SCORE and the Citrus County Chamber of Commerce will present information about these programs in an online webinar at 8:30 a.m. Friday, May 1.
Many Nature Coast small businesses applied for funds through these programs. Many of those have already received funding while others are waiting for their applications to be processed by the SBA and lenders.
Some of these funds are a loan and some are a "forgivable loan" — meaning you do not have to pay it back. However, how you spend the funds and how you document those expenditures may have a major impact on whether you must repay the funds.
Jim Green, Certified SCORE Mentor and Johnny Cash, CPA will provide an update on the status of these two very important programs, as well as detailed information on how to manage and account for expenditures from the funds to protect the "forgivable" status of funds from the PPP program. DeSantis plan: 'Baby steps'

Governor to allow limited openings of stores, eateries with local approval

TALLAHASSEE — Florida's restaurants and retail stores will be allowed to reopen Monday at 25% capacity, if the local government allows it, Gov. Ron DeSantis announced Wednesday, as the state begins the slow climb from the economic abyss caused by the coronavirus.
The governor specifically excluded hard-hit, heavily populated Miami-Dade, Broward and

Palm Beach counties, saying their businesses will begin phase one when it is safer.
His order will also allow hospitals and surgical centers statewide to restart nonessential, elective procedures — but only if they have sufficient medical supplies and agree to help nursing homes and assisted living facilities prevent and respond to coronavirus outbreaks. Parks, golf courses and other outdoor recreation areas already began reopening in some counties Wednesday.

"I am convinced we can take this step. We will be smart, we will be safe and we will do it step-by-step, but we should have hope," DeSantis said. "We are resourceful, we are innovative, we can get this done. It is not going to happen overnight. If there was some magic where I could flip the switch, I would do it."
DeSantis, a Republican, is being more cautious than the neighboring state of Georgia, as well as the task force DeSantis formed last week to study how to

get people back to work. The task force suggested restaurants could operate at 50% capacity, but the governor is easing in more slowly — 25% capacity inside, tables 6-feet apart outdoors. He said earlier this week that Florida will take "baby steps" in trying to resume business and is following through with that approach.
The task force also suggested reopening gyms and barber-shops with restrictions, but he's

Board chairman criticizes vote to open all parks, ignore group's review

Brian Coleman hopes this all works out.
Citrus County's commission chairman said the 3-2 board vote Tuesday to reopen Fort Island Gulf Beach along with other county parks starting Friday ignored the workings of a group he formed that included the sheriff and health director.
"We had a good plan put together," Coleman said Wednesday. "Now we're scrambling trying to figure it out. That's never a good

thing when you have time to figure it out and don't use that time."
The vote opens all parks without restrictions other than 6-foot social distancing and groups of no more than 10 individuals, as directed in Gov. Ron DeSantis's stay-at-home order that expires Thursday. The guidelines still exist, Coleman said.
Sheriff Mike Prendergast said his agency has a plan in place to ensure the public is adhering to those guidelines.

Hospital board gives \$430K to charities

Funds will help groups hit hard by virus

The Citrus County Hospital Board is giving 43 local charities \$430,000 in help to offset slumping donations and increasing calls for help as the coronavirus takes its economic toll on the non-profit groups.
Working through the

Citrus County Community Food Bank, hospital board chairwoman Debbie Ressler identified the Citrus County charitable organizations and proposed to her fellow hospital board members to donate \$10,000 to each charity. She told her trustee members that the coronavirus

Septic-to-sewer projects get \$7M

The septic-to-sewer initiative for Citrus County got a huge shot in the arm from the Southwest Florida Water Management District (SWFWMD), which is providing more than \$7 million in matching funds for five Citrus county projects.
That money will help

reduce the impact of septic tanks on the region's five first-magnitude springs.
Sen. Wilton Simpson, R-Trilby, called this "very good news" which helps reduce the financial load on citizens. He thanked county commissioners, the Florida Department of Environmental Protection

has made fundraising more difficult and the stay-at-home orders have left people out of work and needing more help.

"The COVID-19 virus has impacted these (43) organizations dramatically, with an increase in our neighbors in need due to decreases in donations from the public with money or actual food items," she told the hospital board members during a board meeting this week.

She told the Chronicle that as the coronavirus takes its economic toll, this is the time for the hospital board to step in.

Ressler told her trustees the organizations already have registration criteria for their clients requiring proof of county residency and need for financial help. She said giving the money to local organizations during such a pandemic falls well within the hospital board's mission to help the county's residents with health care needs.

The hospital board agreed in a 4-1 vote to give the money and allow the organizations to use it to perform their mission. That includes food aid, helping needy residents pay for utilities and other essential services. Trustee member Rick Harper voted against the measure.

Hospital board attorney Bill Grant said the receiving organizations would have to agree to use the money for the purposes that fit their mission.

The hospital board owns Citrus Memorial Hospital on behalf of the public and leases it to the Hospital Corporation of America.

Barbara Sprague, executive director of Citrus County Community Food Bank, said the money could not have come at a better time.

"We saw a doubling, if not more, of the people needing or services," Sprague told the Chronicle.

The community food bank provides food to 53 other local charities, which in turn distribute it to clients around the county.

Prior to the coronavirus, about 80% of the food banks' donations were from groceries donating dented can foods and foods nearing their expiration dates. A few weeks ago those supplies dropped to 25% of previous food donation levels as more shoppers hoarded food. That's improved, Sprague said, but is still short 25% from previous levels.

The charity has had to scour other food sources to make up the loss, and has had to travel to areas such as Tampa for donations.

"We don't expect this to

end for quite some time," she said of the need for food, and expects the demand to perhaps quadruple as family members remain unable to work.

The hospital board donation "will help tremendously," she said.

Citrus United Basket serves between 300 and 350 clients per month in food donations and executive director Kelly Selph predicts requests and costs to increase by at least half.

To make matters worse, the charity had to shut its thrift store doors, costing the charity about \$100 per day in revenue.

In addition, many of its volunteers are staying home in hopes of not contracting the virus. So that made it especially important that the organization's two full-time employees and two part-time employees stay on the job and be paid, Selph said.

Selph said she applied for federal small business loans, but none have come through. That makes the hospital board help so appreciated, she said.

Before the pandemic, Ginger West, executive director of Citrus County Family Resource Center, said her organization provided food to about 25 families per week. In the past month, more than 80 additional people have been added to the roles.

"There are lots and lots of new families we've never seen before," she said.

The charity also helps people find jobs, get identification documents and health care, such as cancer screenings. But the organization has closed most of those services during the pandemic and focused on food distribution.

Later this fall, the charity will have to move out of its current location in Hernando and to another office. West said the hospital donation will allow the move to go ahead.

"So we don't have to lose service (to our clients)," West said.

Ressler said the hospital board can in August

again review whether the county's charitable organizations still need help and determine whether another infusion in

cash is needed.

**Curbside pickup of unemployment apps now available**

Those having trouble accessing the online unemployment insurance system can pick up a paper application starting today.

The applications will be available for curbside pickup Monday to Friday at the CareerSource Citrus Levy Marion at 683 S. Adolph Point in Lecanto.

The forms will be supplied from 10 a.m. to 3 p.m. each weekday.

Unemployment insurance provides temporary wage benefits to those who have lost their jobs because of the coronavirus. The program, run by the Florida Department of Economic Opportunity (FDEO), has experienced recent difficulties keeping up with unprecedented demand.

Last week, the CareerSource Florida network was authorized to assist FDEO in order to help alleviate the application logjam.

According to Kathleen Woodring, CareerSource CLM's executive vice president, the paper applications are an alternative for those having trouble completing the online application. She said applicants must mail the paper applications to FDEO and that doing so could potentially take longer to process than online.

Those planning to pick up paper applications are urged to drive as close as possible to the center entrance and have one person per vehicle get out and pick up applications from the distribution box outside the center. The centers are not currently open to the public.

"We are mindful of the need to maintain social distancing. If there is a line of vehicles, please stay in your car until you can pull up," Woodring said. "You may take as many applications as you need, if you are getting them for other members of your household. We will restock as needed throughout the day until 3 p.m."

**Homeless man facing more charges**

*Five more added to 13 previous*

Criminal charges kept mounting this week against a 38-year-old Floral City homeless man after Citrus County Sheriff's Office deputies originally arrested him last week.

Deputies charged Justin Edward Fraleigh with five counts of illegal use of a credit card Monday as he was already sitting in the Citrus County jail, according to arrest documents. The additional charges added another \$10,000 to

his previous \$49,000 bond. Deputies originally arrested Fraleigh last week on 13 charges that included aggravated assault with a deadly weapon without the intent to kill, grand theft, burglary to several structures, auto theft and attempted auto theft.

The majority of charges stem from crimes committed in the Floral City area, according to arrest documents, where Fraleigh is accused of breaking into the Floral City VFW, Floral City Auto Sales, Prime Auto Sales as well as a Spectrum work van. In addition, Fraleigh is charged with

burglarizing a law office in Inverness.

Deputies are now accusing Fraleigh of using at least one credit card from the five he stole, according to arrest records. Deputies say he used the cards to purchase a cellphone, cigarettes, electric tools, electronic equipment, food and clothing.

During the burglaries, deputies say he took computers, surveillance equipment and office supplies, in addition to the credit cards.

A broken brake light and a suspended driver's license led to a high speed chase between a 23-year-old Floral City woman and

a Citrus County Sheriff's Office deputy in pursuit.

According to arrest documents, Antoinette Civil Dietrich, of 10495 E. Rabbit Lane, was turning onto South Croft Avenue from East State Road 44 when a sheriff's deputy at the intersection noticed the woman's white pickup had a broken brake light. The deputy headed north on South Croft Avenue to follow Dietrich and reported she increased her speed, according to arrest records.

The deputy reported he turned on his lights and siren, but Dietrich would not stop, but rather continued at a high rate of speed

running two stop signs. She finally came to a stop at East Dawson Drive. The deputy approached the truck with his pistol drawn and ordered Dietrich out of the vehicle.

Arresting deputies found that Dietrich's driver's license had been suspended earlier in April for failing to pay court fees.

She was charged with knowingly driving with a suspended license and eluding a law enforcement officer with siren and lights engaged.

**New Homosassa 7-Eleven tentatively set to open in June**

**Local woman arrested for stealing a car**

Authorities arrested Megan Theresa Stergios on April 24 at the Central Motel in Inverness and charged her with stealing a vehicle.

According to the report, Stergios, 28, admitted she knew it did not belong to her and also that she didn't have a valid driver's license.

She told a Citrus County sheriff's deputy that she needed to go to the store down the street, but got

lost because she was under the influence of methamphetamine.

The owner of the vehicle, a 2001 black and silver Dodge Dakota two-door pickup truck, had reported it stolen from his residence on April 16.

He also reported other items of value that were inside the truck: a toolbox containing miscellaneous tools, valued at \$1,500; a cellphone and a wallet containing a \$50 bill and four credit cards.

At her arrest, Stergios

said she took the victim's cellphone but that the toolbox and tools and the wallet were still in the truck somewhere.

She was charged with one count of vehicle theft and one count of grand theft with a total bond set at \$4,000.

Benjamin Zippy Tobiah Gilbert, 20, said he was upset with the another man's "drinking" and "verbal abuse" toward a female relative, so he allegedly punched the man in the face.

A Citrus County

sheriff's deputy was called to the a home in Hernando on April 24 in reference to a physical domestic violence incident

and was met by the alleged victim, who was bleeding from the right side of his upper lip and on both elbows, outside the residence.

The victim told the deputy that a fight with Gilbert had started when he "unplugged (the) internet," according to Gilbert's arrest report.

The reported victim had gone into the bathroom

and when he heard someone approaching; he opened the door, and that's when his Gilbert attacked him, he said.

The deputy reported that Gilbert admitted to punching the man "because he got fed up with the abuse."

Gilbert was arrested and taken to the Citrus County Detention Facility and charged with one count of battery on a person 65 years of age or older with no bond.

## Streaming films eligible for Oscars, but for 1 year only


LOS ANGELES — Movies that debuted on a streaming service without a theatrical run will be eligible for the Oscars, but only for this year. The Academy of Motion Pictures Arts and Sciences on Tuesday announced the change for the 93rd Academy Awards as a response to how the coronavirus pandemic has impacted the film industry.

The film academy also said it will condense the two sound categories into one and prohibit DVD screeners for 2022's 94th Oscars in an effort to become more carbon neutral.

Oscars eligibility has been a major question since stay at home and social distancing orders led to both the cancellation of major film festivals and the closure of movie theaters. Previously, a film would have to have a minimum seven-day theatrical run in a Los Angeles County commercial theater in order to be considered for film's highest honor. Now films that had a previously planned theatrical release but are made available on a home video on demand service may qualify for best picture and other categories.

"We're dealing with the unfolding reality of an unanticipated, unprecedented global health crisis and trying to be responsive to what's going on in the world and at the same time support our filmmakers who are in a circumstance beyond their control," film academy president David Rubin told The Associated Press Tuesday.

Dawn Hudson, the CEO of the film academy, said that they have been in "constant conversation with all parts of our

community from studios to filmmakers to theater owners" to make decisions that support all.

## 'Trolls' went straight to homes — movie theaters are fuming

NEW YORK — The most controversial movie of the year is ... "Trolls World Tour"?

As innocuous as the rainbow-colored, music-blaring animated movie may seem, the digital release of the "Trolls" sequel has caused a storm to course through the movie industry. Just as the pandemic worsened and movie theaters were shuttering, Universal Pictures shifted the film's release to video on demand, leading a charge straight through the theatrical window.

Universal calls the "Trolls World Tour" digital release a success and suggests it may be the beginning of a sea change in how movies are released. Theater owners strenuously disagree. AMC Theaters, the largest chain in the United States, is signaling an all-out war, saying it will no longer show Universal movies.

While few anticipated a

skirmish would come over a glitter explosion like "Trolls World Tour," it has been long in coming. Netflix, Amazon and other streaming services have in recent years broken the industry's traditional theatrical window of 72-90 days (and thus had their films excluded from major theater chains), and the major studios have sometimes been tempted to try their own luck and head straight to homes.

On Tuesday, NBCUniversal CEO Jeff Shell told The Wall Street Journal that the digital release for "Trolls World Tour" has gone well enough to demonstrate the viability of direct-to-home releases. He promised that even once theaters reopen, "We expect to release movies on both formats."

The Journal reported that in three weeks of \$20 on-demand rentals, "Trolls World Tour" has grossed about \$95 million. The studio, which normally splits sales approximately in half with theaters, pocketed about \$75 million of that. A spokesman for Universal did not dispute those figures.





“We will have an enhanced presence in all places where there is a potential for large numbers of folks to gather,” he said Wednesday.

Prendergast said deputies will educate those not practicing social distancing with a pamphlet, just as they have done the past four weeks when, he said, the marine unit was quadrupled to patrol both coastal and lake waters.

Led by Commissioner Ron Kitchen Jr., the board voted 3-2 Tuesday to not only reject Coleman's recommendation for a gradual reopening of parks that had been vetted by the working group and supported by the health director, but also to open all county parks starting Friday.

Commissioners Kitchen, Scott Carnahan and Jimmie T. Smith voted for the total reopening of parks. Coleman and Commissioner Jeff Kinnard opposed.

The working group was prepared for commissioners to approve Coleman's plan. Coleman did a video — not released — explaining the parks reopening plan. A news release was written, approved and ready to go after the vote. And, because the overall plan was to reopen city and county parks on Wednesday — the day after the board meeting — Coleman said Oliver's staff had begun to make signs for the parks letting the public know of social distancing rules.

Tuesday's vote changed all that.

“That's what happens when you have a good plan and three commissioners vote to change it,” he said. “We put a lot of work in it. I had no idea it was going to go that way.”

Health director Ernesto “Tito” Rubio was unavailable for comment. Spokeswoman Audrey Stasko responded to a reporter in an email that read in part:

“The role of the Florida Department of Health is to provide guidance and recommendations based on the latest data. During the meeting yesterday those recommendations were discussed.”

Stasko then directed a reporter to watch a video of the board meeting if he wanted more information.

Prendergast, asked if opening Fort Island Gulf

Beach and other parks all at once places the county in a position to ramp up COVID-19 cases, said: “The science out there right now has gone to show social distancing is working. Statistically, when you look at what Florida was projected to see, we have not seen the dire circumstances of a serious outbreak.”

Coleman said he is particularly concerned for

county workers and vulnerable citizens who may be exposed to the virus by someone asymptomatic who ignores social distancing at the beach.

He said many people are purposely ignoring the guidelines, which frustrates him.

“Whether you think it's right or don't think it's right, stop thinking just about yourself. Think of the other person,” he said.

“If one of those people brushes up against one of my kids and it infects one of my grandkids, I'm going to be pretty upset about that.”

City Managers Ken Frink of Crystal River and Eric Williams of Inverness opened some of their city parks on Wednesday. Both said they were disappointed in the county commission's rejection of the plan formulated by

the working group.

“Since the onset of this situation, the counties and cities have worked close together,” Frink said. “I don't think we're always going to hit that mark. This is one of these cases where the county and cities disagree on how to open up these parks.”

(FDEP) and Gov. Ron DeSantis for helping push this money through.

“We have some other line items in the (state) budget that we hope will be spared from the veto pen in addition to this money,” he said.

Excess nitrogen, phosphate and sewage get into the aquifer

and eventually into local waters. Making these conversions now, Simpson said, ensures continued quality-of-life for local springs and waterways for future generations.

Septic tanks contribute up to 42% of the current nitrogen pollution in the district's five first-magnitude springs, according to FDEP. Increased nitrogen can cause algae growth, which can be harmful to aquatic plants and wildlife.

“Improving our five

first-magnitude springs is a key priority for our district,” said Brian Armstrong, the District's executive director.

The five septic-to-sewer projects, estimated to reduce nitrogen by more than 10,000 pounds per year, include:

### Crystal River/ King's Bay

- Citrus County Cambridge Greens septic-to-sewer.
- Crystal River Indian Waters

phase II septic-to-sewer.

- Crystal River southern septic-to-sewer project.

### Chassahowitzka and Homosassa

- Citrus County Old Homosassa West septic-to-sewer project.
- Citrus County Old Homosassa east septic-to-sewer.

not allowing that in the first phase. DeSantis is also not setting a date for the second phase. Instead, he's taking a wait-and-see approach to how the state fares during the first phase.

“My hope is that we are thinking about each phase as weeks, not thinking about months,” DeSantis said. “We are making progress. We need to put people back to work in a safe, smart and step-by-step way, but it is going to be data driven.”

Bars and nightclubs also won't reopen yet, but DeSantis gave approval to sporting events if they don't include spectators. The state will continue to

restrict visitors to nursing homes and state prisons.

Florida has had more than 33,000 confirmed cases of coronavirus, resulting in at least 1,218 deaths, according to the state Department of Health.

More than 800,000 Floridians have filed for unemployment as the state's two biggest economic sectors, tourism and

agriculture, have been decimated after visitors fled and institutional produce buyers such as hotels and schools closed.

DeSantis was one of the last governors to issue a statewide stay-at-home order, preferring a county-by-county approach throughout March. Statewide, he essentially closed bars March 17 and

on March 20 he closed gyms, limited restaurants to takeout and delivery and banned gatherings greater than 10. Schools also closed in March.

On April 1, the governor ordered the closure of nonessential businesses statewide starting two days later and ordered employees to work from home wherever possible.



# HOF nixes ceremony

## Jeter, Walker induction will wait for 2021

Derek Jeter, Larry Walker and the rest of this year's Baseball Hall of Fame class will have to wait another year for their big moment at Cooperstown.

The Hall of Fame announced Wednesday that it has canceled the July 26 induction ceremony because of the coronavirus pandemic.

Instead, the class will be included at next year's induction festivities — along with any additional new choices — on July 25, 2021.

A record crowd of over 70,000 had been expected this summer in an outdoor field at the small town in upstate New York to honor Jeter, the former New York Yankees captain who came within one vote of unanimous election by the Baseball Writers' Association of America in January.

Jeter and Walker were to be inducted with catcher Ted Simmons and the late Marvin Miller, the pioneering players' union head who negotiated free agency and transformed the sport.

"Being inducted into the Hall of Fame will be an incredible honor, but the health and safety of everyone involved are paramount," Jeter said in a statement released by the Hall.

"I respect and support the decision to postpone this year's enshrinement and am looking forward to joining current Hall of Famers, fans, staff and my family and friends in Cooperstown in 2021," he said.

This will be the first year without an induction ceremony since 1960.

"It was a very difficult decision, but with so many unknowns facing the world, the board felt strongly that this was the right decision," said Hall member Joe Morgan, vice chairman of the shrine's board.

Record attendance for an induction ceremony was set in 2007, exceeding 70,000 when Cal Ripken Jr. and the late Tony Gwynn were enshrined. Cooperstown is within easy driving distance of the New York metro area, and loads of Yankees fans had already made their plans to see Jeter on the Hall stage.

The Baseball Hall of Fame and Museum closed at the end of the day on March 15 due to the virus outbreak.

Jeter, now the CEO of the Miami Marlins, and Walker were elected by member of the BBWAA. Simmons and Miller were chosen in December by the Hall's Modern Era Committee.

"I fully understand and agree with the board's decision," Walker said in a statement from the Hall. "It is most important to do the right thing for everybody involved, and that means not putting any participants in jeopardy."

Simmons echoed that view.

"I commend the board for making this decision under these difficult circumstances, particularly in New York, a state severely hit by the pandemic. This was the wisest and smartest thing to do, given the existing environment and the danger that this pandemic presents," he said.

Also to be honored during next year's Hall induction weekend: 2020 Ford C. Frick Award winner Hawk Harrelson, 2020 J.G. Taylor Spink

Award winner Nick Cafardo and the winner of the 2020 Buck O'Neil Lifetime Achievement Award, David Montgomery.

Jeter, a key to five World Series titles, was on 396 of 397 ballots in voting announced Jan. 21. The only player with a higher percentage was former Yankees teammate Mariano Rivera, who became the first unanimous pick in 2019. Walker, making his 10th ballot appearance, got 304 votes — six over the threshold.

Next year's first-time eligible players have no odds-on favorites: Torii Hunter and Mark Buehrle are among the players who will be on the BBWAA ballot for the first time.

Holdovers include Curt Schilling, who fell 20 votes short this year, and steroids-tainted stars Roger Clemens (56 shy) and Barry Bonds (57). All three will be on the ballot for the ninth time, one shy of the limit.

If anyone new is elected, it would be the first ceremony since 1949 to combine multiple classes.

The first four Hall classes were inducted jointly in 1939 on the day the Hall of Fame opened. The classes of 1946 and '47 were inducted together, as were the classes of 1948 and '49.

Rogers Hornsby was elected in 1942, but there was no induction ceremony because of travel restrictions during World War II.

There was no balloting in 1940, '41 and '43. No ceremony was held in 1950, '58 and '60 after no one was elected.

Since Ty Cobb, Walter Johnson, Christy Mathewson, Babe Ruth and Honus Wagner became the original Hall of Fame class in 1936, the only previous years with no inductions were 1940, '41, '43, '50, '52, '58 and '60.

# Wildlife management areas

Now that the spring turkey season is over, it's time to do a little fishing, maybe hunt a hog or two, but importantly, it's time to begin making a hunt plan for the upcoming deer season. Sure, in our zone we'll be waiting until September to begin our hunts, but preparations can never begin too soon. First, ask yourself if you were satisfied with your season last year? If not, then you have to ask, are you going to repeat the same game plan as last year or step outside the box and seek new opportunities; especially on wildlife management areas?

Start your search for public hunting land with a laptop computer while resting on your couch. Our Florida Wildlife Commission has lists of all public land throughout the state with excellent details of each parcel, including maps.

When e-scouting from home, look for properties with access routes that lead you to the far corners of the WMA which butt up to tracts of private land. Search those areas with Googled aerial photos to get an even better idea of the site. Look for narrow hardwood hammocks, water holes, creeks and other corridors that tend to funnel wildlife. Mark those sites for a closer look later on. You don't have to key in on the corners and borders, anywhere you find remote corridors for ease of wildlife travel, mark the site. I only suggest corners and borders because that's where I always find success. Once you finish your digital scouting, it's time to put

boots on the ground. Identifying potential hunting sites with online maps is just the first step in scouting WMA lands. To consistently find deer, you must craft a scouting plan to begin visiting the sites for a thorough assessment. Look for rubs, scrapes and deer trails that connect bedding areas to feeding areas, but also look diligently for hunter sign. If you find tree-stands, trail markers, or other signs of hunters, you should expect to share those sites with others come fall ... I'd just keep looking.

Think creatively to find hidden hotspots. If you hunt near water, consider paddling to your tree stand in a kayak or canoe. A short paddle can separate you from nearly every other hunter. But, don't overlook places near roads or parking area as some of those spots are easily overlooked by most hunters, who hike right past the best cover, only 100 yards away.

To make the most of your scouting efforts, pick several hunting sites. Learn their entry and exit routes, so you can come and go depending on the wind direction, and if you discover someone else hunts nearby, you'll have plenty of options while respecting your fellow hunter's area.

### FRESHWATER

**LAKE ROUSSEAU** — Bill Burgess of Lake Rousseau RV and Fishing said bluegill in nice size and quantity are being caught, particularly in the evening, on crickets and wigglers up next to the bull rushes and tall brush in 5-6 feet of water. Catfish are biting on wigglers or a lump of bait in the same area as the bluegill. Crappie have gone deep and scattered. Catch bass, some weighing 4-5 pounds, some 7-8 1/2 pounds, by throwing worms above the weed beds or with topwater bait. Also try wild shiners on a bobber or just trolling behind the boat, as well as Texas-rigged Culprit worms in fire and ice on top of the weeds. Plastic frogs might also get the bite.

### SALTWATER

**KING'S BAY** — Captain Louie Argiro of Florida Fishing Adventures (352-601-1963, www.floridafishingadventures.com), based out of Pete's Pier in Crystal River, said, "Speckled trout have made a great showing inshore as we are

drifting hard bottom, throwing D.O.A. Lil Johns with 1/8th-ounce jig heads. The watermelon red color has been the best on my boat."

### AROUND CITRUS

Captain William Toney (352-422-4141) said, "Great fishing continues on the Big Bend. We have a few new fish to chase that are seasonal to us. Cobia are moving north and will pass through with the warming water temperatures. Cobia up in the shallows are not usually as

big as the fish out deep but provide some great fun.

"On the flats look for large stingrays; cobia like to shadow them as with jacks. A small jig on light tackle or 8-weight fly rod is a fun way to sight cast for them. An angler must be prepared because you never know when a keeper may be available and if hooked be ready to follow the fish. On my charters I've had anglers put quite a few in the boat on light tackle by following the fish and keeping

the boat between a crab buoy or marker.

"Tripletail have moved into the darker waters of river mouths and channels. They love old crab buoys on the moving tides. A float with a shrimp 12 inches under it; cast past and let it drift up to the buoy and it will get the bite. The size of a keeper tripletail is 18 inches and there is a lot of small fish out there, so be ready for the bite so they do not swallow the hook. Incoming tide will be in the late morning this weekend."

# Leaders must address county’s poverty, health

It is not surprising that 57 of the 97 positive COVID-19 cases in Citrus County are people over the age of 55, as of the morning of April 28.

Thirty-six percent of Citrus County’s residents are over the age of 65. Older residents typically develop the underlying conditions — heart and lung disease and diabetes — that make them especially vulnerable to the disease.

But that is only a part of the equation. The county has tested 1% of its residents. Of the total test given, about 6.3% have tested positive. Twenty-six percent of those who tested positive were hospitalized and 11.4% died. Hernando and Marion counties have fared better in terms of hospitalizations and fatalities.

Historically, Citrus County has consistently registered at the bottom in public health rankings and higher-than-normal levels of poverty.

Citrus County’s poverty level (15.2) lags far behind the national average (11.8) as does its median family

income (\$41,000 compared to \$63,000 nationally).

Families living in poverty have limited access to health care, maintain poor diets, live unhealthy lifestyles (alcohol, smoking, drug abuse) and have higher rates of obesity.

As a community, we should be very careful with and for seniors. Understand it is difficult for those in nursing homes

and assisted living facilities to be separated from family. We can still go shopping for a senior or send them food.

The real fear is for those low income seniors who don’t have options or family. Their risk is much higher.

Another takeaway is the county needs to develop an action plan to address the deficiencies in the county’s health survey. We have the data, but have failed to get buy-in from county leadership on how to address the problem. Until we take action on our poverty and illness issues, Citrus County will always lag behind state norms.




## Trump won't extend guidelines

WASHINGTON — President Donald Trump said Wednesday the federal government will not be extending its coronavirus social distancing guidelines once they expire Thursday, and his son-in-law and adviser, Jared Kushner, predicted that by July the country will be “really rocking again.”

Meanwhile, Trump said he plans to resume official travel with a trip to Arizona next week. And he said he's hoping to hold mass campaign rallies in the coming months with thousands of supporters, even though medical experts have said there is little hope of having a vaccine by then.

Putting a positive face on the latest grim numbers — the U.S. death toll has now surpassed those in the Vietnam War — Trump delivered his daily upbeat update and Kushner described the administration's much-criticized response to the pandemic as “a great success story.”

Trump also talked up the good news the day provided: hopeful results for a possible COVID-19 treatment. But the government announced dismal new economic numbers as the pandemic took hold and shut down much of the country.

The U.S. economy shrank at a 4.8% annual rate in first quarter of the year — a precursor to far grimmer reports that are expected this summer from the severe recession triggered by the pandemic.

The White House has been trying to pivot to a new stage of the crisis, focused on efforts to reopen the nation's economy state-by-state amid concerns that lifting restrictions too quickly and without sufficient testing and contact tracing will spur a resurgence.

“We're heartened that the worst of the pain and suffering is going to be behind us,” Trump said as he led a roundtable with executives from companies like Hilton and Toyota.

Trump laid out a vision of a return to pre-coronavirus normalcy — “with or without” a vaccine — with packed restaurants and filled stadiums. That vision flies in the face of sober assessments from doctors who say the country will need to embrace a “new normal” that includes extended social distancing and mask-wearing.

“I don't want people to get used to this,” Trump told reporters. “I see the new normal being what it was three months ago.”

To underscore his confidence, Trump announced that he plans to resume out-of-state travel after spending more than a month mostly cooped up in the White House. He said he's planning a trip to Arizona next week, followed by a possible trip to Ohio, even as much of the country remains under effective lockdown with all but essential travel banned.

“We're going to start to move around and hopefully in the not-too-distant future, we'll have some massive rallies and people will be sitting next to each

other,” he said, adding that having people spaced out in accordance with social distancing guidelines “wouldn't look too good.”

He didn't say exactly when he envisioned such rallies returning, but said the timing would depend, in part, on the states, since some have had far fewer cases than others. The federal government and most states have urged residents to avoid mass gatherings and to remain at least six feet apart.

The announcement came after Trump said he will not be extending the White House's “30 Days to Slow the Spread” guidelines when they expire Thursday.

“They'll be fading out because now the governors are doing it,” Trump told reporters in the Oval Office as he met with John Bel Edwards, the Democratic governor of Louisiana.

Those guidelines — which were originally supposed to last 15 days and were then extended an additional 30 — encouraged Americans to work from home and avoid restaurants, group gatherings and discretionary travel and advised older Americans and those with serious underlying health conditions to isolate themselves.

Mix hot, drained spaghetti with cream cheese and sour cream. Fry hamburger and chopped onion. Drain and add to spaghetti mixture along with remaining ingredients.

## Cooperative cuisine

### You've probably got all you need to make fabled 'Stone Soup'

As the days go by, I am being forced to become more creative with my cooking. I've always been a fan of stews and hearty soups, and I make them all year round to stock my freezer. That stash has started to run low lately. So it was time to see what I could make out of the slim pickings I had and replenish the freezer stock.

Rooting around in my pantry, I came upon a mixed bag of soup beans. I don't even remember buying these dried beans, but I was happy to find them.

The recipe on the back was uninspiring, so I decided to use the beans to make a hearty soup in honor of the children's folk tale "Stone Soup." In the story, a hungry stranger persuades people in a hungry town to each bring what little food they have to add to a soup he started with a stone. The result is a delicious meal that everyone enjoys. It's a fable about the value of sharing, and how the whole is bigger than the sum of its parts.

So, I thought of the bag of beans as the "stone." I started my soup with. If you have children at home, you can read the story and get the kids involved. Start with a bag of beans if you have it, and build the soup with whatever is in your kitchen. Ask everyone in your locked-down household to find a

carrot, an onion, a potato, etc., to add to the soup.

I began the way I do whenever I make stews and hearty soups, with a foundation of vegetables known to chefs as mirepoix. That's French for a mix of diced onions, celery and carrot. You saute it, and use it as the base of a dish.

I had some raggedy celery, a few carrots and an onion. Once they were chopped, I put them in a large Dutch oven with olive oil. A ham bone is a classic seasoning for bean soup; I didn't have one, but I did have some salty pieces of country ham, which I sliced and sautéed with the vegetables. I added a few cloves of roughly chopped garlic and an extra glug of olive oil for richness.

After the vegetables and ham had cooked and the onions had become translucent, I added mostly water, the last of my chicken stock, a packet of French Onion Soup Mix (because I had it, and it is a good flavor addition for soup) and a large can of stewed tomatoes. After that, I washed the dried beans and added them.

I didn't soak them the night before because, truthfully, I never soak dried beans. I prefer the way they cook when they start dry, but I always felt like I was doing the wrong thing until I saw a tweet from my friend Joe Yonan, who just wrote a book on beans, "Cool Beans: The Ultimate Guide to Cooking with the World's Most

Versatile Plant-Based Protein" (Ten Speed Press). He tweeted that "cooking (beans) is faster than soaking." And he was quoting Steve Sando, the bean master from Rancho Gordo heirloom beans.

Let the soup boil for a few minutes and then turn the heat to low. Let it cook slowly for most of the day or until the beans are creamy. It will take at least three hours to re-hydrate and soften the beans. I put the lid on the pot with just a tiny opening to let the steam escape, so it didn't boil over.

I tasted the broth and decided it would benefit from some acid and the depth of flavor that wine brings. I had the end of a bottle of red in my refrigerator, so I added a cup. You could use a beer, too, or even a bit of red wine vinegar if you don't want to add alcohol.

Almost anything tastes good with beans. You can add what you have in the house, from mushrooms to potatoes to corn. Fresh herbs are nice additions as well. And if I had kale or spinach, I would swirl it in at the end. Remember to salt at the end of the cooking time. If you don't use an onion soup mix packet, you might need a lot of salt. Bean soups generally need quite a bit of salt and a good shake of Tabasco to balance out the flavors.

This is an easy soup to make meat-free if you are vegetarian. It is also a perfect base for adding chicken, smoked sausage, andouille, etc.

Now, with the economy taking a massive hit and so many of our family and friends dealing with uncertain financial outcomes, questioning statistics has become daily speculation.

The daily briefing from the White House is must-see TV in our household as it is in many others (not everyone, of course). And we have learned a lot (more than we ever thought possible about viruses), from the "experts" and others who speak to us every day.

So, in spite of the hold on most outside activities lately, we finally decided to brave the new world to

satisfy a few cravings we simply can't get at home.

Youngest daughter Kristine drove about 3,000 miles from San Francisco to visit us at the beginning of the shutdown and is still stuck with us until the ominous quarantines lift.

With our favorite restaurants mostly closed or only offering take out, we grabbed a couple of folding chairs last week and made our way to World Fusion near Beverly Hills on County Road 486 for a feast.

A sweet server named Heather came to our car, took our order and we parked in a shady spot to wait. Pretty soon she was back with fresh specialty sushi rolls for Kris and vegetable tempura and Israeli salad with ginger dressing for me.

Our al fresco picnic was a huge success and we will do it again soon. Nothing like a picnic in a very windy parking lot when the food is really great.

One day, Kris and daughter Kelly and I called ahead to the new Coney Island restaurant in Crystal River and picked up our order at the drive-thru window.

The Reuben and Chicago hot dogs were terrific, as was the buttery corn on the cob and a couple of other sides. I think the huge chocolate shakes must be the thickest and tastiest anywhere within driving distance!

Another delicious takeout was at BubbaQue's in Crystal River, for

the always-great ribs, corn on the cob and baked beans. No complaints.

Then there was also a visit to Chili's in Crystal River, again with car-side service for order and a quick-bag sack of vittles that definitely satisfied. The service was exemplary.

There are plenty of other places we will try as well and I would urge anyone who can to keep visiting your favorite restaurants who are struggling mightily to maintain their business imprint during the shutdown.

Bravo to all of them, and may this scourge soon pass.

Oh yes, I've been cooking at home a lot more lately, too, especially since my regular weekly food page stories are also quarantined for the duration.

That said, I will leave you this week with a super-easy pizza recipe:

### EASIEST EVER PIZZA

- 1 cup Greek yogurt
- 1 cup self-rising flour

Mix ingredients thoroughly and pat lightly into greased pizza pan or rectangle baking sheet. Bake at 400 degrees for 15 minutes or until done. Remove from oven and cool slightly.

Top with favorite ingredients and bake again until cheese is melted and bubbly.
