PAYMENT AFFIDAVIT

Per F.S. 40.24 jurors who are regularly employed and who continue to receive regular wages while serving as a juror are not entitled to receive compensation from the State for the first three days of juror service. Jurors who are not regularly employed or who do not continue to receive regular wages while serving as a juror are entitled to receive \$15 per day for the first three days of juror service. All jurors who serve more than three days will be paid \$30 per day for the fourth day and each service day thereafter, regardless of their employment status.

JUROR INFORMATION

TIME TO REPORT: You must report no later than 8 A.M. Presentation of a valid ID (FL Driver License, or FL ID Card) is required. Parking is limited, see designated areas on map. Trials may be cancelled, please refer to our website at www.citrusclerk.org, or call (352) 341-6471, any time after 5:00 P.M on the Friday prior to your appearance date.

LENGTH OF SERVICE: As a rule, the jury selection process lasts one (1) day and you should plan on spending the entire day at the Courthouse. If you are selected to serve as a juror, the trial judge will advise you of the probable trial duration. **YOU MAY WISH TO BRING A NON-PERISHABLE LUNCH AND/OR SNACK**
