Report Narrative **On May 5, 2019 at approximately 0114 hours, officers were dispatched to 1212 Winterberry Dr, Marco Island, FL, 34145 in reference to a domestic dispute.**

Officer Stafford and I arrived on scene and witnessed a white female, Nina Mckeough [REDACTED], grabbing hold of Officer Derrig as officers were detaining a white male, Mont Reed [REDACTED]. Officer Stafford and I took hold of Nina and pulled her off Officer Derrig as he stated to Nina "What are you doing? Get off me." Nina was attempting to stop officers from detaining her fiancé Mont.

As officers attempted to restrain Nina, she continued to fight and pull away from officers. Nina was placed into handcuffs where she continued to attempt to get away from officers. Her cuffs were checked for fitting and double locked. Nina was placed under arrest for resisting officers without violence. Nina was placed in the rear of my patrol vehicle (#180). Audio and video of this arrest can be viewed from my in-car camera. Once inside vehicle (#180), Nina banged her head against the glass window on the vehicle door numerous times.

Nina was transported to the Naples Jail Center without incident.
