WHO HAS THE KING? WHO CARES?

North-South had an intelligent auction. South's two no trump bid was forcing after North's positive response. North's three no trump bid showed a minimum, but South could hardly do less than bid a slam with his terrific hand.

West's heart lead would not have been everyone's choice, but it gave South nothing that wasn't available after any other lead. South won the opening lead with his queen and cashed the three top clubs, disappointed to see East discard a diamond on the third club.

South now cashed four rounds of diamonds, discarding a spade on the fourth round. East shed a low heart and a low spade. South might have taken the spade finesse at this point. Should that finesse be successful, he could just lead a club to West and claim his contract. South, however, judged that the spade finesse was probably not necessary. Unless West had made a deceptive lead of the nine of hearts from a holding of king-nine-low, he could be end-played.

South backed his judgment with his play. He crossed to his hand with the ace of hearts and led a low club. West won and now had to lead a

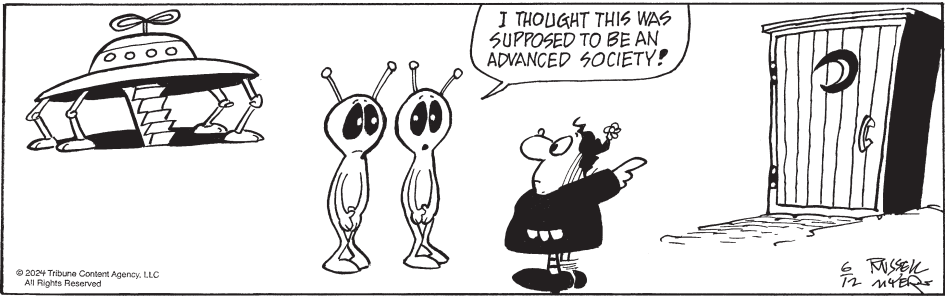

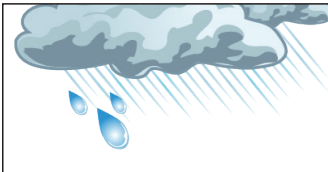
