Report Narrative **On 05/05/2019 at approximately 0114 hours I was dispatched to 1212 Winterberry Dr, Marco Island, FL, 34145 in reference to a domestic dispute.**

Upon arrival I was met by the witness Ms. Rosario, Arroyo, H/F, [REDACTED] who was waiting in her car. Ms. Arroyo stated that she picked a couple up from a restaurant in Naples, the female and male began to argue during transportation. While on Winterberry Dr., Ms. Arroyo observed the male passenger later identified as Mr. Reed, Mont Robert, W/M, [REDACTED] punch the female passenger in the face, at which time the female passenger began crying. Arroyo arrived at the above address to drop the couple off and heard the male say to the female that he was going to hit her. The female passenger was subsequently identified as Ms. McKeough, Nina U, W/F, [REDACTED]

After speaking with the witness, I went to 1212 Winterberry Dr and observed Nina sitting on a step and Mont walking into his residence. Officer H. Schmid was speaking with Nina, at that time I instructed Mont to come outside and provide his statement. Mont attempted to flee inside of the residence and close the front door in my face, where there could be potential weapons. I escorted Mont out of his house. Mont became combative, tensed up and placed his arms in front of him; after a brief struggle Mont was placed in handcuffs (checked for proper spacing and double locked). Mont was advised that he was being detained pending my investigation and his refusal to comply with my commands. During my interaction with Mont, Nina obstructed officers by becoming combative. Nina grabbed Officer J. Derrig and was advised to stop, Nina refused. Officer J. Stafford, and A. Moreno was able to prevent Nina from interfering with the detention of Mont. Please refer to Case # MIPD190368.2 (Supplemental report) for more details in Nina's arrest.

Mont provided the following statement, he and his girlfriend had dinner at a restaurant in Naples. He placed a request for an Uber and Ms. Arroyo was their driver. During the ride, he and Nina got into a verbal dispute, but he never became physically violent with Nina in the vehicle. Mont stated that the driver became involved in their dispute and he advised her that their business was not her concern, and Arroyo became upset.

Nina was very upset and refused to provide a statement. The only thing Nina consistently stated was "He did not hit me."

Based on my training and experience I determined that both parties were under the influence of alcohol, due to both having glassy and bloodshot eyes, and a strong odor of alcohol coming from their person. Mont admitted that they both had alcoholic beverages in the restaurant. I was unable to check Nina for injuries due to her disorderly conduct and resistance while on scene. The decision to arrest tonight came from Arroyo's statement. Arroyo is an unbiased source that observed Mont punch Nina in the face during transport. Based on Arroyo's statement, Mont punched Nina in the face against her will. Mont was placed under arrest for Battery-DV (F.S.S.784.03(1)(a)) and Resisting an Officer without violence (F.S.S. 843.02(6)).

Nina was also placed under arrest. Based on Nina's combative conduct and willful obstruction of an officer which violates F.S.S. 843.02(6). Nina was placed in handcuffs (double locked and checked for proper spacing).

Nina was provided with a vine form and advised of remedies. Nina was also provided with a Public records exemption request which has been completed and logged to this case.

Mont and Nina were both transported to Naples Jail Center. This incident was captured on vehicle's #180 and 192 cameras
